36 Apologies for Absence

Apologies for absence were received from Councillors Morgan and Simmons.

37 Declarations of Interest

No declarations of interest were received.

38 Minutes

The minutes of the meeting held on 4 November 2014 were approved by the Committee as a correct record and were signed by the Chairperson.

39 Hackney Carriage/Private Hire Applications

RESOLVED – That the following application be dealt with as indicated:

- (1) That the Peugeot Partner be approved as a Prestige Vehicle.
- 40 Application for an Additional Front Seat in a Ford Tourneo

After viewing the vehicle Members discussed the merits of the application. The Committee considered that permitting an additional passenger to use the front seat bench would put the driver and the passengers at unnecessary risk. Members felt that the Licensing Authority's guidelines on this issue should be adhered to.

RESOLVED – That the application for an additional front seat in the Ford Tourneo be refused.

41 Presentation on Enforcement of Moving Traffic Contraventions

Councillor Bridges moved that this item be postponed as the issue was not included on the agenda. Councillor Boyle seconded the move to postpone the item. The Committee voted in favour of hearing the presentation.

The Chairperson welcomed Councillor Ramesh Patel, Cabinet Member for Transport, Planning and Sustainability; Paul Carter, Operational Manager – Transportation; and Steve Carrell, Team Leader, Network Management; to the meeting. The Cabinet Member and officers were invited to deliver a presentation on the enforcement of Bus Lane and Moving Traffic Contraventions in the City.

The Committee was advised that the Welsh Government had passed legislation which

allowed the authority to enforce a range of bus lane and moving traffic offences. The ability to enforce such offences would support the authority's transport policies. The presentation included details of the legal background to the matter, how enforcement would support transport policies and provided further details on the systems supporting enforcement and a prediction on the level of enforcement actions expected annually.

The Chairperson thanked the officers for their presentation and invited comments from Members of the Committee. The Committee sought further clarification on the exemptions to enforcement, particularly in relation to incidents involving the emergency services. Councillor Patel stated that all drivers will need to adhere to the law in relation to bus lane and moving traffic offences. However, the cameras will provide video of footage of all incidents. Each offence will be reviewed by Civil Parking Enforcement Officers, and, for example, where a driver has moved into a bus lane to clear the road for an emergency services vehicle to pass, that driver would not be fined.

Officers confirmed that signage would be installed at locations were cameras at situated. Such signage was already in-situ at the majority of locations. It was also confirmed that South Wales Police would still have powers to enforce Moving Traffic Offences and bus lane contraventions.

The Committee asked for an estimate on the level of revenue likely to be generated by the scheme. The Cabinet Member was unable to provide an estimate but it was emphasised that any revenue received would be ringfenced for transportation projects.

42 Village Green Application - Arls Field, Llandaff

The County Solicitor submitted a report on behalf of the Council as Registration Authority under the Commons Act 2006, relating to the registration of land in the Register of Town and Village Greens, as maintained by the Registration Authority. The report was presented by Geoff Shimell, Operational Manager – Property and Development.

Members were advised that an application for the registration of land known as 'The Arls Field' in Llandaff as a town or village green had been received from Mr Geoffrey Barton-Greenwood on behalf of the Llandaff Society. The County Solicitor's report stated that the applicable law in this matter was complex and that there was no right of appeal against the decision of the Registration Authority. Any decision can be vulnerable to legal challenge. It was therefore essential for the Registration Authority to be able demonstrate that the Committee has acted in accordance with the principles of natural justice and proper administration. Consideration needed to focus on the legal issues rather than amenity or property issues and decisions needed to turn to evidence, and not to policy considerations.

The evidence produced by the applicant and the landowner (Cardiff Metropolitan University) as objector was considered. The evidence was set out in the appendix to the report. After applying the legal tests to the evidence, the County Solicitor recommended that the Council should not register the application land as a town or village green. The Committee was therefore asked to determine the application.

The report provided a description of the application land and the role of the Council as Registration Authority. Further details of the law in relation to village greens were included in the report along with the bases for both the application and the objection.

Geoff Shimell introduced the report. The Committee was advised that 35 witness statements in support of the application had been received together with witness statements from the objector. Mr Shimell stated that he had visited the site which was fairly heavily overgrown with brambles and similar weeds. The site had a public footpath around the perimeter. Mr Shimell addressed each of the 6 legal tests that need to be established when considering the application. These tests were detailed in 5.3 of the appendix to the report.

At this point Councillor Gareth Aubrey, a ward member requested permission to address the Committee on behalf of the applicant. Councillor Aubrey wished to clarify witness statements and to challenge some contents of the report and the legal conclusion. The Councillor also requested that consideration of this issue be deferred to allow for a site visit to take place and that these requests be recorded in the official record of the meeting. The Committee was advised by Mark Roberts, the Committee's legal officer that the consultation period for the village green application had closed. It was therefore not appropriate to add comments on evidence at that stage. The application has been publicly advertised, and ward members had had the opportunity to respond. The Chairperson requested further clarification of the point of law *in camra*. The meeting was adjourned.

The meeting was reconvened. Councillor Boyle had moved that Councillor Aubrey should be permitted to address the committee, which was seconded by Councillor Howells. Members voted not to permit Councillor Aubrey to address the meeting.

Mr Shimell stated that in order to prevent members of the public asserting possessory rights over his land, a landowner can give consent for his land to be used by erecting notices and thereby preventing the establishment of possessory rights. However, if the public use is only random and insufficient to demonstrate to the landowner that use for lawful pursuits and pastimes is occurring, then the landowner has no way of knowing that he needs to think about protecting his position. The burden of proof lies with the applicant to shown that on the balance of probabilities the legal tests have been satisfied. The only consistent evidence received from those supporting the application suggested that many people used the public footpath for walking around the field. This was also the view of the objector's witness statements. Crossing land for walking, with or without a dog, for access purposes is not in itself sufficient to establish a lawful pursuit and pastime. In this case, the footpath is adopted and not part of the field in any event.

Members questioned why residents were making the application for village green status for the land. Mr Shimell stated that Members could only make their determination based on the evidence presented.

RESOLVED – That on behalf of the Council as Registration Authority, the Committee determine the application as not to register the Arls Field as a town or village green under s15(2) of the Commons Act 2006.

43 Street Trading Conditions - Application to Amend Conditions in St Mary Street

Members were advised that a request had been received to modify the current street trading conditions in St Mary Street to allow the use of a vehicle to sell food at the St Mary Street Market. The Committee received a report and were asked to consider merits of the application.

The current street trading conditions were last approved by the Committee in 2000, subject to minor amendments in November 2014. The conditions were appended to the report. The current policy prevents the present of a vehicle at street markets unless it is for the purposes of loading and unloading. The applicant operates a mobile, woodfired pizza business. The operation requires the use of a small, three-wheeled vehicle which has a wood-fired oven fitted into the body of the vehicle.

The Committee received representations for the applicants. Members were advised that the applicant believed they offered a unique dining experience for the people of Cardiff, using locally sourced ingredients, but were prevented from do so at the St Mary Street Market.

Views on the proposed amendments to the conditions were sought from relevant bodies. The Committee heard that South Wales Police made no comments. The Highways Department raised concerns that removing the clause from the conditions may have implications for Traffic Regulation Orders on fixed licence sites. It was therefore recommended that the clause be removed for the St Mary Street Market only. Highways also considered that the movement of the trading vehicle should be restricted and therefore it will only be permitted to enter or leave the Market at times when stalls are being assembled and dismantled.

RESOLVED – That delegated authority be given to the Head of Regulatory and Supporting Services to amend the Street Trading Conditions as appropriate.

44 Approval of Driver Fitness Criteria

At its meeting of 5 August 2014 the Committee considered a report which recommended replacing the current guidance on the treatment of convictions, cautions and criminal charges in respect of new applicants and existing hackney carriage/private hire drivers. The Committee was recommended to adopt the Directors of Public Protection Wales (DPPW) Licensing Technical Panel (LTP) 'Fitness Criteria for Drivers and Operators'.

Consultation was undertaken with trade representatives. A single representation was received from Mr Mathab Khan of the Cardiff Hackney Carriage Association. A copy of the representation received was appended to the report. Members were reminded that Mr Khan was also given an opportunity to address the Committee at its meeting in August 2014 and he had raised concerns regarding the legality of the fitness criteria. Members were advised that a number of local authority and independent solicitors were involved in the drafting of the LTP Fitness Criteria to ensure that they fully comply with all relevant legislation.

RESOLVED - That:

- (1) The Fitness Criteria for Drivers and Operators be approved and implemented from 1 January 2015;
- (2) The Head of Regulatory Services and Group Leader (Licensing) be delegated to make any necessary administrative changes that may be required.

Report of the Head of Regulatory and Supporting Services

STREET TRADING DESIGNATION – CENTRAL SQUARE

1. Background

- 1.1 Street Trading is controlled by Schedule 4 of the Local Government (Miscellaneous Provisions) Act, 1982.
- 1.2 The Act provides that a local authority may by resolution designate any street in their area as:
 - i) a "prohibited street" where street trading is prohibited;
 - ii) a "consent street" where street trading is prohibited without the consent of the local authority; and
 - iii) a "licence street" where street trading is prohibited without a licence granted by the local authority.
- 1.3 Central Square opposite Cardiff Central Station is currently designated as a Licence Street. Licenced trader Mr Timothy Harris has occupied the site for many years and sells hot drinks and hot food such as jacket potatoes and burgers. A location plan of Mr Harris's trading pitch is detailed in Appendix A.
- 1.4 Due to the impending development of Central Square it will no longer be possible for any person to trade from the site; it is therefore recommended that the street designation is changed to a 'prohibited street'.

2. Central Square Development

- 2.1 A major redevelopment of Central Square is to be undertaken which will include new office, retail and residential properties. It is envisaged that the first phase of the development will be initiated in summer 2015.
- 2.2 The development plans do not include provision for any street trading, and trading during the development will not be possible as it will involve demolition of the existing buildings.
- 2.3 The statutory procedure for designating a street for the purpose of street trading is briefly outlined in the following steps:

- (a) The publication of a notice of intention to pass a resolution designating a particular street. The notice must contain a draft of the resolution to be passed and must be published in a local newspaper. A copy is then served on the chief officer of police and any highway authority responsible for that street.
- (b) A period of at least twenty-eight days must elapse from the time of initial publication of the notice to the time when a district council passes a resolution confirming the proposed designation. This is to allow for objections to be made to the local authority, which must be considered before a resolution is passed designating a particular street.
- (c) Once a resolution has been passed, the council is obliged to publish the fact in two consecutive weeks in a local newspaper. The first publication must not be later than twenty-eight days before the date specified in the resolution for the coming into force of the designation.
- 2.4 Should the authority wish to rescind a designation or re-designate a street, the same procedure must be followed.

3. <u>Consultation</u>

3.1 Mr Harris has been consulted regarding the development plans and is aware of the legal process involved in the street designation process.

4. **Legal Implications**

4.1 The legal implications appear in the body of this report

5. Financial Implications.

- 5.1 The current fee for an annual street trading licence is £759.00. The licence is issued from 1st January 2015. If the street designation is changed before the licence expires on 31st December 2015, a pro-rata amount of the compliance element of the licence fee will be refunded to the trader.
- 5.2 The cost of advertising the designation will be met from the existing budget.

6. Recommendation

- 6.1 It is recommended that the Committee resolve to agree an intention to:
 a) rescind the designation of that part of Central Square currently designated as a
 - Licence Street; and
 - b) designate Central Square in its entirety a Prohibited Street

6.2 That the County Solicitor, be authorised to publish a legal notice of the Committee's intention and report to the Committee in due course so that it may consider passing the necessary resolution.
