1. Application

1.1 An application for a Premises Licence – Summary Review, has been received in respect of the Premises Licence held by 411 Entertainment Ltd for the 411 (formerly Aqua Bar), 3-6 St Mary Street, Cardiff, CF10 1AT .

1.2 The Licence Holder is permitted by the licence to provide the following:

(1) In respect of the following licensable activities:

1. The sale by retail of alcohol for consumption on and off the premises.
2. The provision of regulated entertainment in the form of films, live music, recorded music, performances of dance and anything of a similar description.
3. The provision of late night refreshment.

(2) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Sunday: 09:00 to 04:00

New Year's Eve: 09.00 to the end of permitted hours on New Year's Day

(3) The premises are permitted to provide licensable activities during the following hours:

1. The sale by retail of alcohol for consumption on and off the premises:

Monday to Sunday: 09.00 to 03.30

New Year's Eve: 09.00 to the end of permitted hours on New Year's Day

2. The provision of regulated entertainment in the form of films, live music, recorded music, performances of dance and anything of a similar description:

Monday to Sunday: 09.00 to 04.00

New Year's Eve: 09.00 to the end of permitted hours on New Year's Day

3. The provision of late night refreshment:

Monday to Sunday: 23:00 to 04:00

New Year's Eve: 23:00 to 05:00

2. Details of the Application for Review.

- 2.1 An application for Summary Review was received from South Wales Police on 1st December 2015. A copy of the application is enclosed with the report.

The application was submitted following an incident of serious crime and disorder at the premises on 29th November 2015 which resulted in a person sustaining injuries. Subsequent disorder followed which required police attendance and five arrests were made. It was evident that on 29th November 2015 the premises was operating in breach of a Premises Licence Condition in respect of the use of non glass drinking vessels.

A Summary Review hearing was held on 3rd December 2015. The Licensing Sub Committee suspended the Premises Licence until the full review hearing.

3. Relevant Representations

The application for review has been advertised on the premises as required by the legislation. A representation has been received from the Cardiff and Vale University Health Board and a copy is included with the report.

South Wales Police have submitted a list of conditions they would like to see attached to the licence and have advised that the conditions have been agreed by the DPS.

The licence holder has advised that the conditions are agreed, and a copy of this agreement is attached.

4. Legal Considerations.

- 4.1 Any decision must be taken following consideration of the representations received with a view to promoting the licensing objectives which are:

Prevention of crime and disorder
Public Safety
Prevention of Public Nuisance
Protection of Children from Harm

4.2 In each case the Sub-Committee may make the following determination

- a) To take no action.
- b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
- c) To exclude a licensable activity from the scope of the licence.
- d) Remove the Designated Premises Supervisor.
- e) Suspend the Premises Licence for a period not exceeding three months.
- f) Revoke the Premises Licence.

4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

5. **Recommendation.**

It is recommended that the application for Summary Review be considered and determined on its merits.

Room 112 booked a Rap Artiste called 'J HUS' to perform at the premises on 06 June 2015. This event never took place since the artiste was at that time wanted by London Police for a stabbing. Police intelligence suggested that a rival gang would attend Room 112 to take their revenge in Cardiff. On police advice the artiste was cancelled. J Hus was subsequently stabbed, five times, in September this year in a retaliation attack in London. He was photographed on his hospital bed, making gang signs with his hands. This revenge attack attracted substantial social media attention throughout the UK.

On 24 October 2015 Room 112 featured a DJ by the name of Tim Westwood. This artiste was subject of a drive-by shooting in 1999 in Kennington, South London, in which he and his assistant were both shot by a gunman on a motorbike; This was gang-related. The event at Room 112 was brought to an early finish on police attendance after a report was received suggesting that someone at the event had 'a blade'.

On 29/11/15 at approximately 02:50 hrs, a fight broke out at Room 112. During the fight a person was badly injured by a glass, sustaining wounds to the front and back of his head.

The fight spilled out of the premises, into the street.

The disorder which followed was of such scale and severity that all available police officers in Cardiff were needed at the scene.

Territorial Support Teams, Dog Handlers and Firearms units were necessary to quell the situation.

Five arrests were made, Taser was deployed by the police on two offenders.

Offences charged include Violent Disorder, Possession of an Offensive Weapon, Criminal Damage and Assaults on Police.

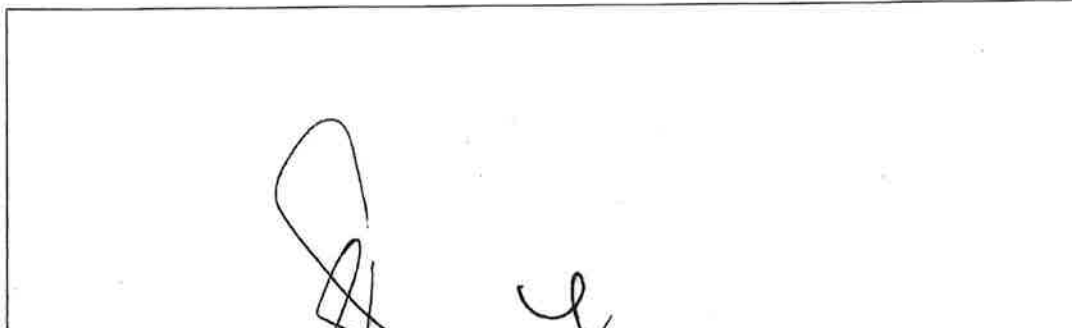
It is strongly believed that the fight involved rival gang members from the West Midlands and Bristol areas.

It is believed that swift reprisals are highly likely and the obvious meeting place for further disorder is Room 112.

Enquiries are on-going and it is anticipated that further arrests will be made.

It was evident that on 29/11/15 the premises were operating in breach of the condition that non glass vessels should have been in use.

The premises were operating at full capacity but the Designated Premises Supervisor was not present.

In accordance with Cardiff and Vale University Health Board's role as a responsible authority I can confirm that we have concerns regarding the license for:

Room 112 Bar and Nightclub, 3-6 St Mary's Street, Cardiff, CF10 1AT

The Health Board's concerns are based on the impact of the venue's activity on public safety.

The Health Board believes that there is evidence of the premises operating irresponsibly by being in breach of a condition of the license relating to the serving of alcohol in non glass vessels.

Following an incident that took place at the venue in the early hours of Sunday 29th November a total of 6 people presented at the Emergency Unit at the University Hospital Wales with injuries related to the impact of glass vessels sold from within the premises. Injuries to the face from glass vessels often result in admittance to hospital with a need for maxillofacial surgery. Individual cases of this kind are estimated to cost the NHS around £2,000 in treatment costs for the patient alone. The costs accrue when taking into consideration the ambulance transfers and staffing costs (e.g. receptionists, nurses, surgeons). This incident alone is estimated to have cost Cardiff and Vale University Health Board up to the region of £12,000, and is a direct result of the breach of the license condition. The Health Board believes that this incident is reflective of an irresponsible approach to implementing the licensing conditions, and the licensing activity posed significant threat to public safety on the night in question. The Health Board believes that without further conditions and close work with South Wales Police the premises, through its licensed activity, has the potential to pose further risk to public safety in the future.

The Health Board also raises significant concern with the nature of licensable activity within the premises. There is evidence of sales of full bottles of champagne and full bottles of spirits, potentially for the consumption of individuals or a small number of people. International evidence highlights that alcohol related harm in a population is linked to the increased availability of alcohol. The Health Board believes that such uncontrolled and unregulated sales increases the risk of over consumption of alcohol and alcohol related harm. This could be in the form of incidences of violence as detailed above, harm due to intoxication, or longer term alcohol related illness.

The location of the premise is an additional concern to the Health Board, being in the Saturation Policy area of Cardiff City Centre, right at the centre of the thriving night time economy. The Health Board believes that the irresponsible sales of large amounts of alcohol within the premise significantly increases the risk of incidents taking place in the City Centre and has the potential to lead to a further increase in activity at the Emergency Unit and Alcohol Treatment Centre.

Once again, the Health Board believes that without further conditions and close work with South Wales Police to address issues of sales of large quantities of alcohol in one serving (such as those detailed above), the premises, through its licensed activity has the potential to pose further risk to public safety in the future.

The Health Board would like these points to be taken into consideration by the Licensing Committee. We support any action to implement further conditions on the license along with further support of South Wales Police to work with the premises to avoid any future negative impact on public safety.

In summary, the Health Board would like to see the following actions implemented at the premises:

- Use of polycarbonate vessels only, no glass vessels to be used
- No sales of large bottles of alcohol for consumption

'Alcohol misuse is already one of the most serious public health challenges in Wales'
(Chief Medical Officer for Wales, 2010)

- Every year, alcohol contributes to around 1000 deaths in Wales¹.
- 1.5% of all hospital admissions in Wales are alcohol related¹.
- Trend data show that alcohol related hospital admissions are increasing¹.
- Alcohol related incidents cost the NHS in Wales between £70 and £85 million per year².
- 42.7 % of adults in Wales report drinking alcohol above the recommended alcohol limits in the previous week and 26.6% of adults in Wales report that they binge drink³ – this is likely to be a substantial under-estimate of the true number.
- It is estimated that for every drinker in Wales there is a disparity of a bottle of wine between reported drinking levels and alcohol purchased⁴.
- Alcohol and its misuse is associated with significant health, social and economic costs, to individuals, families, communities, workplaces, organisations and society as a whole.
- As well as potentially causing harm to the individual who is drinking, alcohol consumption can also have an effect on wider society through alcohol-related crime.
- In 2007/8, there were estimated to be around 18,000 incidents of violent crime attributable to alcohol in Wales¹ This figure is likely to substantially under-estimate the contribution of alcohol to crime.

In Cardiff and Vale...

- Cardiff and Vale has higher levels of alcohol misuse than Wales in general.
- 43.7% of adults report drinking alcohol above the recommended alcohol limits on at least one day in the previous week⁵.
- Men drink above the guidelines more often than women, with the 45-54 year olds drinking over the guidelines most⁶.
- 26.1% of adults in Cardiff and the Vale report that they binge drink⁵.
- Binge drinking in Cardiff and Vale is on or above the national average, and is likely to be centred on hotspots such as Cardiff City Centre.
- Alcohol related hospital admissions in Cardiff and Vale, for males and females, are slightly lower than the Wales average⁷, but this trend is rising.
- Alcohol related violent crime is lower in the Vale of Glamorgan than across all-Wales average but, this may be due to under reporting of these crimes.
- Crime in Cardiff is above the national average and while the residencies of the offenders are unknown (many may be from other areas) the impact on Cardiff's services is considerable.

Why does licensing matter?

- Opening hours and density of alcohol sales outlets influence alcohol consumption, drinking patterns and damage due to alcohol⁸.
- It has been concluded that restricting the availability of alcohol is an effective way of reducing alcohol related harm.
- The number of alcohol outlets is strongly related to alcohol related hospital admissions⁹.
- There is a significant link between the density of 'pubs and clubs' and numbers of assaults¹⁰ and also to crime rates in general¹¹
- Reducing alcohol availability and access is key to preventing alcohol related problems in the community¹².
- Extensions to opening hours are most often used by problem drinkers to increase their access to alcohol¹³.
- Increasing the density of alcohol outlets increases competition, usually leading to lower prices and increased alcohol consumption¹⁴.
- Marginalised drinkers are most affected by changes in alcohol availability¹⁴.

ROOM 112

Proposed Conditions

1. The licence Holder shall submit to the Police licensing and the licensing authority a separate operating schedule for each event where an external promoter or DJ are involved at the premises. It shall be submitted in writing at least 28 days prior to the event. South Wales Police will notify the premise licence holder in writing of any conditions that should apply to the operation of the event within ten days of receiving written notification of the event. If less than 28 days notice is given in writing, any condition(s) applied by the Police shall not be challenged by the applicant / Licence holder.
2. The premise shall maintain a register when external promoters are involved, which will include, specific date of event, nature/title of the event, name and contact details of the promoter. The register must be available for immediate inspection upon request by a police employee or authorised officer of the council.
3. The designated premises supervisor or a personal licence holder shall be present at all times when the public are on the premises and licensable activities are being carried out.
4. The Designated Premises Supervisor shall maintain a duty register of all persons engaged as door and security staff. This register must include the name and SIA registration number of the person employed, time and date of duty commenced/finished with a signed acknowledgement by that person. The register must include the company employed or through whom the services of that person are engaged. The register shall be kept so that it can be readily inspected by a police employee or an authorised officer of the council.
5. Door staff must be SIA registered as required by the licensing Act 2003. The door staff provided on a ratio of 1 to 50, and employed at all times after 21:00hrs.
6. A minimum of 2 Portable CCTV recording devices, capable of storing audio as well as video data, such as a body camera or similar will be worn by SIA security staff when the premises are open to the public.
7. A search policy shall be in place, including procedures for confiscation and storage of illegal substances and random searches with the use of metal detectors at the door supervisor's

discretion. When security are on duty, they will be of both sexes so as to undertake searches of males and females.

8. SIA security will remain visible outside the premises on St Mary St for 30 minutes upon closing to ensure the safe dispersal and egress of patrons away from the premises. Such security staff are to be easily identifiable to members of the public
9. An incident book is to be maintained on site, to include a record of the details of any person refused entry or ejected from the premises, including that person's name (if possible), the time of the refusal of entry / ejection and the reasons for the refusal of the entry / ejection. That book is to be produced to a police employee or an authorised officer of the council immediately upon request when the premises are open to the public , and at all other times, as soon as reasonably practicable.
10. There shall be no admission or re- admission to the premises after 02:00hrs, except for patrons using the outside smoking area.
11. Staff and management shall receive annual refresher training in relation to licensing legislation, underage sales and drug policies and shall be fully conversant with the conditions contained therein the premises licence. A record of the training shall be maintained, including the date, name
12. No drinks to be served in glass containers at ANY time within the venue. The exception to this condition is that GLASS BOTTLES are permitted within a designated VIP area.
 - (a) This designated VIP area will be sufficiently enclosed (except for the single point of entry/exit) to prevent the movement of glass bottles into the non VIP area
 - (b) Patrons will not be permitted to remove glass bottles from the designated VIP area
 - (c) All drinking vessels used in the designated VIP area will be polycarbonate.
 - (d) SIA security staff will control the single point of entry / exit of the designated VIP area at all times when the VIP area is in operation to ensure that no glass bottles are removed from the designated VIP area.

Existing conditions will be amended as follows;

2(1) The premises will adopt the Drug Safe Scheme. The drug safe procedure will involve a dedicated log of illegal substances placed in the safe by staff. It will record details of where the substance was discovered (or from whom it was recovered) date and time as well as details of the person seizing the substance(s).

If the person making the entry in the log is different to the person seizing the substance(s) their details shall also be included in the log entry.

Any seizure made where supply is suspected or likely shall be reported immediately to the police in order to assist with prosecution of offender(s).

3(b) The numbers of patrons in the premises shall be recorded, hourly during open times, by SIA staff. Two counters will be utilised to enable this condition to be met.
