Application for Premises Licence - Grant

Application No: CCCP/01935 Name of Premises: Small Bar Ward: Cathays

1. <u>Application</u>

- 1.1 An application for a Premises Licence Grant, has been received from The Big Beer Company Limited in respect of Small Bar, 17 Church Street, Cardiff, CF10 1BG.
- 1.2 The applicant has applied for the following:
 - (1) In respect of the following licensable activities:

1. The sale by retail of alcohol for consumption on and off the premises.

2. The provision of late night refreshment (indoors).

(2) Description of Premises (as stated by applicant):

Bar specialising in 'craft' beers and American BBQ style food.

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Sunday: 10:00 to 00:30 New Years Eve: 10:00 to 02:00

(4) To provide licensable activities during the following hours:

1. The sale by retail of alcohol for consumption on and off the premises:

Monday to Sunday: 10:00 to 00:00 New Years Eve: 10:00 to 02:00 2. The provision of late night refreshment (indoors):

Monday to Sunday: 23:00 to 00:00 New Years Eve: 10:00 to 02:00Until 02:00 hours into the morning following New Years Eve.

1.3 The applicant consulted with South Wales Police and the Licensing Authority prior to submitting the application and has advised that the operating schedule was amended following discussions with South Wales Police. A copy of the previous version of the application, together with supporting documentation is attached to the back of this report.

2. <u>Promotion of Licensing Objectives.</u>

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report.

3. <u>Relevant Representations</u>

Representations have been received in respect of the application, copies of which are enclosed with the report.

4. <u>Legal Considerations.</u>

4.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives which are:

Prevention of crime and disorder Public Safety Prevention of Public Nuisance Protection of Children from Harm

4.2 In each case the Sub-Committee may make the following determination

- a) To grant the application.
- b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
- c) Reject the whole or part of the application.
- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

5. <u>Issues for Discussion.</u>

5.1 The application should be determined and the appropriateness of any conditions on the licence needs to be discussed.

M Describe the steps you intend to take to promote the four licensing objectives:

a) General - all four licensing objectives (b, c, d and e) (please read guidance note 9)

The Premises Licence will have no effect until the premises are constructed/altered only in accordance with the appropriate provisions of the local licensing authority and this condition has been removed from the premises licence.

Locations of fire safety and other safety equipment subject to change in accordance with the requirements of the responsible authorities or following a risk assessment.

Any detail shown on the plan that is not required by the licensing plans regulations is indicative only and subject to change at any time.

A 30 minute drinking up time on top of the last permitted sale of alcohol to allow customers to use the toilet facilities and disperse from the premises.

b) The prevention of crime and disorder

On days classified as 'major event days' by the South Wales Police, all drinks will be dispensed into plastic vessels, with the exception being hot drinks. The premises need only comply with this requirement should the Police, after consultation with the operator, deem that there is a real risk to public safety during a specific major event and notify them accordingly.

The premises will operate a South Wales Police approved radio system.

The premises will be a member of Pubwatch or related scheme (where one exists).

CCTV shall be installed to a standard agreed with South Wales Police. It will be maintained and operated at all times that the premises are open to the public. The system shall cover all areas to which the public have access (excluding toilets), including entrances and exits and any outside areas used by customers. Images shall be kept for a minimum of 31 days. The images shall be produced to an authorised police employee in a readily format upon reasonable request. There will be sufficient staff training to facilitate this request.

SIA registered door staff shall be employed at a ratio of 1:100 on 21:00 until close on a Friday and Saturday whenever regulated entertainment is taking place and on all days classified as 'major event days' by South Wales Police. At all other times, SIA registered door staff shall be employed on a risk assessed basis.

When employed, a register of those door staff shall employed shall be maintained at the premises and shall include:

- a) number of door staff on duty
- b) the identity of each member of door staff
- c) the times the door staff are on duty

Open containers shall not be removed from the premises, save for consumption in any delineated external area.

Any external furniture will be moved inside or alternatively secured by 23:00 daily.

A refusals book will be maintained at the premises, and made available to an officer of a responsible authority on request.

A dispersal and smoking policy document is to be drawn up in consultation with Police and Council officers. Once agreed it is to be implemented in full. To include, but not *limited to;* (the monitoring of customers by (door) staff, the pre booking of mini cabs/taxis, orderly dispersal of patrons). This policy

shall be reviewed on an annual basis to ensure it is still effective and shall be updated if necessary.

c) Public safety

Appropriate fire safety measures will be installed and maintained as shown on the drawings accompanying this application.

d) The prevention of public nuisance

Noise from amplified music, voices, nor vibration be transmitted through to the structure of the nearest residential dwelling as to cause a noise nuisance to occupants.

The emptying of bins into skips and refuse collections shall not take place between 11pm and 7am.

Late Night Refreshment is restricted to on the premises only.

A designated, de-lineated and bordered smoking area will be allocated outside the premises. Suitable receptacles will be provided within this area for cigarette litter. The Premises Licence Holder or nominated person shall ensure that the smoking area is regularly cleaned to ensure that all discarded smoking litter is removed and properly disposed.

e) The protection of children from harm

A 'Challenge 21' scheme shall be implemented in full and identification sought from any persons who appear to be under 21. Acceptable forms of identification shall be photographic driving licences, passports, HM forces cards or a form of identification with the "PASS" hologram.

Staff to be trained in the laws relating to underage sales, particularly around ¹Challenge 21' and its operation. All training to be documented and repeated at 6 monthly intervals.

I, Acting Chief Inspector Jason Rees, of the South Wales Police, herby give notice that an objection shall be made to the application for a new premises licence for Small Bar, 17 Church Street, Cardiff.

This Police objection is based upon the licensing objectives:-

- 1. The prevention of crime and disorder. (The premises are situated in an area which has high incidents of crime and disorder and incidents associated with alcohol)
- 2. The prevention of public nuisance (The premises are situated in an area which have incidents of public nuisance)

As a result the premises are located within the agreed Cumulative Impact Policy area for Cardiff City Centre. (Special Policy Statement in respect of Cardiff City Centre adopted 2016)

South Wales Police will object to the application to allow a Licensing Committee the opportunity to undertake the rebuttable presumption that the premises licence will not be granted unless the applicant can demonstrate that there will be no negative cumulative impact on one or more of the licensing objectives

Within the current application, the applicant has detailed the steps he intends to take to promote the four licensing objectives. These are in the way of voluntary conditions that would be placed on the premises licence

If the applicant successfully challenges the Saturation Policy or is able to demonstrate that the premises are likely to promote the licensing objectives, I feel that these conditions do not adequately promote the four licensing objectives, in particular the prevention of crime and disorder and the prevention of public nuisance.

For that reason I have identified conditions that are necessary and proportionate that would enable the premises to operate whilst reducing the negative impact it will have on the licensing objectives.

However, I feel that it is pertinent to take this opportunity to reinforce the point that these conditions will not adequately promote the licensing objectives but merely go some way in limiting the extent as to which they are likely to be undermined.

Police Representations

- 1. Hours premises open to the public Monday to Sunday 1000 hours to 23:00
- 2. Sale / Supply of Alcohol on and off the premises Monday to Sunday 1000 hours to 22.30 hours
- 3. Late night refreshment None
- 4. At least 60% of the public space within the licensed area of the premises shall be occupied by tables and chairs.
- 5. No performance of striptease, lap dancing, entertainment or a sexual nature of other similar entertainment will be permitted on the premises
- 6. Children under the age of 16 shall not be permitted to enter the premises after 21.00 hours, unless eating a meal and accompanied by a parent or guardian.
- 7. On days classified as 'major event days' by south Wales Police, all drinks will be dispensed into plastic vessels, with the exception being hot drinks.
- An incident book shall be kept at the premises and maintained on site at all times. It shall be made available on request to an authorised officer of the local authority or a member of police staff, which will record the following: All crimes reported to the venue Any complaints received (of a Criminal or Licensing nature) Any incidents of disorder Any refusal of the sale of alcohol

Any refusal of entry

Any visit by a relevant authority or emergency service.

- 9. SIA registered door staff be employed at a ratio of 1:100 from 21.00 hours until close on a Friday and Saturday and from open to close on Major Event Days
- 10. Use of any external delineated area to cease at 23.00 hours

I write in respect of the above application submitted to the authority on 16th May 2016, and hereby give notification that the Licensing Authority of Cardiff Council object to the application for a Premises Licence.

A Cumulative impact Policy has been adopted for the City Centre area of the City. The Licensing Authority has adopted the policy due to high levels of alcohol related crime and disorder, in the interests of public safety and the avoidance of nuisance.

The policy creates a presumption that new applications for Premises Licences will be refused unless the applicant can demonstrate the business will have no negative effect on any of the licensing objectives. I have attached a copy of the policy for your information.

The premises detailed above falls within the boundary of the Cumulative Impact Zone and therefore an objection is submitted in respect to the following Licensing Objectives.

The prevention of crime and disorder. The prevention of public nuisance. Public safety.

Consequently the Licensing Sub-Committee will need consider this application.

You will need to demonstrate to the Licensing Sub-Committee that there will be no negative cumulative impact on one or more of the licensing objectives if the Premises Licence were to be granted.







The Premises Licence will have no effect until the premises are constructed/altered only in accordance with the appropriate provisions of the local licensing authority and this condition has been removed from the premises licence.

On days classified as 'major event days' by the South Wales Police, all drinks will be dispensed into plastic vessels, with the exception being hot drinks and those drinks served with a substantial table meal to seated persons, wine, champagne and/or cocktails. The premises need only comply with this requirement should the Police, after consultation with the operator, deem that there is a real risk to public safety during a specific major event and notified accordingly.

The premises will operate a South Wales Police approved radio system.

To be a member of Pubwatch or related scheme.

CCTV shall be installed to a standard agreed with South Wales Police. It will be maintained and operated at all times that the premises are open to the public. The system shall cover all areas to which the public have access (excluding toilets), including entrances and exits and any outside areas used by customers. Images shall be kept for a minimum of 31 days. The images shall be produced to an authorised police employee in a readily format upon reasonable request. There will be sufficient staff training to facilitate this request.

SIA registered door staff shall be employed at a ratio of 1:100 on 21:00 until close on a Friday and Saturday whenever regulated entertainment is taking place and on all days classified as 'major event days' by South Wales Police. At all other times, SIA registered door staff shall be employed on a risk assessed basis.

When employed, a register of those door staff shall employed shall be maintained at the premises and shall include:

- a) number of door staff on duty
- b) the identity of each member of door staff
- c) the times the door staff are on duty

Open containers shall not be removed from the premises, save for consumption in any delineated external area.

Any external furniture will be moved inside or alternatively secured by 23:00 daily.

A refusals book will be maintained at the premises, and made available to an officer of a responsible authority on request.

A dispersal and smoking policy document is to be drawn up in consultation with Police and Council officers. Once agreed it is to be implemented in full. To include, but not *limited to; (the* monitoring of

customers by (door) staff, the pre booking of mini cabs/taxis, orderly dispersal of patrons). This policy shall be reviewed on an annual basis to ensure it is still effective and shall be updated if necessary.

c) Public safety

Appropriate fire safety measures will be installed and maintained as shown on the drawings accompanying this application.

d) The prevention of public nuisance

Noise from amplified music, voices, nor vibration be transmitted through to the structure of the nearest residential dwelling as to cause a noise nuisance to occupants.

The emptying of bins into skips and refuse collections shall not take place between 11pm and 7am.

Late Night Refreshment is restricted to on the premises only.

A designated, de-lineated and bordered smoking area will be allocated outside the premises. Suitable receptacles will be provided within this area for cigarette litter. The Premises Licence Holder or nominated person shall ensure that the smoking area is regularly cleaned to ensure that all discarded smoking litter is removed and properly disposed.

e) The protection of children from harm

A 'Challenge 21' scheme shall be implemented in full and identification sought from any persons who appear to be under 21. Acceptable forms of identification shall be photographic driving licences, passports, HM forces cards or a form of identification with the "PASS" hologram.

Staff to be trained in the laws relating to underage sales, particularly around 'Challenge 21' and its operation. All training to be documented and repeated at 6 monthly intervals.
