1. Application

1.1 An application for a Premises Licence - Grant, has been received from Mrs Naomi Gropetis in respect of Miss Jones, 25-29 Merthyr Road, Whitchurch, Cardiff, CF14 1DA.

1.2 The applicant has applied for the following:

(1) In respect of the following licensable activities:

1. The sale by retail of alcohol for consumption on the premises.

2. The provision of regulated entertainment in the form of live music and recorded music.

3. The provision of late night refreshment.

(2) Description of Premises (as stated by applicant):

“Cocktail bar and restaurant with live music.”

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Sunday to Thursday: 09:00 to 00:00

Friday and Saturday: 09:00 to 01:00

New Years Eve: 09:00 to 04:00

(4) To provide licensable activities during the following hours:

1. The sale by retail of alcohol for consumption on the premises:

2. The provision of regulated entertainment in the form of live music (indoors):

The Management will keep an incident book of all incidents that relate to crime and disorder at the premises.

CCTV is in operation and will cover all key areas of the premises. The CCTV system is set to record at all times and has the function to burn still images and moving footage for production to the police.

c) Public safety

Door staff will be employed to ensure capacity guidelines are adhered to and for public safety.

d) The prevention of public nuisance

The Licence holder will hold membership to the local pub watch committee and posters will be displayed to this effect. All Live music will be played through although amplified will be played through a noise limiting device with built in analyser. This will not cut out the music but will alert the operative when the level is close to exceeding that which has been set. The limiter must be set to a level which is agreed by the local authority's pollution control department, which ensures that the music will not cause a public nuisance.

All Recorded music will be played through although amplified will be played through a noise limiting device with built in analyser. This will not cut out the music but will alert the operative when the level is close to exceeding that which has been set. The limiter must be set to a level which is agreed by the local authority's pollution control department, which ensures that the music will not cause a public nuisance.

No Recorded music will be played in the external areas beyond 21:00 on any day.

No Live music will be played in the external areas on any day.

All doors and windows will be kept closed when live or recorded music is being played except for those doors which allow

access/egress to the premises.

The Bifold doors facing Merthyr Road must remain closed when recorded or live music is being played and must remain closed from 21:00 to attenuate the noise from the music.

All waste glass disposal or collection must be take place between 09:00 and 16:00 on any day to prevent public nuisance. Prominent signage is to be placed around the premises to remind patrons that they are in a mixed residential area and to leave the premises quietly.

To prevent public nuisance, no alcohol is to be taken to the external areas beyond 23:30 on any day.

e) The protection of children from harm

The "Challenge 25" scheme will be adopted.

Children must be supervised at all times.

I have caused enquiries to be made into this application and make the following representations that I wish to be considered when deciding on the licensable activities and conditions for the licence.

I therefore ask that the Licensing Committee hear the representations made by the Police when determining the grant of this application.

Should the applicant agree to comply with the representations made to meet the licensing objectives before a hearing, then please accept that the Police will automatically withdraw their request for a hearing with the Licensing Committee

POLICE REPRESENTATIONS

I have identified conditions below which are appropriate and proportionate that would enable the premises to operate in line with the licensing objectives

1. A CCTV system be installed to an agreed standard as approved by South Wales Police and maintained and operated at all times when the premises are open to the public.
The system will cover all internal areas of the premises where the public have access (excluding toilets), including all entrances and exits and any external area associated with the premises.
The images will be kept for a minimum period of 31 days.
The images will be produced to a police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable.
There will be sufficient trained staff to facilitate the above.
CCTV signage will be placed in prominent positions inside and outside the premises.
2. The premises will operate the 'Challenge 25 Policy. This policy will be brought to customers' attention through the display of appropriate signage. Challenge 25 notices will be displayed in prominent positions throughout the premises. The only form of identification recognised will be photographic identification cards, such as driving licence, passport or proof of age scheme (PASS) card.
3. SIA licensed security shall be on duty at the premises at a ratio 1 to 100 members of the public on Friday and Saturday nights from 8.00pm until close.

On any other occasion when the premises are open beyond midnight, SIA licensed security shall be on duty at the premises at a ratio of 1 to 100 members of the public from 8.00pm until close.

4. When on duty at the premises one member of SIA security must wear a body camera which is capable of recording video and audio footage. The camera must be used when dealing with incidents of disorder or ejections from the premises.
The images will be kept for a minimum period of 31 days.
The images will be produced to a police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable.
5. A duty register shall be kept on site of all persons engaged as SIA security staff at the premises. It shall be made available on request to an authorised officer of the local authority or member of police staff. The register must include the following

Name of security staff
SIA number
Time and date of duty commenced and finished

6. An incident book shall be kept at the premises and maintained on site at all times. It shall be made available on request to an authorised officer of the local authority or member of police staff which record the following

All crimes reported to the venue
All ejections of patrons
Any complaints received (of a Criminal or Licensing nature)
Any incidents of disorder
All alcohol sale refusals



7. All staff will be fully trained before they are authorised to sell alcohol and will be refresher trained on a regular basis, with records kept on the training, retraining and initial authorisation and re-authorisation.
8. The area outside the front of the premises can only be used for licensable activities providing a valid Cardiff Council table and chairs (street café) permit is in existence for the premises. Persons using the area must be seated.
9. At least 75% of the licensable area of which the public have access will be laid out with tables and chairs

Additional evidence to support the Police representations and conditions may be used at a subsequent hearing before the Licensing Committee; this may be expanded on verbally, or by way of written evidence.

The planning permission (ref: 14/01396/DCO) allowing for the use of the premises as a Bar and Restaurant is subject to the following condition:

No member of the public shall be admitted to or allowed to remain on the premises between the hours of 1130-0900 Sunday to Thursday and 0030-0900 on Fridays and Saturdays
Reason: To ensure the amenities of occupiers of other premises in the vicinity are protected

The licensable hours (late night refreshment) applied for would constitute a breach of planning control. Notwithstanding the grant of a licence the premises should not operate outside of the hours permitted by planning permission. Failure to comply with such requirements could result in a maximum fine of £20,000 upon conviction at Magistrates' Court.

At Whitchurch PACT meeting of the 13th September 2016 a resident of Old Church Road aired their concerns regarding music and after closure noise relating to the establishment known as Miss Jones 25-29 Merthyr Road Whitchurch CF141DA.

The following Licence is being applied for.

1. The sale by retail of alcohol for consumption on the premises
2. The provision of regulated entertainment in the form of live music (indoors):
Monday to Sunday: 09:00 to 23:00
New Years Eve: 09:00 to 04:00
3. The provision of regulated entertainment in the form of recorded music (indoors):
Sunday to Thursday: 09:00 to 23:00
Friday and Saturday: 09:00 to 00:30
New Years Eve: 09:00 to 04:00
4. The provision of regulated entertainment in the form of recorded music (outdoors):
Monday to Sunday: 09:00 to 21:00
5. The provision of late night refreshment (indoors and outdoors):
Sunday to Thursday: 23:00 to 00:00
Friday and Saturday: 23:00 to 01:00
New Years Eve: 23:00 to 04:00

Concern was aired at the New years Eve 4am live music and refreshments being allowed outdoors licence being applied for.

Although Merthyr road is a hub of village life it must be remembered this is not the centre of the city it is a residential area surrounded homes.

It is not just the ongoing noise that residents in Old Church road can already hear from this establishment, but the customers leaving after its closure re: walking home taxis pick ups. They also have concern over the clearing up after closure or at clearing up at 5am in relation to the noise of bottles being disposed of.

Residents also stated that weekends they have to keep their windows closed, at the back of their house. Enjoyment of their small garden during the summer has also been spoiled due to the ongoing music they can hear from this establishment. I can only assume that they do not have licence for music outdoors after 9pm, that there are doors that are open out into the back area or and the music is too loud?

I have urged the resident and neighbours to send their own objections. But has this has been brought to Whitchurch PACT I have to forward this ongoing concern to the licensing committee. In the hope you will review this establishment live music and outdoor refreshment licence's and in particular refuse the 4am New Years eve application.

If music outdoor is to be allowed it must be monitored to ensure it is not entertaining the neighbourhood but the small are at the back of this establishment. Allowing drinking outdoors after 11pm and till 4am is unacceptable.

PROPOSED LICENSE CHANGES – MISS JONES MERTHYR ROAD WHITCHURCH CARDIFF CF14 1DA

I write to strongly object to any amendments to extend the licensing and entertainment hours (live music or otherwise) at the above premises for the following reasons:

- The noise levels from the premises on occasions when music is played can be heard quite clearly in the rear of my home and garden. This means that if I retire to bed at a reasonable hour I am unable to actually sleep until the bar closes and customers clear the whole area. This has also had an effect on how I use of my garden as noise levels carry.
- As you will appreciate when people leave a bar their farewells are often lengthy and loud which extend noise levels beyond licensing hours.
- It must be remembered Whitchurch is a suburban residential area and not the centre of the City.
- It is very disconcerting to realise that I have virtually no say in this matter, whereas I would hope to have more if the noise and disruption was coming from a private address, as opposed to a business premises, i.e. Miss Jones.

Since the premises have been granted a license it had affected how I actually use my home which I feel is totally unacceptable. I have written on two occasions to the Council to complain about noise levels when I was told my letters had been passed to the Noise Pollution Dept. but then heard nothing further. I hope this letter to your Dept will generate a response.

My own position on this application, as with so many other applications of this nature, is that the council needs to take a nuanced approach: we need to balance our support of local businesses that meet the legitimate desires of those people who wish to go and out and enjoy themselves with the rights of local residents to periods of rest and tranquillity (particularly so that children and adults can, respectively, sleep in preparation for school and work the next day). It is against this background that I would point out that Whitchurch PACT meetings have, over a period, of time recorded concerns about the level of noise emanating from Miss Jones. I have also received some representations from individuals on the same subject. I note that the application relates to music indoors, but local residents have asked whether the doors and windows are sometimes open because the sound is reportedly excessive at times. I would, therefore, respectfully ask the Licensing Committee to investigate this aspect of the application.

Miss Jones is a valued part of the village and, it should be noted, supports local charitable events. My comments are therefore not hostile to the business *per se*. However, I am persuaded that some local residents do have legitimate worries about certain aspects of this application and would accordingly ask you to give their concerns serious consideration.

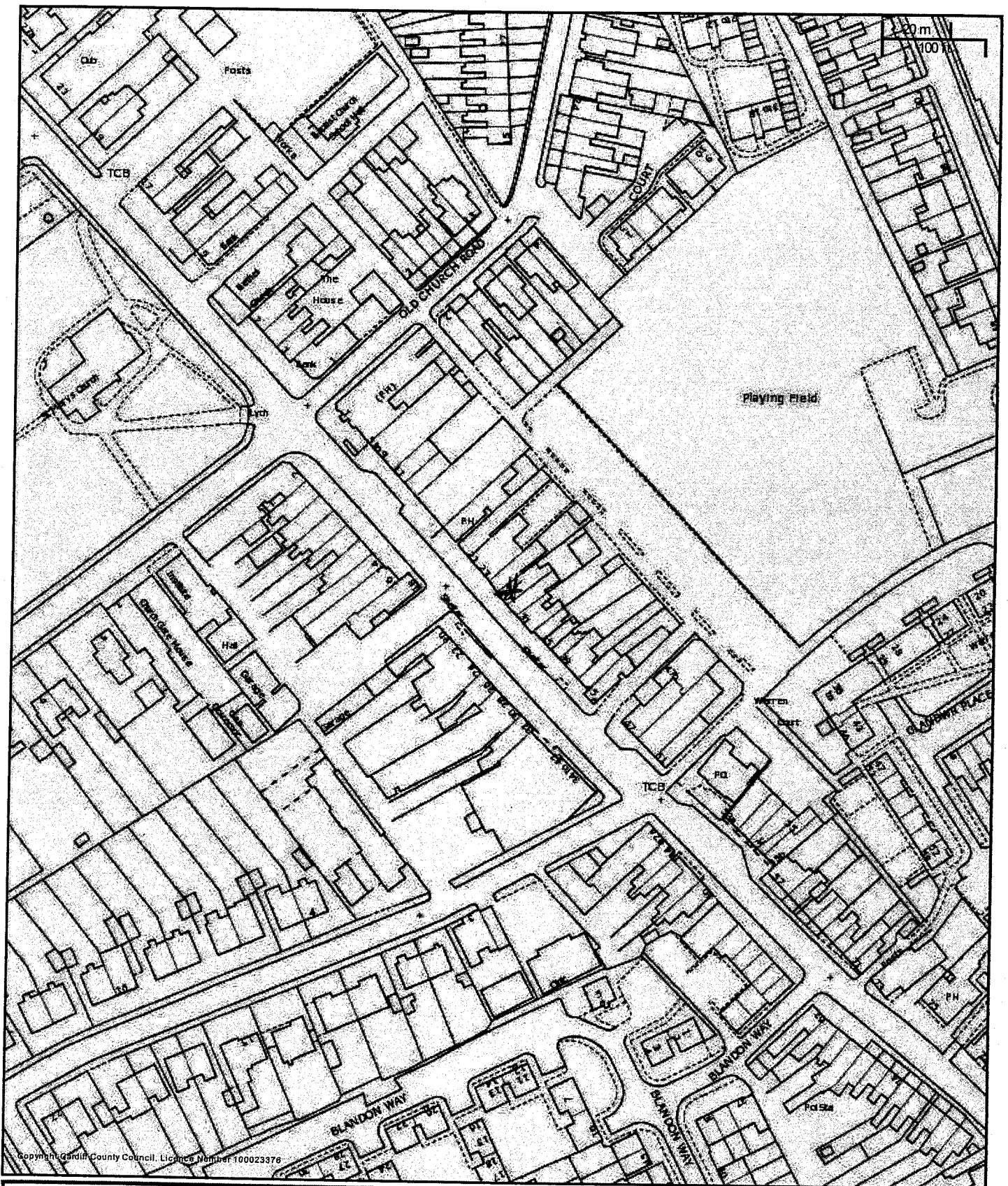
