## The Application

An application for a Premises Licence – Grant was received from Mrs Naomi Gropetis in respect of Miss Jones, 25-29 Merthyr Road, Whitchurch, Cardiff, CF14 1DA.

The applicant had applied for the following:

The sale by retail of alcohol for consumption on the premises:

Sunday to Thursday: 9:00 to 23:00 Friday & Saturday: 9:00 to 00:30 New Years Eve: 9:00 to 04:00

The provision of regulated entertainment in form of live music (indoors):

Monday to Sunday: 09:00 to 23:00 New Years Eve: 09:00 to 04:00

The provision of regulated entertainment in form of recorded music (indoors):

Sunday to Thursday: 9:00 to 23:00 Friday & Saturday: 9:00 to 00:30 New Years Eve: 9:00 to 04:00

The provision of regulated entertainment in form of recorded music (outdoors):

Monday to Sunday: 09:00 to 21:00

Provision of late night refreshment (indoors and outdoors):

Sunday to Thursday: 23:00 to 00:00 Friday & Saturday: 23:00 to 01:00 New Years Eve: 23:00 to 04:00

At the commencement of the meeting, Members were advised that there were no changes to the original licence application, which, due to an administrative error, had not been transferred within the required deadline. There were no responsible authorities' representations however the police had suggested further conditions such as upgrading the door security, which had been accepted by the applicant. Further to this the door staff had been provided with body cameras and the CCTV system had been upgraded.

Members considered the Noise Pollution Report provided by CDM on behalf of Miss Jones.

Councillor Ben Thomas advised Members that his ward Councillors had addressed any concerns made by residents and he was happy to support the application being satisfied that any concerns had been adhered to.

In response to a question from Members, Janice Hughes explained that she considered that there had been lack of communication and residents should have taken any concerns directly to Miss Jones rather than to a future PACT meeting.

RESOLVED: – That the Sub-Committee having considered all the information and in accordance with the requirements of the Licensing Act 2003, the Section 182 Guidance and the Licensing Authority's own Statement of Licensing Policy the Sub Committee granted the application, subject to a slight grammatical amendment of the original set of licensing objectives under the section 'The prevention of public nuisance'.
