The Licensing Act 2003 requires that the premises user must either ensure that a copy of the Temporary Event Notice is prominently displayed at the premises, or is kept at the premises in his/her custody, or in the custody of a nominated person present and working at the premises and a notice specifying that fact and the position of that person is prominently displayed at the premises.

Under the Licensing Act 2003, the Police and Environmental Health now have 3 working days to notify us if they intend to object to your Temporary Event Notice. We will notify you if an objection is received. If no objections are received, your event is permitted to go ahead under the authorisation of this Temporary Event Notice.

- (2) A CCTV system shall be installed to an agreed standard as approved by South Wales Police, maintained and operated at all times when the premises are open to the public. This system will cover all areas where the public has access (excluding toilets). The images will be kept for a minimum period of 31 days. The images will be produced to the Police employee in a readily playable format immediately when the premises are open to the public and at all other times as soon as reasonably practicable.
- (5) Registered door staff are to be employed by the premises after 22:00 hours Sunday to Thursday. The ratio shall be one to each 100 customers.
- (6) Provisions will be made to enable SIA approved and trained door staff to carry out searches of customers when deemed necessary.
- (7) When the premises are to be open to the public after 03:00 hours, all drinks are to be dispensed in non-glass vessels from 23:00 hours the previous day.
- (9) Internal radios to be used by staff Friday and Saturday.
- (10) Incident log book to be kept and maintained and available to the Police at their request.
- (11) On days considered to be major events in the City and Cardiff Bay areas, such as a sporting event or concert in the Millennium Stadium. All drinks shall be dispensed in non glass or plastic drinking vessels, the exception will be if person are seated at tables and partaking of food.
- (13) All recorded music must be played through a specified limiter (noise) RODEC audio level controller single 19" unit connected to a SERATO Pioneer Professional mixer, set to a level which is agreed by the Local Authority's Pollution Control Department which ensures that the music will not cause a public nuisance.
- (14) Amplified live music is not permitted at any time.
