I have caused enquiries to be made into this application. As a result of these enquiries, I now make the following representations. I therefore ask that the Licensing Committee hear these representations made by the Police when determining the grant of this application.

POLICE REPRESENTATIONS.

At this time, the Police object to the granting of a variation to the existing premises licence. However, should the applicant agree to the below detailed conditions, the Police will withdraw their objections and withdraw their request for a hearing before the Licensing Committee.

1. A CCTV system shall be installed to a standard as approved by South Wales Police and maintained and operated at all times the premises are open to the public. The system will cover all internal areas of the premises where the public have access {excluding toilets} including all entrances and exits and any external areas associated with the premises. The images shall be kept for a minimum of 31 days and shall be produced to a Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

2. An incident book shall be kept at the premises and maintained on site for a period of twelve months. It shall be made available on request to an authorised officer of the local authority or a member of police staff, which will record the following:

All crimes reported to the venue

Any complaints received (of a Criminal or Licensing nature)



<p>Dear Planning Officer,</p> <p>With regards to the application for Chunky chicken to extend closing hours from 11:30 till 2 am, we would like to convey our strong objection and strongly request that permission not be granted. I live directly opposite the takeaway and the surrounding clubs and several kebab shops / missmillies that open till 3 am. It is not just the late night opening times but also the extra people attracted to the area during these times that causes anti social behaviour/ noise/litter/ illegal parking.</p> <p>The owners of these properties apply for and are granted permission to operate late hours, yet live nowhere near any of their properties to put up with the disturbances caused.</p> <p>Increasing the current opening hours at Chunky Chicken will have negative implications for the adjacent residential homes on strathnairn st and glenroy st, which are already suffering with a shortage of parking spaces and smell from their chimney.</p>

Dear Officer,

I wish to express my anxieties regarding the extension of opening hours from 11:30 till 2 am of Chunky Chicken on 230 City road, Cardiff, CF24 3JH.

As a nearby resident, I live just behind the takeaway and strongly request that permission not be granted to open another food outlet / takeaway until 2 am or indeed beyond its current time of 11:30pm.

I think this area is already saturated and drowning in late night takeaways and through traffic of people. On weekends the place has been full and noisy with people from clubs and bars who take a taxi to Chunky chicken and walk home from there (rather than taking a taxi directly), increasing the noise, sleep disturbance and anti-social behaviour which can reach unacceptable levels.

The noise / fumes generated from the takeaway extractor fans permeate our street air quality leaving a permanent smell in the air.

Increasing the opening hours would mean a regular occurrence of such events.

Please could you consider our strong objection and assist in this matter.

We are already suffering from increased congestion from their delivery car parking on our street. The area is saturated with late night takeaways. This has resulted in a loss of air quality from extractor fan fumes permeating into our street, noise and disturbed sleep from late night customers.

This area is already drowned in late night extra traffic from extra customers/people encouraged by the food outlets who remain in the area after the food outlet is closed. Other environmental issues such as rubbish and pollution is generated also. 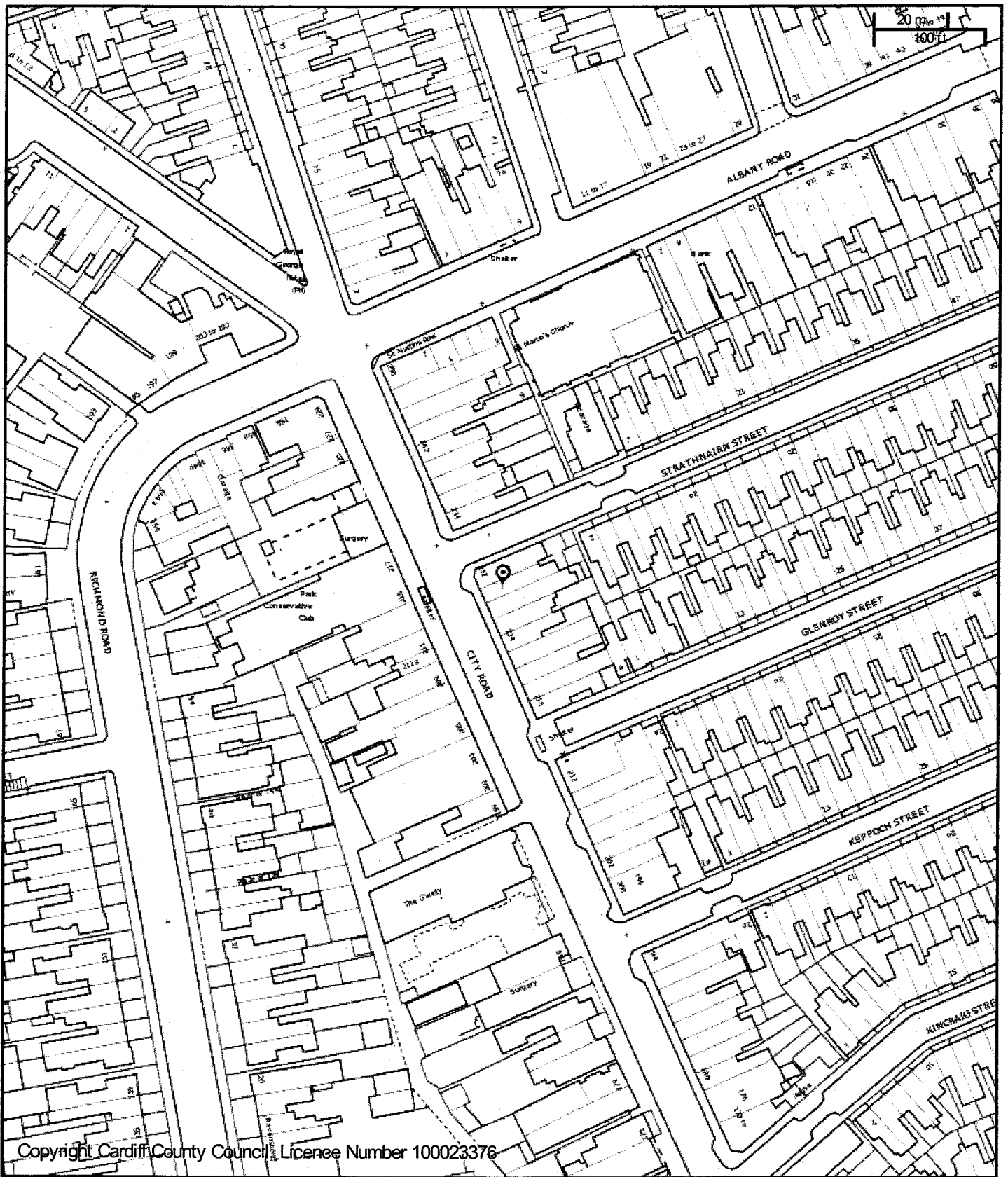
