Cardiff Speaker Hire, Unit 4 Anchor Industrial Estate, Dumballs Road, Cardiff

I have considered your notification a temporary event notice for the above named premises on dates between 3rd March 2018 and 4th March 2018.

The nature of the event, its promotion on social media and internet videos linked to the event are contrary to the licensing objectives of the prevention of crime and disorder and public safety.

The promotions are entitled "Babylon Dead". The main poster depicts a police van on fire and a police officer lying next to it surrounded by a hooded gang. The linked videos on social media show videos of mass public disorder and personal violence against uniformed police officers including officers being set on fire.

The temporary event notice states that there will be a maximum of 200 people present in the premises. The fire safety risk assessment for the premises is set at 120.

William DAVIES does not have control over the ticket sales and the ticket sales are advertised as available in advance and also on the door during the event.

Mr DAVIES has not demonstrated any control over the numbers of people that will turn up at the event.

Accordingly South Wales Police object to this Temporary Event Notice.

Additional evidence to support the notice of objection may be used at a subsequent hearing before the Licensing Committee; this may be expanded on verbally, photographically or in written form.
