Application for Premises Licence - Grant

Application No: 087220

Name of Premises: Local Express, 94 Crwys Road, Cathays, Cardiff CF24 4NQ

Ward: Cathays

1. Application

1.1 An application for the Grant of a Premises Licence has been received from Local Express 94 Ltd in respect of Local Express, 94 Crwys Road, Cathays, Cardiff CF24 4NQ.

1.2 The applicant has applied for the following:

(1) In respect of the following licensable activities:

(i) The sale by retail of alcohol for consumption off the premises.

(2) Description of Premises (as stated by applicant):

"The property is on the ground floor with entrance and exit to Crwys Road. They intend to operate as an off licence as the primary business with a small selection of general grocery. There will be no alcohol consumed on the premises."

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Monday to Sunday: 08:00 to 23:00 hours

(4) To provide licensable activities during the following hours:

(i) The sale by retail of alcohol for consumption off the premises:

Monday to Sunday: 08:00 to 23:00 hours

1.3 A site map showing the premises and the plan of the premises submitted with the application can be found in **Appendix A**.

2. Promotion of Licensing Objectives

2.1 The conditions proposed by the applicant for the promotion of the licensing objectives are attached to the report and can be found in **Appendix B**.

3. Relevant Representations

- 3.1 Two representations have been received from local residents. A copy of these representations is attached as ***Appendix C***.

4. Legal Considerations

- 4.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives, which are:

Prevention of crime and disorder
Public Safety
Prevention of Public Nuisance
Protection of Children from Harm

- 4.2 In each case the Sub-Committee may make the following determination:

- a) To grant the application.
- b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
- c) Reject the whole or part of the application.

- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council e.g. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

5. Issues for Discussion

- 5.1 The application should be determined and the appropriateness of any conditions on the licence needs to be discussed.

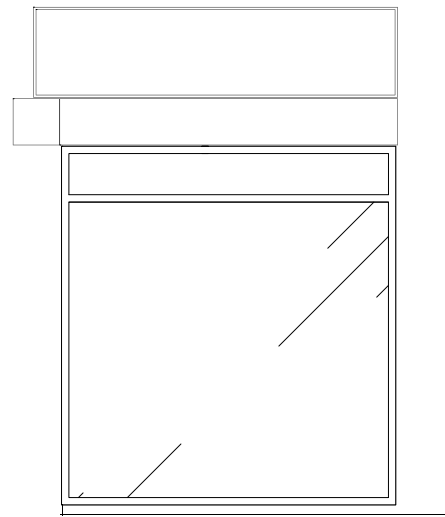
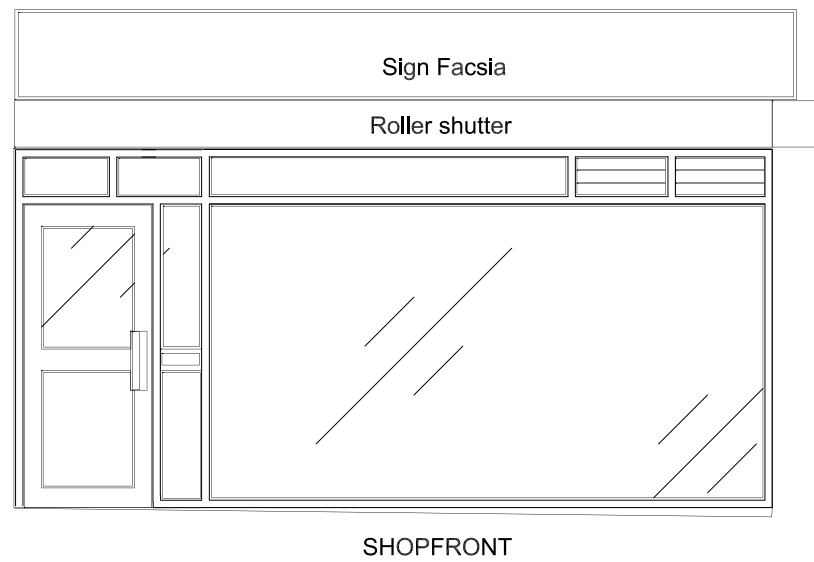
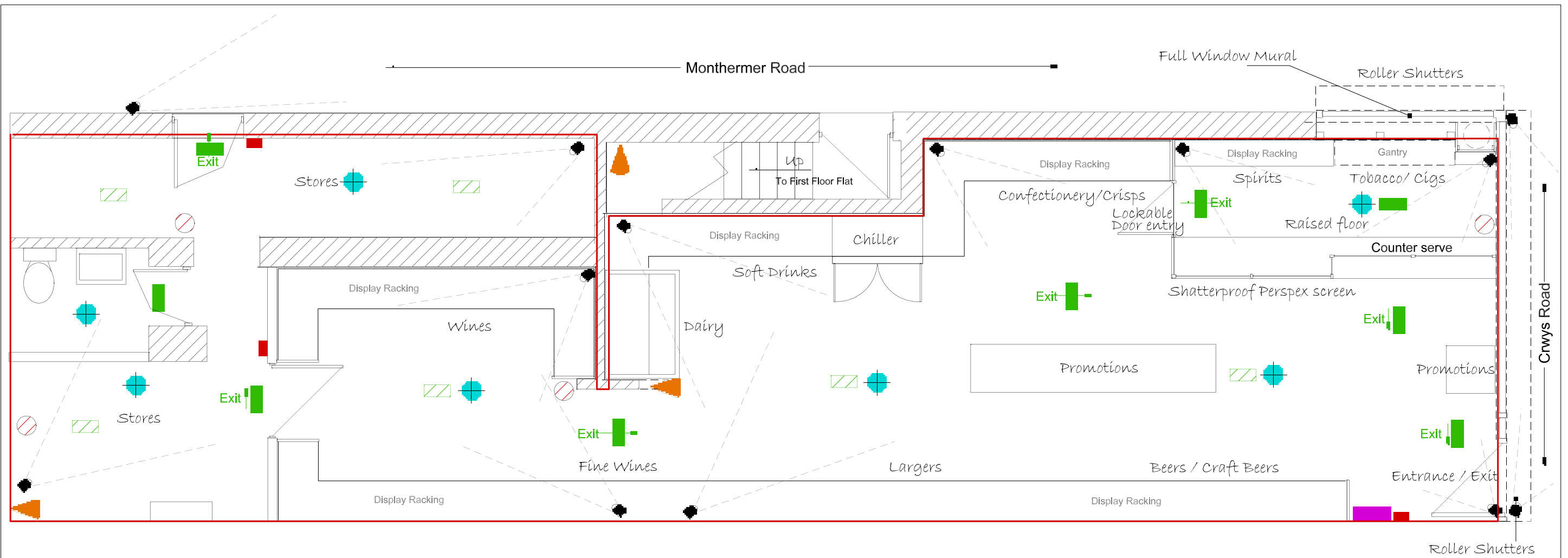

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

We will be responsible Licensees and operate a Challenge 21 age verification policy.
We will operate a daily litter sweep to make sure there are no cigarette ends outside the premises.

b) The prevention of crime and disorder

We will operate CCTV on the premises and over the entrance and exit.
Recordings will be maintained on a secure file for 31 Days,
Acceptance of accredited 'proof of age' cards and /or 'new type driving licences with photographs, Passports, an official identity card issued by H M Forces.
Effective and responsible management of premises-at all times a duty manager is on site.
We provide training of staff
Adoption of best practice guidance (e.g. The National Alcoholic Harm Reduction Strategy Toolkit and our own codes of practice.

c) Public safety

Staff will be trained in fire dispersal/Evacuation policy and a record kept of training.
First aid kits will be kept on the premises and a duty first aider on hand .
Fresh drinking water will be supplied at all times
Public areas will be clear of clutter and shelf filling will be carried out after hours of trading.

d) The prevention of public nuisance

No alcoholic drinks will be permitted to be opened on the premises.
 The prevention of groups gathering around the entrance.
 To avoid a noise pollution whilst leaving the establishment.

e) The protection of children from harm

There will be no entry to the premises for adults under the age of 18 during trading hours.
 Unless accompanied by a responsible adult.
 We will have a written proof of age policy which staff will be trained
 Signs and legends to make customers aware

Dear Kirstie

I'm a resident of Cathays living at [REDACTED], Cathays Cardiff CF24 4PF. I'm also currently the Chair of Keep Cathays Tidy and I am happy for it to be put on the record that the bins left permanently on the pavement of Monthermer road and belonging to 94 Crwys Road are in my opinion a public nuisance and the granting of a licence in my opinion does undermine the 3rd objective - **the prevention of public nuisance**

We already had a problem with bottles and pint glasses being left on top of the BT exchange boxes outside the side of 94 Crwys Road but this has now been made worse since the two commercial bins belonging to the business have been permanently based on the pavement.

As the top of the bins have curved tops; bottles left on top of them easily roll off and break if the bins are bumped or if it's windy. The Council cleaning teams do a great / if thankless job of keeping Monthermer Road clean but small pieces of broken glass can be seen here this morning even after their clean up.

I have in the past suggested that Council bins be placed on this junction; as the pavement has a high footfall of students coming home from clubs and pubs or going to the recreation ground on Ninian Road "The Recc".

I would like to make a representation that the granting of a licence undermines the 3rd objective - **the prevention of public nuisance**

The applicant does not have a rear yard / facility to store refuse bins for the collection of commercial general waste or commercial recycling waste created by the sale of alcohol and currently general waste bins and recycling bins are left on the pavement outside the shop 24 hours a days 7days a week - see further photograph taken today

Leaving commercial bins on the public pavement 24/7 is one issue causing a public nuisance

The second issue causing a public nuisance is that customers who have been purchasing products from 94 Crwys Road and consuming them in the street are then leaving their empties either on top of the bins which fall off or left on the floor next to them where they accidentally get kicked/broken when it's dark. As this is a main route / busy junction for students returning from town late at night a lot of bottles and cans are regularly being left on this corner of Crwys Road/Monthermer Road.

Again I believe the four councillors can testify to this problem if asked
