#### 1. Application

- 1.1 An application for the Grant of a Premises Licence has been received from Oasis Cardiff in respect of Oasis Cardiff, 69b Splott Road, Splott, Cardiff, CF24 2BW.
- 1.2 The applicant has applied for the following:
  - (1) In respect of the following licensable activities:
    - (i) The sale by retail of alcohol for consumption on the premises.
  - (2) Description of Premises (as stated by applicant):

"A community center for Asylum Seekers and Refugees; adapted from an old Methodist Church. Two halls on the ground floor that are used for daily activities and are hired out in the evening for the local community. Events are catered for via use of a large commercial kitchen in the premises. A mobile food trailer is also operational on the external car park, within the weekday".

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Monday to Sunday: 17:00 to 22:00 hours

- (4) To provide licensable activities during the following hours:
  - (i) The sale by retail of alcohol for consumption on the premises.

Monday to Sunday: 17:00 to 22:00 hours

1.3 A site map showing the premises and a plan of the premises submitted with the application can be found in *Appendix A*.

#### 2. Promotion of Licensing Objectives

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report and can be found in *Appendix B*.

#### 3. Relevant Representations

- 3.1 A representation has been received from South Wales Police. A copy of the representation can be found in *Appendix C*.
- 3.2 Representations have been received from local residents. Copies of the representations can be found in *Appendix D*.

#### 4. Legal Considerations

4.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives, which are:

Prevention of crime and disorder Public Safety Prevention of Public Nuisance Protection of Children from Harm

- 4.2 In each case the Sub-Committee may make the following determination
  - a) To grant the application.
  - b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
  - c) Reject the whole or part of the application.
- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council e.g. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

#### 5. Issues for Discussion









11. No staff below the age of 18 are allowed to serve any alcohol in our premises, they will inform the DPS or line manager to carry out that service.

#### CONCLUSION

The following conditions have been offered by yourself as the applicant, however South Wales Police wish for the wording of these conditions to be changed;

#### Condition 1 and 12 to read:

Challenge 25 shall be in use at all times licensable activities are undertaken. Any person who appears to be under the specified age will be required to prove they are over 18. The only acceptable forms of identification in these circumstances are photographic identification documents such as passport, PASS hologram or Driving Licence. Where a customers age is in doubt and no identification is available, no sale of alcohol will be permitted. Signs to be displayed in prominent positions throughout the premises advising customers of this policy.

South Wales Police wish to object to the grant of this application under the Licensing Objectives;

Prevention of Crime and Disorder Prevention of public nuisance Protection of children from harm

However, should you as the applicant be minded to agree to the below conditions, then South Wales Police will withdraw their objection.

#### Hours agreed for the sale/supply of alcohol being:

Monday to Sunday 17:00 – 21::30 hours

South Wales Police request that the following conditions are added to the premise licence:

1. A CCTV system will be installed to an agreed standard as approved by South Wales Police and maintained and operated at all times the premises are open to the public. The system will cover all internal areas of the premises where the public have access (excluding toilets) including all entrances and exits and any external area associated with the premises. The images will be kept for a period of 31 days and produced to a police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

- 2. An incident book shall be kept at the premises and maintained on site at all times. It shall be made available on request to an authorised officer of the local authority or member of police staff which record the following;
- i) All crimes reported to the venue
- ii) All ejections of patrons
- iii) Any complaints received (of a criminal or licensing nature)
- iv) Any incidents of disorder
- v) Any visit by representatives of a relevant authority or emergency service
- vi) Any faults in the CCTV system

Staff will be trained in relation to their responsibility to complete an incident report. Access to incident reports shall be made available to South Wales Police on request.

- 3. All staff involved in the sale of alcohol shall be trained to record refusals of sales of alcohol in a refusals log (whether written or electronic)
- 4. Staff authorised to carry out Licensable Activity shall receive initial training in relation to age related sales, sales to intoxicated persons and age challenge procedures prior to being allowed to work at the premises. Refresher training shall be conducted every 12 months. The DPS shall keep records of such training for a period of at least 18 months.
- 5. A minimum of two (2) SIA door supervisors will be employed at the premises when attendance is over 100 patrons, employed at all times from 17:00 until premises closes. At all other times SIA registered door supervisors will be employed at the premises in accordance with a written risk assessment carried out by the Premises. A copy of the risk assessment will be maintained for 12 months and be made available to the Police immediately upon request.
- 6. A register of door supervisors will be kept at the premises. The register shall contain the full name and SIA registration number of each door supervisor, stating the start and end duty times from each door supervisor. The register will be kept for a minimum of 12 months and will be made available to a Police employee on request.
- 7. When SIA registered door supervisors are employed at the premises they will utilise at least one body worn video device. Any such device will be capable of recording both audio recordings and visual images. The recordings will be kept for a minimum of 31 days and will be produced to a Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.
- 8. SIA Licensed door staff shall each carry an internal radio to allow communication between themselves and management.
- 9. Lagers, beers and cider above 5.5% ABV shall not be sold from the premises.

## Oasis Cardiff - Objection to Alcohol Licence Application

To Whom it may Concern

I wish to object to the application that the Oasis Centre on Splott Road has recently put forward.

First of all I don't think it appropriate for a refugee centre to have an alcohol licence. I live along Splott Road and already see many people coming and going to and from the centre. Many would have cultural and/or religious reasons for avoiding alcohol and I'm sure some are vulnerable individuals, possibly even alcoholics themselves, who would not benefit from alcohol being anywhere on the premises. I understand that the licence may be to support room hire and possibly holding functions on the premises in order to raise funds but I still think there will be a danger of conflicting interests. I, myself, am involved with a small charity where we rent rooms and we would not dream of compromising our ethical beliefs simply to raise money.

The second reason I'm objecting is because, inevitably, an alcohol licence will increase traffic to the area. We already suffer from parking problems in most nearby streets and, even though there used to be a parking area in front of the building this is mostly taken up with a large marquee and a couple of camels. Patrons would have to park in the surrounding streets causing more difficulty and inconvenience to local residents. I regularly have to go round the block 3 or 4 times or more when I come home to try and park and have to eventually park some distance away, moving the car several times to try to get back near my house.

The third reason is because of the noise and disturbance that will be caused by people attending events where alcohol is present. Occasionally they have had events, usually on the weekend, where loud music can be heard from a distance especially if the event is outside. I feel sorry for those living next door and closer than me but if attendees will be drinking alcohol in future it will only get worse. The license application states times between 5pm and 10pm but the noise and disturbance created will carry on beyond then even if the sale of alcohol terminates at 10pm.

I often walk home from friends nearby and pass by the Oasis Centre. I would feel very intimidated if there were people who had been drinking hanging around on the pavements outside the centre. It's already more worrying walking home late in this area and I never carry any valuables with me if I'm out late.

I can't imagine that anyone living in the close vicinity of the Oasis Centre will think that it's a good idea for a building that was actually a Methodist Church to be transformed into a drinking hall. I just hope that sufficient numbers make the effort to voice their opinions.
