### 1. Application

1.1 An application to vary a Premises Licence has been received from Premier Golden Kebabs Ltd in respect of T & A Kebabs, 4 Miskin Street, Cathays, Cardiff, CF24 4AQ.

1.2 The licence currently permits the following:

The provision of late night refreshment (indoors):

Sunday to Thursday: 23:00 to 00:30 hours

Friday and Saturday: 23:00 to 02:00 hours

1.3 The applicant has applied for the following:

To vary the hours permitted for the provision of late night refreshment as follows:

#### **4. Legal Considerations**

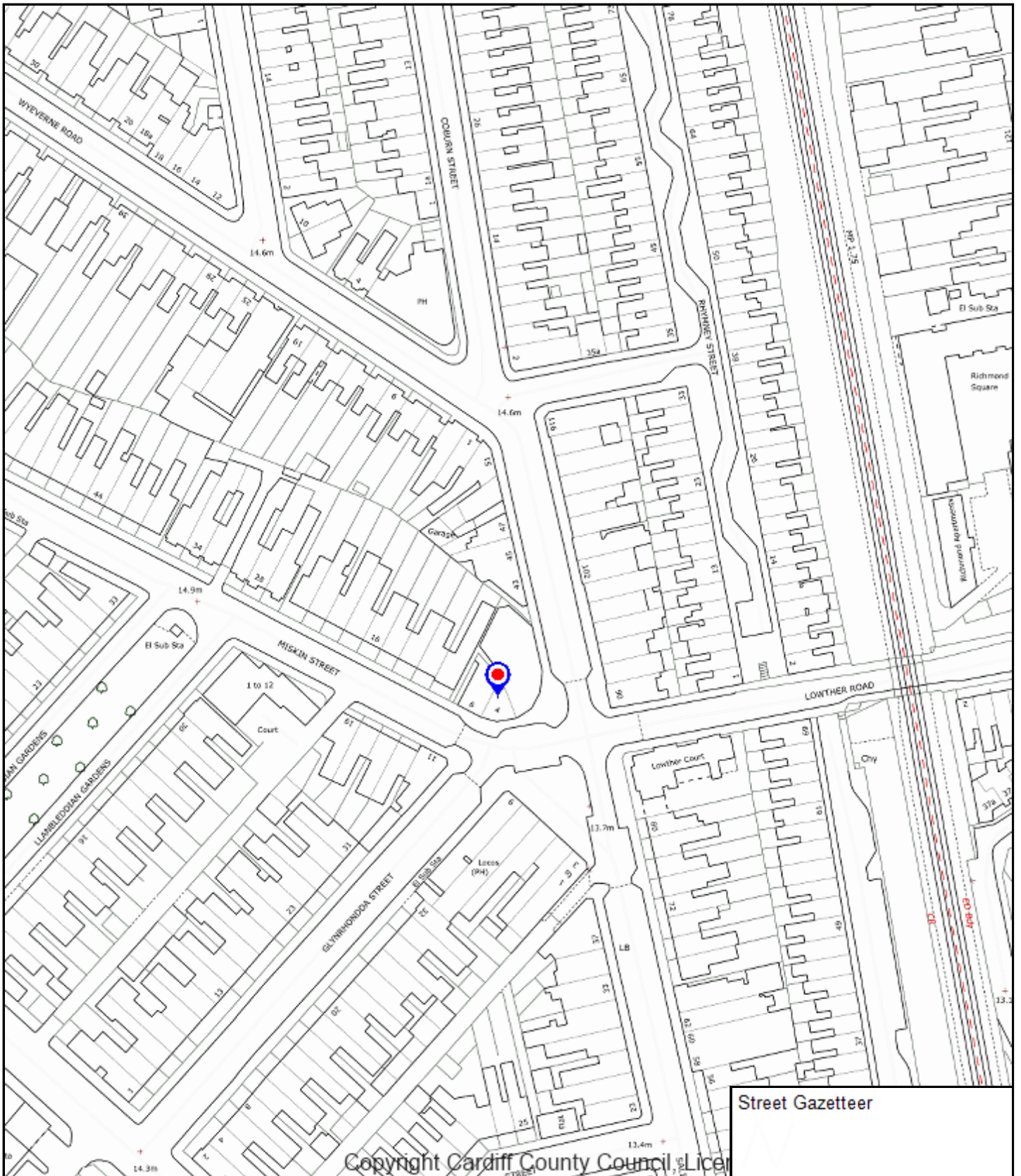

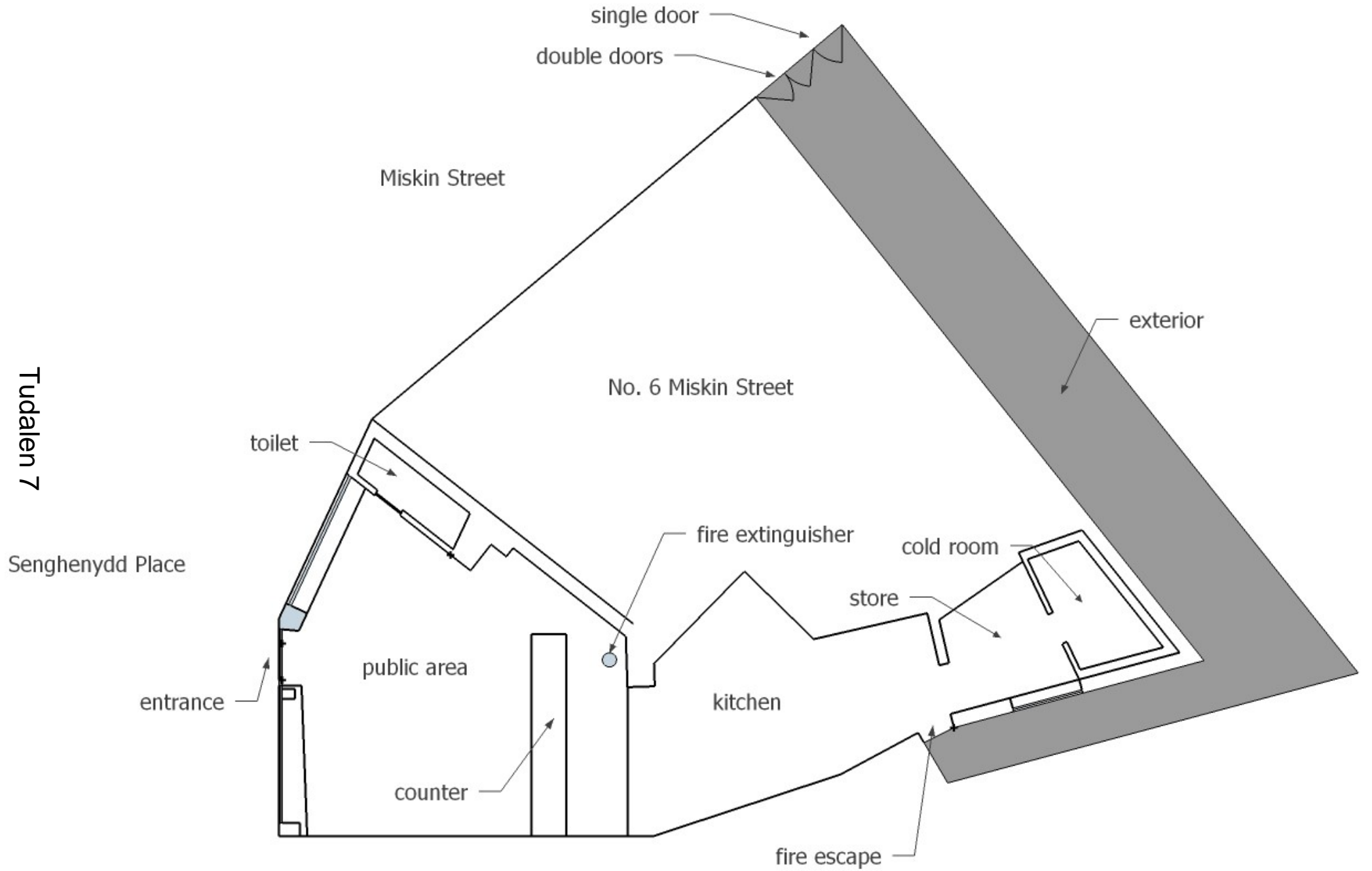

Good Afternoon

The Licensing Authority would wish to object to the above application on the grounds of Prevention of Crime and Disorder.

Historically information came to light that the premises trading without a licence (previous licence had lapsed) and subsequently once they obtained a licence continued to trade whilst not in compliance with its licence. This complaint stretches back prior to but now also including the time at which the current licence holder Premier Golden Kebabs Ltd started trading. These complaints related to trading until 04.00 am without a licence. Initial involvement from the department started in December 2022, with the most current and relevant visits occurring in 2023.

It was noted by staff during visits that the same individuals identified themselves as management both prior to and now whilst the current licence holder is in place. This would have indicated that even during the previous investigations staff would have been aware of the limitations of trading until the specified hours on the licence.

Officers worked with the business at the time to apply for a licence, their original application was until 05.00 am however the business agreed following representation from Pollution Control to limit the hours to their current trading arrangement. However Following previous warnings of trading outside of licensed hours and after the business agreeing to their current hours officers continued to witness breaches of premises licence on the 11/05/2023 at 00:45am and 14/05/2023 at 02:15am. Currently the licence holder Premier Golden Kebabs is in legal proceedings with the local authority for these offences.

The premises now seeks to apply for a licence to trade until 04.00 hrs. The premises has displayed irresponsible management and considerable disregard to licensing objectives and to upholding the conditions of their current licence. This view is supported within the statement of licensing Policy where Examples of circumstances that may cause the Licensing Authority to make representation include:- • Where there is evidence of non-compliance with the existing Premises Licence. (In the case of variation or review applications). It is the authorities position that the committee should be aware of the current evidence held in relation to the premises prior to determining this application for variation.

I write on behalf of myself and of Cllrs Sarah Merry, Chris Weaver and Ali Ahmed, as Councillors for Cathays to object to the above application for a variation of their Licence.

It is our understanding that the current Licence allows opening until 12.30am Sunday to Thursday and 02.00am on Fridays and Saturday.

To extend the opening hours until 4am every day will serve to increase the noise, crime and anti-social behaviour in this area and will cause further disruption to residential streets and the nearby social housing.

It is very likely that prospective customers will call in for a kebab on the way home from nightclubs and at around 4am they are also very likely to be intoxicated and prone to create noise and antisocial behaviour.

This not only disturbs residents but will also increase the work of the already stretched police officers in the area.

South Wales Police crime statistics record 753 reported crimes around that area between June and November 2023. That includes 180 for violent or sexual offences. These do not include incidents that the police deal with at the time and take no further action. Cathays does not want to see these already large crime figures increase.

We object to this application on the grounds that it will not promote the Licensing Objectives of the prevention of:

Crime and Disorder as it will encourage more intoxicated people to the area at a later hour on a daily basis;

Public Safety and Public Nuisance in that there will be increased noise, antisocial behaviour and violence.

We ask you to refuse this application.
