1. Application

- 1.1 An application for a Premises Licence Variation, has been received from WM Morrison Supermarkets PLC in respect of M Fuel (Morrisons), Newport Road, Cardiff, CF23 9YG.
- 1.2 The current conditions attached to the Premises Licence:
 - (1) In respect of the following licensable activities:
 - 1. The sale by retail of alcohol for consumption off the premises.
 - (2) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Sunday 06:00 to 00:00

- (3) The premises are permitted to provide licensable activities during the following hours:
 - 1. The sale by retail of alcohol for consumption off the premises:

Monday to Sunday: 06:00 to 00:00

- 1. 4 The following application for variation is now made:
 - 1. To extend the hours for the sale of alcohol and opening to 24 hours a day, Monday to Sunday
 - 2. To permit late night refreshment from 23:00 to 05:00, Monday to Sunday
 - 3. To permit alterations to the premises in accordance with the plan deposited.

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report.

- 4.2 In each case the Sub-Committee may make the following determination

APPLICATION TO VARY A PREMISES LICENCE UNDER THE LICENSING ACT 2003. M FUEL {MORRISONS} 507 NEWPORT ROAD CARDIFF CF23 9YG.

To whom it may concern,

I have caused enquiries to be made into this application. As a result of these enquiries, I now wish to advise that the Police make an objection to the granting of a variation of the existing premises licence at Morrisons Supermarket 507 Newport Road, Cardiff.

These objections are based upon the following licensing objectives namely,

- 1. The Prevention of Crime and Disorder.
- 2. That of public safety.

However, should the applicant agree to comply with the representations made to meet the licensing objectives, before a hearing takes place, then please accept that the Police will automatically withdraw their request for a hearing before the Licensing Committee.

POLICE REPRESENTATIONS.

The following conditions are requested specific to M Fuel.

- 1. A Personal Licence Holder will be present at all times whilst the premises { M Fuel } is open to the public and alcohol is offered for sale.
- 2. Two members of staff will be present at all times.

RESTRICTED

- 3. SIA registered security staff will be present at the premises { M Fuel } between the hours of 22:00hrs and 06:00hrs in addition to the two members of Morrisons staff.
- 4. No display of alcohol shall be located within 5 metres of the entrance to the premises.
- 5. 'The premises { M Fuel } will operate a Challenge 25 policy. This policy will be brought to the attention of customers by the use of appropriate signage. Challenge 25 notices will be displayed in prominent positions in the premises. The only form of identification recognised will be photographic identification cards such as driving licence, passport or proof of age scheme cards. All permanent staff will receive the appropriate Challenge 25 training, having completed a minimum of six continuous weeks of employment'.
- 6. An incident book shall be kept at the premises { M Fuel } and maintained on site at all times. It shall be made available upon request to a Police officer or other authorised person. This will record the following;

All crimes reported to the venue

Any complaints received.

Any incidents of disorder

Any refusal of the serving of alcohol


Any visit by a representative of a relevant authority or emergency service.

7. A CCTV system shall be installed, maintained and operated at all times when the premises { M Fuel} are open to the public. The system will cover all internal areas of the premises to which the public have access, excluding the toilets, including all entrances and exits. These images will be retained for a period of 31 days and will be of sufficient quality to identify persons entering the premises and provide the registration numbers of vehicles entering the forecourt area of the premises. The images will be produced to a Police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate this condition.
