ENGAGEMENT AND PARTICIPATION OF CHILDREN & YOUNG PEOPLE - INTRODUCTORY BRIEFING

Purpose of the Report

 For Members to receive a brief overview of this Agenda Item ahead of the formal committee meeting, where Members will receive a presentation from Cabinet Members, senior officers and a young person.

Background

2. In July 2023, Members agreed to make the issue of "engagement and participation of children & young people" a priority topic for the Committee during 2023/24. At this time, Members were asked what they would wish to consider as part of this topic, and they responded as follows:

Potential Approach:

- Cross- authority issue
- Need to understand the range of E&P with CYP across the authority
- Look at areas of good practice across the authority
- Are there areas for improvement across the authority gap analysis?
- How are service areas working together?
- Who are key partners?
- How effective are we working with key partners such as Police, Health, third sector?

- What groups/networks of CYP are currently in place and how effective are they?
- Mapping out this work if possible?
- How are we engaging and working with CYP across areas such as community safety; safeguarding board; corporate parenting etc.
- Examples of positive outcomes arising from E&P with CYP.
- Examples of good practice working across partners
- Child Friendly City status how has this impacted improved E&P

Potential witnesses:

- Would be good to involve those members of council staff leading on the consultation process/ Officers responsible for consultations across Cardiff Council.
- Representatives of young people themselves.
- Relevant staff and clients of the Youth Service.
- Members of Young People's Parliament
- Members of Youth Council (including CYPSC rep)
- Members of other Cardiff wide Youth 'voices' organisations
- Others to be agreed with lead service areas

Issues

- 3. At this meeting, Members will receive presentations from the following services:
 - Child Friendly City Team
 - Children's Services
 - Youth Services
 - Community Safety
 - Education Cardiff Commitment and School Organisation Planning
- 4. The focus of this session is for Members to receive introductory presentations from the above, who will be supported by Cabinet Members. The aim (at this stage) is to give the Committee a briefing on work taking place across these areas, with a view to give Members a baseline for further scrutiny at a later date.

- 5. Members are requested to note that this briefing will not be a "hold to account" session, but an information briefing; and are therefore asked to keep questions to points of clarification at this stage.
- 6. Attached at **Appendix A** is a short report from the Child Friendly Cities Team setting the context for today's session. Members are asked to click on the link in **paragraph 4 of Appendix A**, which sets out a range of supporting information and evidence, which will include information from South Wales Police and Cardiff & Vale Health Board.
- 7. Members will recall that, during the past 12 months, they have considered a range of evidence arising from engagement and participation of young people, particularly in the School Organisation Planning (SOP) area of work. Members will remember hearing directly from the Cardiff Influencers in July 2023, where the Committee stated its support for the Influencers and recognised the Group as an example of good practice. The Influencers will be invited to May's meeting of this scrutiny committee when Members will consider the SOP Strategy.
