5: DECLARATIONS OF INTEREST

The Chairman reminded Members of their responsibility under Article 16 of the Members' Code of Conduct to declare any interest, & to complete Personal Interest forms, at the commencement of the item of business.

6 : SEPARATION OF FUNCTIONS – THE CHAIRMAN OF THE COUNCIL AND THE RIGHT HONOURALE THE LORD MAYOR

The report detailed proposals on the separation of the functions of the Chairman of the Council, and those of The Right Honourable the Lord Mayor of Cardiff.

Councillor Joyce, as Leader elect, advised that the administration believed that the recognised political governance and administrative functions of the Chairman the Council should be separated from the ceremonial and civic functions of the Lord Mayor as first citizen of Cardiff, and this would provide stronger focus and prominence to both roles.

The proposals sought to provide focus for the position of Chairman of Council, providing for the effective impartial chairing and conduct of the business at Council meetings. The ceremonial and civic functions of the Lord Mayor would continue to work to benefit local communities and the city's wider commercial interests. It would also enable the Lord Mayor to concentrate on the historic and traditional civic role and continue to

provide the sense of tradition and representation at civic functions and events.

The Leader elect advised that until such time as the formal separation has been achieved, the Chairman of Council would undertake both the administrative and the civic functions that are currently associated with the title of Lord Mayor without exercising the entitlement to use the title of Lord Mayor, and would be referred to as Chair of Council. In addition the Chair would take on additional responsibilities for chairing other Council Committees.

The proposals as set would implement a clear more effective separation of the business and civic functions of the Chair of Council and the Lord Mayor respectively.

The Chair invited debate on the proposals. During the debate a number of matters were raised relating to the mechanism for implementing the proposals and the timeframes for such an amendment to receive Royal approval. There were strong views that the Lord Mayor as the first citizen of Cardiff and the civic role were very important for Cardiff as the Capital City, and that the proposals would be detrimental to Cardiff's reputation.

Under Council Procedural 13 (e) Councillor Woodman proposed and this was seconded by Councillor *Bridges* that the motion be moved without notice, and the recommendations of the report be disapproved.

11: LEADER'S ANNOUNCEMENTS

The Leader took the opportunity on behalf of all the candidates who contested the Election on 3 May 2012 to thank the Returning Officer and his staff for their efficiency and hard work in ensuring that the Election ran smoothly. The Leader thanked every candidate who stood for Election for the interest that they had shown in Cardiff and it's Council, and for the valuable contribution they made to the democratic process.

The Leader was honoured to have been elected as Leader of the Council and to be given the opportunity to take Cardiff forward and ensure that the Cabinet delivers on the pledges made to the people of Cardiff. She

looked forward to working with communities across the city, seeking genuine improvements for all the people of Cardiff and the Capital City.

The Leader recognised that these were tough economic times, with difficult decisions and challenges to delivering more services for less money, and to support working families and protect the most vulnerable people in society who rely on Council services to achieve a reasonable quality of life.

The Leader detailed the key themes going forward for the future in particular the development of business links, including international links to develop investment opportunities and potential connections, and building on highly respected science and technology sectors to attract major investment into the city to boost the local economy.

The Leader underlined the importance for every young person in any part of the city to have the opportunity to reach their full potential and for the city to be NEET free (Not in Education Employment and Training). This would involve working creatively to get to the root of the issues.

Work would continue to support proposals to improve the city's transport links, including the electrification of the main Cardiff to London railway line, as well as Valley Lines, and to improve the roads, transport services and infrastructure in the city.

The Council will work to deliver a Local Development Plan to improve the quality of life for the residents of Cardiff and support its position as the Capital City and driving force in the city region.

The Council's transformation agenda remains extensive and far reaching and the money saved through proposed improvements would be reinvested directly into services.

The Leader concluded that she was ambitious for Cardiff and the Council and eager to start working with Cabinet to deliver a thriving, prosperous leading European Capital City.

12: THE CARDIFF UNDERTAKING FOR COUNCILLORS

On 1 July 2004, Council approved the Cardiff Undertaking to provide an opportunity for Members to publicly commit to using their term of office

to work for the Council, the City and its citizens, and to commit to the standards of conduct expected by the Council.

All newly Elected Members have signed up to the Cardiff Undertaking as part of the Induction process, and Members were asked to endorse their commitment to the Cardiff Undertaking at the meeting.

13: MEMBERS' REMUNERATION & ALLOWANCES 2012/13

The report detailed for consideration by Council the prescribed levels of Members' remuneration and allowances that are payable in 2012/13, as determined by the Independent Remuneration Panel for Wales.

The Independent Panel published its Annual Report in December 2011, which set out the actual levels of Basic, Senior and Civic Salaries and the maximum allowances which are payable to all Members across Wales in 2012/13 as part of a consistent national framework.

Paragraph 7 referred to the Council's ability to determine the allocation of up to 19 Senior Salaries in 2012/13, and details of the proposed allocation of 18 Senior Salaried positions within Bands 1-3 had been circulated.
