2 : ELECTION OF THE LORD MAYOR FOR THE COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF FOR 2014/2015

Council, at its meeting on 27 March approved the nomination of Councillor Margaret Jones as Lord Mayor Elect.

The nomination was formally proposed by County Councillor Walker and seconded by County Councillor Cowan.

RESOLVED – That County Councillor Margaret Jones be elected as Lord Mayor of the County Council of the City and County of Cardiff for 2013/2014.

3: ACKNOWLEDGEMENT FROM LORD MAYOR

The Lord Mayor was delighted and honoured to be elected Cardiff's 110th Lord Mayor and wanted to thank Councillor David Walker and Councillor Jayne Cowan for their kind words, and her husband Lawrence, family and friends for their support here today.

The Lord Mayor fully appreciated the high expectations that come with the role of first citizen and relishes the challenge that has been set up for her to help ensure that Wales' capital city, and all it has to offer, continues to be projected in the best possible light to all with whom she comes into contact.

The Lord Mayor congratulated Councillor Ali Ahmed on his inauguration as the first Muslim Deputy Lord Mayor for the City of Cardiff.

The Lord Mayor announced that Tenovus the Cancer Charity will be my nominated charity for the year. Tenovus is the leading cancer charity in Wales providing support services to people in the community suffering from the disease and that she looked forward to working with the charity representatives on many fundraising events over the future months. The Lord Mayor hoped that all Councillors show their support where possible by attending the events planned throughout my mayoral year.

Finally the Lord Mayor thanked the outgoing Lord Mayor, Derrick Morgan and the outgoing Lady Mayoress for being superb ambassadors for our capital city.

5: VOTE OF THANKS FROM THE LEADER & LEADERS OF THE OPPOSITION, CONSERVATIVE GROUP, INDEPENDENT GROUP AND PLAID CYMRU GROUP.

The Leader welcomed this opportunity to be able to lead the tribute to thank the outgoing Lord Mayor, Councillor Derrick Morgan and thank him for his enormous contribution to civic business in the City of Cardiff since his appointment in September 2012.

On behalf of himself and Councillor Heather Joyce, as the previous Leader of the Council he extended both warm and sincere personal thanks to Councillor Morgan for undertaking the civic roles and responsibilities with great warmth, dignity and enthusiasm, and for the tremendous support and fund raising efforts for the two charities, Llamau and Cardiff Foodbank.

On behalf of the City of Cardiff the Leader presented Councillor Morgan with his outgoing badges of office.

Councillor Woodman, on behalf of the Opposition, offered thanks for Councillor Morgan's excellent chairmanship of Council meetings over the last couple of years, and as Lord Mayor for being such a wonderful 4

6 : ACKNOWLEDGEMENT FROM THE IMMEDIATE PAST LORD MAYOR

The outgoing Lord Mayor indicated that it had been an honour and a privilege to serve as the Lord Mayor of Cardiff for the last 20 months. During that time has attended many memorable events and occasions and met countless citizens with amazing stories – many who have overcome disadvantages and are now flourishing and achieving their potential.

He had represented the people of the city on extremely poignant and heartfelt acts of Remembrance for Holocaust and the victims of two world wars and other genocides. These events are even more poignant this year as the start of World War 1 is commemorated and the memories of the people who were affected by these atrocities will always remain.

Over the past two years the Lord Mayors nominated charities, Llamau and Cardiff Foodbank have benefitted greatly from the support of Members, local communities and members of the public and he indicated that this year's fundraising total for Cardiff Foodbank is over £19,200 and equally important – over a tonne of food donations have been collected at Council venues which have made a real difference to people suffering short term periods of crisis.

The outgoing Lord Mayor thanked the Lady Moyoress for her continual support and the many consorts who have accompanied him on engagements, the outgoing Deputy Lord Mayor for all her support and wished her well in her role as incoming Lord Mayor of Cardiff and all Members of Council for their support.

9: THE CARDIFF UNDERTAKING FOR COUNCILLORS

On 1 July 2004, Council approved the Cardiff Undertaking to provide an opportunity for Members to publicly commit to using their term of office to work for the Council, the City and its citizens, and to commit to the standards of conduct expected by the Council.

Elected Members were asked signed up to the Cardiff Undertaking as amended to reflect the approved Local Resolution Protocol and endorse their commitment to the Cardiff Undertaking at the meeting. RESOLVED – That the Cardiff Undertaking be endorsed.

10: LORD MAYOR'S ANNOUNCEMENTS

HMS Dragon given the Freedom of Cardiff

I was pleased to see the city of Cardiff celebrating its newest Honorary Freemen this month as HMS Dragon, the Royal Navy's newest warship, came to visit, mooring in the Roath Basin, Cardiff Bay.

The ship and its 190-strong crew were awarded the Freedom of the City in a ceremony outside City Hall. A flag waving crowd soaked up the sunshine as they showed their support while the Band of the Royal Marines played and Captain Rex Cox accepted the honour.

The crew celebrated the award by marching through the streets of Cardiff with swords drawn, bayonets fixed and colours unfurled to the delight of visitors to the city centre.

HMS Dragon follows in the footsteps of the last warship to be affiliated to the city. HMS Cardiff was awarded the Freedom of the City in 1988. The ships are two of only ten organisations to be presented with the Freedom of the City since records began in 1886.

During its visit HMS Dragon opened its doors to members of the public. Over 3,000 people took the opportunity to tour the ship and talk to local crew members before they left Cardiff's shores and set sail for Portsmouth.

I would like to thank Captain Cox and the Crew of HMS Dragon for visiting the city and everyone who attended the Freedom ceremony, making it a fantastic day for Cardiff.

It has also been an honour and privilege to bestow the Freedom of the City of Cardiff upon the 203 (Welsh) Field Hospital.

12: MEMBERS' REMUNERATION & ALLOWANCES 2013/14

The report detailed for consideration the prescribed levels of Members' remuneration and allowances that are payable in 2014/15, as determined by the Independent Remuneration Panel for Wales (IRPW), and agree those matters which are reserved for local determination by the Council

The Independent Panel has determined that the Basic Salary for elected members in Wales to be raised from £13,175 (which was payable in both 2012/13 and 2013/14) to £13,300 in 2014/15.

The Independent Panel has determined that there is no change to the maximum proportion of the Council's membership that is eligible to receive a Senior Salary in 2014/15. In Cardiff this equates to a maximum of 19. This was reduced to 18 at the meeting of council on 27 March 2014 and is reflected in the table contained in the report.

Councillor Chris Weaver moved the recommendations as set out in the report.

Councillor Nigel Howells seconded the recommendation.

RESOLVED -

- 1. to agree the allocation of 18 Senior Salary positions for 2014/15 and an additional one senior salary position to be determined;
- 2. to set the Civic Salary payable for the positions of Civic Head (Lord Mayor) and Deputy Civic Head (Deputy Lord Mayor) in accordance with the Band A level of Civic Salary payments 2017/2015; and
- 3. that the payment of Co-opted Member fees should continue to be based on a maximum of the equivalent of 10 full days a year in 2014/15.

13 : ESTABLISHMENT OF COMMITTEES, THEIR SIZE, TERMS OF REFERENCE AND ALLOCATION OF SEATS

The Constitution provides that the Council will at its Annual Meeting, decide on any amendments to its standing Committees for the municipal year, the size and terms of reference of those committees, and the allocation of seats to political groups in accordance with the political balance rules.

Councillor Chris Weaver moved the recommendations as set out in the report and amendment sheet,

Councillor Nigel Howells seconded the recommendations.

- (2) the allocation of seats on each Committee based on political balance be agreed as detailed in the appendix B to the report.
