151: RHIWBINA COMMUNITY POLL

The Lord Mayor invited the Cabinet Member for Safety, Engagement and Democracy, Councillor De'Ath to present the report which was seconded by Councillor Hunt.

The report was to receive the result of the Rhiwbina Community Poll on 5 February 2015 consider what action should be taken. Councillor De'Ath advised that the Cabinet's recommendation was that the poll be considered as part of that meeting's budget debate.

The Lord Mayor invited the Local Ward Members to speak. Members asked the Council to note the value of community polls in representing the views of the community. Rhiwbina residents had given its support to the Library and it was worth noting that the poll was proved by the subsequent extension of funding the Rhiwbina Library and the other six standalone Libraries in Cardiff library received. Members sought Cabinet's support to extend the funding of libraries for the length of this administration.

152 : BUDGET PROPOSALS 2015-2016

(Members declarations of interest under Article 10 of the Members' Code of Conduct as set out in Minute Number 148 were noted.

The Chief Executive, Corporate Director, Resources, County Clerk and Monitoring Officer and County Solicitor declared a pecuniary interest in Item 7 - the Plaid Group Amendment and left the meeting during consideration of the Amendment).

The Council was requested to consider and approve the Cabinet Budget Proposals for 2015 - 16.

The Lord Mayor reminded Members of the agreed conduct of debate for the consideration of the Cabinet Budget Proposals 2015-16, the amendments to the proposals received in accordance with the Council Procedure Rules which included necessary Statutory Officer advice. The Lord Mayor indicated that Members would be called to speak in accordance with the agreed Speaking Order.

The Lord Mayor advised that the Labour Group Amendment had been received on time but was not seconded in accordance with Council Meeting Procedure Rule 22 (b) and she had therefore ruled the Labour Group

amendment was out of order and the amendment would fall. Two other amendments had been received from the Independent Group and Plaid Group.

The Lord Mayor called on the Cabinet Member for Corporate Services Resources and Performance to formally move the Cabinet Budget Proposals 2015-16. Councillor Hinchey moved the Cabinet Budget Proposals and in addition a Cabinet Amendment to the proposals in accordance with Council Meeting Procedure Rule 22 (n) and requested the Lord Mayor seek the consent of the meeting for the Cabinet Budget proposals to be altered. The Lord Mayor in accordance with the Council Meeting Procedure Rule ruled that the meeting be adjourned for 20 minutes to allow Members time to consider the content of the Cabinet Budget Amendment which had been tabled.

(Meeting was adjourned at 5.10pm for 20 minutes. Meeting reconvened at 5.40pm)

The meeting was reconvened and the Lord Mayor asked Members whether they had had sufficient time to consider the Cabinet Budget Amendment.

It was proposed by Councillor Cowan and seconded by Councillor Robson that the meeting be suspended to the following day.

The proposal was put to the vote and the vote was LOST.

It was proposed by Councillor Hinchey and seconded by Councillor Magill that the meeting be adjourned for an hour.

The Lord Mayor invited the Section 151 Officer to explain the variations contained in Version 2 of Cabinet Budget Amendment to the original proposals. The Section 151 Officer explained the alterations in Version 2 from the first Cabinet Budget amendment circulated earlier in the meeting.

The amendment included an additional reduction in the Cardiff Enterprise Zone Budget taking an additional £430,000 to the original Cabinet proposal. The additional funding had allowed the whole of the saving to the Cardiff Alcohol and Drug Team Counselling Service to be removed – changing it from a half year to full year saving.

The other alteration was to Children's Play where the proposal was for Children's Play to remain in place and run for 5 evenings a week for as long as it takes for alternative operational arrangements to be put in place. The whole saving had been put back into the budget with an addition element of growth of £120,000 to enable the engagement of three Community Development Workers with small amount of funding to work with developing and supporting the transition to alternative operational arrangements.

The Section 151 Officer drew attention to the narrative contained in the second version of the Cabinet Budget amendment and advised that the recommendations and the appendices take into account these proposed alterations but this did not change the proposals for setting of the Council Tax for 2015-16.

The Section 151 Officer refer to the statement within the narrative of Version 2 of the Cabinet Budget Amendment on the Library Service which altered the original budget proposals by stating that the Cabinet Budget amendment proposes to continue to fund Branch Library Services until the end of the Council term unless, and/or until alternative delivery arrangements are operational. Consequential amendments had been made to the medium term financial plan for 2016 - 17

The Lord Mayor moved to the vote under the Council Procedure Rule 22 (n) to accept the proposed Cabinet Budget alteration.

The Vote was CARRIED

The Lord Mayor invited the Cabinet Member, Corporate Services and Performance, Councillor Hinchey to present the Cabinet Budget as altered.

Councillor Hinchey expressed his thanks to Cabinet colleagues; Members of all Scrutiny Committees; Members of the Council's Labour Group and Opposition groups; the Trade Unions and the Council's workforce; and the Chief Executive, Senior Management and specifically the Corporate Director – Resources and the Finance team for their professional support in preparing what was a very difficult budget for the Council to set.

The Cabinet Member highlighted the severe and sustained pressure on Public Services and the impact on Service provision and the way the Council has traditionally delivered Council services to the citizens and communities in the city.

The Council has a legal responsibility to set a balanced budget, but this has resulted in difficult choices and needs to implement change to deal with increases in demand and shrinking budgets.

Cardiff has a unique position as the Capital City of Wales. Over the last decade Cardiff has become one of the fastest growing cities in the UK, and is projected to experience the biggest increase in population of any major British city – including London. This growth is a sign of success. People want to live, study and visit our great capital City. That unique ability to attract people is central to the future economic success, not just for Cardiff but of the wider Cardiff Capital Region. This growth will continue to place, additional demand pressures on public services from schools to older people.

The budget pressures facing the Council are well known. In February last year, a budget gap of £31.3 million was anticipated in 2015/16 but the

Council is now facing a budget reduction requirement of over £41 million. Council budgets are complex, wide ranging and often subject to significant and unpredictable changes. The Cabinet Members advised that in order to meet the gap it was proposed to raise Council Tax by 5% to generate additional net resources of £5.4 million. For the average Band D property 5% equates to an increase of 93p per week.

Council was advised that the majority of savings required must come from changing the way we do business. However of the overall Council budget of £574 million, only £227 million, (40%) can be used to make savings. The rest is protected or ring-fenced for areas like schools, precepts and capital charges. The protected schools budget alone is £200 million. It is noted that some of the services included in the £227 million are statutory or the subject of escalating demand – for example, social care and waste collection services, further limiting the scope for targeting cuts.

The Cabinet Member referred to the fiscal pressures from UK Government, Welsh Government and predictions from the Office for Budget Responsibility. The Medium Term Financial Plan(MFTP) for Cardiff is requires a further £119million to be found from our budget over the subsequent 3 financial years from 2016-2019 Council therefor can no longer do all the things that it has done in the past. It must prioritise and reform.

The Organisational Development Programme is part of this reform agenda as well as our values of openness, co-operation and partnership. These values have been the basis of our new Partnership for Change agreement which has been signed by all Trade Unions, the Leader and Council.

These values have also underpinned the budget consultation process, which commenced in November 2014, and involved over 4,000 people completed the Changes for Cardiff questionnaire;500 people attended Council-run engagement events across the city; More than 21,000 people gave their views via petitions; and the short animated information video was played 2,605 times during the consultation period. It was the largest consultation exercise the Council has ever carried out on the budget proposals.

The Council's Cabinet has informed, listened and engaged with citizens, partners and stakeholders which resulted in the Cabinet Budget Amendment to Council.

The Cabinet Member advised that it was proposed to support the sustainability of community services are sustainable, and move to new operational models that an allocation of £474,000 had been made to create a new Community Redesign of Services Team dedicated to the task of capacity building and empowering communities to take over services in certain areas, without the need for ongoing Council funding, and action on these areas will need to continue in the medium term.

The Cabinet Member commended the Cabinet Budget Proposals with the alteration to Council.

At this point Councillor Holden moved a Motion without Notice to suspend Section 5 of the Budget Procedure Rules to remove the limited of 45 speakers and allow all Members if they wished to speak in the general debate.

The Motion was seconded by Councillor Sanders.

The proposal was put to the vote and the vote was LOST.

The Lord Mayor invited the proposer and seconder of the amendments to formally move their proposal and to speak.

Councillor Robson formally moved the Independent alternative proposal and spoke on the proposal.

Councillor Cowan formally seconded the Independent alternative proposal and reserved the right to speak later in the debate.

Councillor McEvoy formally moved the Plaid Cymru alternative proposal and spoke on the proposal.

Councillor Ford formally seconded the Plaid Cymru alternative proposal and spoke on the proposal.

The Lord Mayor invited contributions from the remaining Party Group Finance Spokespersons, Councillors Aubrey and McKerlich before opening up the debate to all Members in accordance with the Budget Procedure Rules. Group Leaders spoke as part of the general debate. The debate raised a number of issues in relation to the Budget setting process; Cardiff Debate consultation; the Cabinet Budget Amendments and the assurances on Library and Play centre services going forward.

The Lord Mayor invited the Cabinet Member Corporate Services and Performance to respond to matters raised during the debate. Councillor Hinchey emphasised the impact on public services of the fiscal pressures on budgets and underlined that Cardiff was on a transition path of reforming services in collaboration with partners; communities and their citizens and stakeholders, and would protect and maintain statutory services to the most vulnerable people of the city.

Following the debate the Lord Mayor advised that a vote would be taken on each of the amendments received on notice.
