Report of the Chief Strategic Planning and Environment Officer

AUTHORISATION OF OFFICERS AND DELEGATIONS

1. **Background**

- 1.1 Strategic Planning and Environment has the responsibility for enforcing many varied pieces of legislation. To ensure that officers have the appropriate authorisation the Council delegates powers to the Chief Strategic Planning and Environment Officer and Operational Managers. In addition the Council approves the authorisation of certain qualified officers to carry out the requirements of specific legislation.
- 1.2 The Council has adopted a new Constitution and Scheme of Delegations with effect from 1 October 2006 that sets out the present arrangements for decision-making and delegations. However, in the course of instituting legal proceedings, the Council is occasionally challenged to demonstrate an unbroken line of authority between the enforcement powers contained in the legislation concerned and the officer who will be expected to use those powers and initiate legal proceedings.
- 1.3 This report is provided to clarify the delegation of authority within the Environment and Public Protection and Consumer Protection services of Strategic Planning and Environment in respect of specific legislation.

2. **Delegation of Authority.**

- 2.1 The new Council scheme of delegations were approved by Council in July 2006. These delegations permit Chief Officers to appoint staff in accordance with the Council's Human Resources and Financial procedures.
- 2.2 The new scheme of delegations further authorise Chief Officers to issue and serve statutory and other notices, to institute formal cautions, to institute legal proceedings before courts or tribunals, to take default action under all legislation relevant to their functional area and to authorise officers to appear on behalf of the Council in tribunals, review boards and inquiries, also to sign all necessary documents and authorise entry to land in pursuance of statutory powers.
- 2.3 The scheme also includes for Chief Officers to delegate in writing all or any of the delegated functions to other officers (described by name or post) either fully or under the general supervision and control of the delegating officer.

The written record of the decision will be kept in accordance with the requirements of the Chief Officer.

- 2.4 The Local Authorities Coordinating Office for Regulatory Services (LACORS) has made recommendations regarding local authority delegated powers, authorisation of officers and use of credentials in a document dated November 2004.
- 2.5 An instrument of appointment should be used to confer such powers as are appropriate to the officer to undertake his/her work, making it clear which statutes these powers relate to. Strategic Planning and Environment has an authorisation of officers procedure in place which details the process for creating such an authorisation and details the statutes the officer has been authorised to enforce.
- 2.6 In order to clarify the legislation the Chief Officer may delegate, a table of statutes is appended as Annexe 1 to the report.

3. **Achievability**

This report has no equality, property or human resource implications.

4. Financial Implications

This report is for information purposes only and does not result in any additional financial implications.

5. Legal Implications

This report provides clarification of the delegation of authority in respect of specific legislation enforced by Environment and Public Protection and Consumer Protection Service areas.

6. **Recommendations**

It is recommended that Committee: -

- 6.1 Confirm the delegation of authority to the Chief Strategic Planning and Environment Officer to deal with those statutes detailed in Annexe 1 and any amendments or modifications thereof, any byelaws, orders, regulations made thereunder, or at any time hereafter to be made pursuant thereto any amendments or modifications thereof for the time being in force, relevant to such enactments as the City and County of Cardiff Council require or are required to enforce.
- 6.2 In the absence of the Chief Strategic Planning and Environment Officer or upon his approval the delegations are exercisable by the Operational Manager (Environment and Public Protection) or the Operational Manager (Consumer

Protection) in the interests of the efficient performance of the statutory functions.

- 6.3 In the absence of the Chief Strategic Planning and Environment Officer, the Operational Manager (Environment and Public Protection) and Operational Manager (Consumer Protection) be delegated authority to exercise the delegation in the interests of effective performance of the functions and that for the purposes of Part 3 of the Council's constitution:
 - a) in the absence of the CSPEO and the OM(EPP) the Operational Manager (Licensing & Strategic Services), Operational Manager (Public Protection), the Operational Manager (Environment) be authorised to exercise the delegations within the functional area; and
 - b) in the absence of the CSPEO and the OM(CP) the Operational Manager (Fair Trading) and the Operational Manager (Consumer Services), be authorised to exercise the delegations within the functional area.
