REGISTRATION OF GIFTS AND HOSPITALITY - REVIEW

Reason for this Report

1. To provide the Committee with information on registrations of gifts and hospitality received by Members, to enable the Committee to review the same; and to consider any comments or observations it considers appropriate in this regard.

Background

- 2. Under the Members' and Officers' Codes of Conduct, Members and Officers are required to register any gifts, hospitality or other benefits where the value of the item or benefits exceeds an amount determined by the Council from time to time. Employees are additionally required to obtain formal authorisation from the Council before accepting gifts, hospitality or other benefits (Members' Code of Conduct¹ Part 4 paragraph 17; Employees' Code of Conduct paragraph 8; and Guidance issued by the Council under the Code of Conduct for Members and Employees on Hospitality, Gifts and Other Benefits 'the Council's Guidance').
- 3. The Standards and Ethics Committee's terms of reference include the role of advising the Council on the content and implementation of its Codes of Conduct. At its meetings on 5th June 2007, 17th July 2007 and 18th September 2007, the Committee considered the Council's thresholds for registration of gifts and hospitality; and on 18th September 2007 resolved to recommend to Council the reduction of the threshold to £25 (in line with the threshold set for all local authorities in England by the Standards Board for England).
- 4. On 18th October 2007 the Council considered this matter and resolved to reduce the threshold for registration of gifts and hospitality to £25, in accordance with the Committee's recommendation. The Council's Guidance was amended accordingly.

¹ The new Members' Code of Conduct adopted by the Council on 15th May 2008 contains essentially the same provisions in this respect (but not identical) to those contained in the previous Code.

5. At the same time as recommending the reduced threshold (on 18th September 2007), the Standards and Ethics Committee resolved to review this matter by considering a six monthly report summarising details of registrations of gifts and hospitality received by Members following the reduction of the threshold to £25. This report presents information for purposes of such review.

Issues

6. Information obtained from the Council's Clerk to the Council, who holds on behalf of the Monitoring Officer the register of Members' Gifts and Hospitality, and the Protocol Office (responsible for administrative support to the Mayoralty), indicates the following registrations during the 6 month period following the reduction of the threshold for the registration of gifts and hospitality to £25 (ie. the period from 18th October 2007 to 18th April 2008):
