STANDARDS CONFERENCE WALES - FEEDBACK

Purpose of this Report

 To provide the Committee with the opportunity to consider feedback from the Standards Conference Wales held at City Hall, Cardiff on 15 October 2009 and to reflect the same in the arrangements for next year's conference.

Background

- At its meeting on 27 January 2009 the Committee was advised that the formal offer from Cardiff Council to host the 2009 Standards Conference Wales had been accepted. This was the first time that Cardiff had hosted the Conference and this would be a good opportunity to showcase Cardiff to other Authorities in Wales.
- 3. At its meeting on 24 March 2009 the Committee agreed that a Task and Finish Group should be established to consider conference arrangements and compile a programme for the Conference.

Issues

- 4. Attached at Appendix A are Graphs indicating General Feedback; Percentage Ratings of Presenters; Percentage Ratings of Workshops and additional comments received from the delegates. The Monitoring Officer has also received several compliments from delegates on the success of the conference.

- It has been suggested that Cardiff will again host the Standards Conference Wales in 2010, and City Hall, Cardiff has been provisionally booked on Thursday 14 October 2010 for this purpose.






