HMS DRAGON

Following a recent meeting with Brigadier Fraser, I am pleased to provide the following update on activities of HMS DRAGON which has been deployed from Portsmouth since September 2018 to undertake naval operations in the Gulf region.

The Dragons include a Royal Marines Boarding Team, US military and civilian linguists, and exchange officers from the Australian, French and New Zealand navies. The youngest is 18 and the oldest over 50, with over 30 years of seagoing experience. She also has a Wildcat helicopter on-board to support deployed operations. HMS DRAGON is tasked with providing maritime security in the Gulf region in conjunction with the 32-nation Combined Maritime Forces coalition, and regional reassurance and engagement in support of UK security and prosperity.

It's deployment has been a tremendous success so far, and has included various activities such as escorting UK and coalition shipping through high-threat regional chokepoints; conducting maritime interdiction of narcotics smugglers in support of United Nations Security Council Resolutions; contributed to major exercises with Oman and India; conducted maritime security operations with navies and coastguards from other nations; visiting and engaging with numerous countries, representing the UK to promote peace and stability; and maintained readiness to react to any emergent crisis, be it a natural disaster in the region or beyond, or a situation that requires a more traditional military response to restore peace and stability.

The Dragons are proud to be representing the UK and especially the people of Cardiff and Wales as they complete their missions, and thank the people of Cardiff for their enduring support. They look forward to a warm welcome when they return to the Capital City.

This Council recognises that reducing carbon emissions from homes bring financial benefits to the occupants and environmental benefits to society.

This Council notes

- The Welsh Government target to reduce emissions of greenhouse gases by at least 80% by 2050, against the 1990 baseline.
- Residential buildings make up 7.5% of Welsh emissions.
- 23% of Welsh households are in fuel poverty.
- The success of institutions such as Cardiff University in showing how zero carbon homes could be built at low cost.

This Council calls on the Cabinet to:-

1. Commit to ensuring that council houses built after 2022 are zero carbon with clean supplies of energy and high energy efficiency designed in from the start.
2. Develop Supplementary Planning Guidance to increase the number of private homes built to zero carbon standards.

- *The Council is piloting a 'PassivHaus' development in Phase 1 of the Cardiff Living programme and has received Welsh Government Innovative Housing Programme funding for this.*
- *The Council is piloting a highly energy efficient modular build project in phase 1 of the Cardiff Living programme and has received WG Innovative Housing Programme funding for this.*

Bullet Point 4 becomes Bullet point 7 and deletion of the words 'low cost to be replaced by *scale*.

Some may be able to use a car to travel but, with limited parking at most work places, the majority will be effectively stuck. Lisvane will effectively rely on a 100/0 modal split and become a car transport only part of the city.</p>

	<p>While Cardiff Bus were planning this service removal, I was not informed or consulted and would have been able to suggest service amendments which could have saved money whilst retaining a basic commuter service, or other local services might have been diverted to Lisvane at key times.</p> <p>Can you assist me by setting up a meeting with the MD of Cardiff Bus to help provide a lifeline to stranded Lisvane commuters and give me your personal support as cabinet member in finding a solution to this major and unnecessary problem?</p>
