1. Application

1.1 An application for variation of a Premises Licence has been received from Jason Arthur Hamer in respect of CFEleven, 151 Cathedral Road, Cardiff, CF11 9PJ

1.2 The premises licence currently permits the following:

The sale by retail of alcohol for consumption on the premises:

Sunday to Wednesday: 10:00 to 23:00

Thursday to Saturday: 10:00 to 00:00

1.3 The applicant has applied to vary the licence as follows:

To amend Condition 2 to read:

“The outdoor area at the front to be included in the premises licence is not to be used by customers for the consumption of beverages after 21:00 hours and in the outdoor area at the rear after 23:00 hours”.

The condition currently states:

“The outdoor areas at the front and rear to be included in the premises licence is not to be used by customers after 21:00 hours for the consumption of beverages”.

2. Promotion of Licensing Objectives.

2.1 A copy of the operating schedule submitted with the application is attached.

3. Relevant Representations

3.1 A number of objections have been received from residents, as well as two local ward councillors. Copies of the objections are attached.

3.2 A number of emails have been received expressing support for the application and copies of these are attached.

4. **Legal Considerations.**

4.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives which are:

Prevention of crime and disorder

Public Safety

Prevention of Public Nuisance

Protection of Children from Harm

4.2 In each case the Sub-Committee may make the following determination

- a) To grant the application.
- b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
- c) Reject the whole or part of the application.

4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

5. **Issues for Discussion.**

5.1 The application should be determined and the appropriateness of any conditions on the licence needs to be discussed.

Summarise concerns

We would like to object to the application to extend the licence of CFEleven, a gin and tapas bar at 151 Cathedral Road, so as to allow consumption of alcohol in the substantial outdoor terrace at the rear of the premises until 11pm.

Our grounds for objection are that the proposed extension would run contrary to the licensing objective set out in the Licensing Act 2003 of 'preventing public nuisance' in that it would generate new and unacceptable late night noise nuisance in a predominantly Residential area. It would also contravene the Council's own published licensing policy prohibiting the serving of alcohol for consumption outdoors in Residential Areas after 9pm.

Reasons for concern and basis of objections.

We note that the latest Revised [March 2015] Government guidance to Local Authorities issued under s 182 Licensing Act 2003 makes the following points. Not only is prevention of public nuisance one of the four licensing objectives but Para. 1.5 of the Guidance specifically refers to further key aims and objectives. These are described as 'vitally important and as principal aims for everyone involved in licensing work'. These include protecting the public and local residents from noise nuisance'.

We note further that Cardiff Council has, as required by the Act, issued a published licensing policy. We note that Local Authorities may only depart

from such declared policy if the individual circumstances of the case merit this decision in the **interests of the promotion of the licensing objectives** (Para 1.12 Revised Guidance 2015). So to depart from declared policy, such a decision must promote prevention of crime and disorder, public safety, prevention of public nuisance or protection of children from harm. It is not thus not permissible under the Guidelines to deviate from policy simply on the grounds that it would promote economic activity.

We note below the significant parts of the City of Cardiff Council Statement of Licensing Policy 206-2012.¹ First, under **Section 7.3 (Licensing Hours)**, it states that 'noise even from well behaved customers leaving licensed premises late at night, can disturb residents especially during the working week. As a consequence, what would be acceptable in the City Centre where there are fewer residents would not be acceptable in heavily populated residential areas'. Then under **Section 7.4C (Prevention of Public Nuisance)** the requirement is specifically set out to consider noise and nuisance including 'patrons leaving the premises, either on foot or by car.' In particular, specific reference is made to the need for operators to

'take particular care to ensure that customers using **external drinking areas**, smoking areas or the pavement outside, do not cause unnecessary nuisance to local residents. **It is suggested that the terminal hour for external areas that are in close proximity to residential properties does not exceed 21:00hrs'** [emphasis added]

Thus, putting together national and local policy frameworks, to extend the right to serve and consume alcohol using external drinking areas after 9pm in a Residential area can only be justified if it was done to prevent crime or disorder, promote public safety, prevention of public nuisance or protection of children from harm. This is clearly not the case.

The context of this objection.

Residents are uneasy at the progression of the licensing approvals granted to these premises and at the transgressions of the conditions imposed. They note a series of undertakings made by, or on behalf of, the proprietors of 151 Cathedral Road which have since been overturned

by activities on the premises. For example, on February 3rd 2017, when the first licence was granted, Jon Wallsgrove, the solicitor representing Mr Hamer, said in *The Cardiffian* publication:

'This is not a place where you would go and party. This is a place for people who are staying there. This is not about trying to make profit from the sale of alcohol. This is about offering that extra facility to guests.'

The implication was that the primary clientele would be staying guests. Just two years later it is clear that this is not the case.

Very quickly, by early 2018, the premises had been reconfigured as a gin bar, marketing its activities extensively. That Summer, tables were set out, canopies erected, alcohol served and live music performed in the rear outdoor area, exceeding the terms of the original licence. CFEleven then retrospectively applied for an extension of the licence terms. At a licensing committee hearing on August 24th, despite opposition from residents on grounds of nuisance, an extension was partially granted, subject to the conditions currently imposed. These included – in relation to the current application – that alcohol consumption in the outside areas must cease by 9pm. The conditions imposed were in line with the recommendations of South Wales Police. Mr Hamer and his solicitor indicated at the licensing hearing that they were happy with these conditions and would comply.

The August 24th ruling increased the footprint of Mr Hamer's rear outdoor licensed area so that it covers the rear of both 149 and 151 Cathedral Road, doubling its impact. Potential nuisance from this large outdoor area affects residences in both Cathedral Road and Plasturton Avenue (whose bedrooms overlook the rear of 149 and 151). Many people on the odd-numbers side of Cathedral Road sleep at the rear of the properties.

Following the August 24th hearing, residents were advised to report any breach of the conditions. Very soon, and on several occasions, the conditions were breached, and following resident complaints, Enforcement Officers attended the premises and warnings were issued.

The current application demonstrates a pattern of continued expansion of activities which was not indicated when the original 2017 licensing committee first approved a new limited alcohol licence in a Residential

area, nor when the more generous conditions were applied in August 2018. Residents request that the licensing committee adhere to the council's stated policy and to its previous ruling, and reject this application.

Individual comments in support of the objection

In addition to contributing to the general argument above, some who put their names to this objection reported individual concerns resulting from their experience of the activities of CFEleven, and their concern for the future. These confirm the rationale for the council's stated policy 'that the terminal hour for external areas that are in close proximity to residential properties does not exceed 21:00hrs'. Among these comments are:

'Our bedroom overlooks the rear outside terrace. In good weather, on evenings when the terrace has been full, after a few hours steady drinking, the noise rises to the point whereby it would be impossible for us to sleep. A closing time of 11pm implies drinking up time and noise pushing towards 11 30pm. Given that we have regularly to get up to work before 6.45am this would be intolerable. There are no doubt many places for late night gin bars in Cardiff. But not in areas that have historically been residential.'

'Throughout last summer, our children were regularly disturbed by the noise... It is totally unacceptable for a residential area such as ours to be subject to such a nuisance and there is no justification for the proposed variation.'

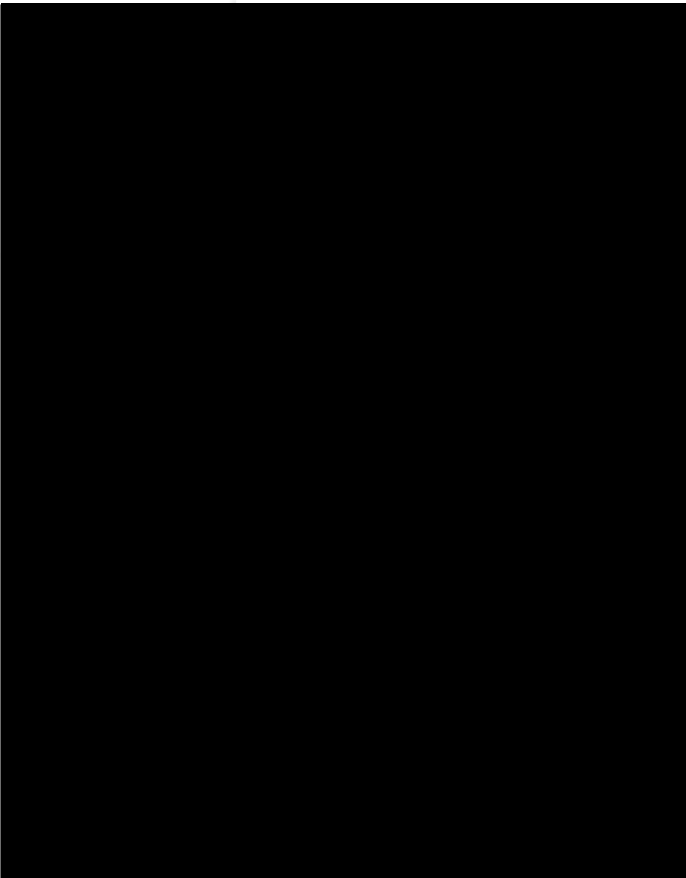
'My daughter is at a local Comp, doing A-levels. She studies into the night in a small room at the back, both through the week and at weekends. It's above and to one side of the drinking area. She needs to open a window for air. The noise will interfere with her work.'

'Before CFEleven got its first licence my husband and I broke up the concrete area behind our family home and planted trees and flowers to encourage a green-way for birds. Last Summer the noise from CFEleven — especially at weekends -- meant our family could not enjoy the garden. The idea that this could continue until 11pm this Summer is devastating.'

'I'm concerned at the amount of broken glass outside CFEleven, which never seems to be cleared up. I walk the dog past there and it's a real nuisance. I worry that outside drinking late at night may make it worse.'

Residents voiced a range of other complaints including concerns about restrictive and inconsiderate parking and lack of adherence to Cathedral Road's heritage status. These have not been included because we note that they are outside the remit of the licensing committee. They do, however, contribute to residents' fears regarding the future of the premises should an extended outside licence be granted.

I wish to object to this proposal for the following reasons:

The premises are situated in a residential area and it would adversely affect my reasonable enjoyment of my home were it allowed to proceed.

Outdoor drinking at such late hours will affect the wellbeing of my children, who will be disturbed by the additional noise which will inevitably result if this application is granted.

Customers who leave the property under the influence of alcohol already disturb myself and other residents in the area as they walk home. This existing public nuisance is likely to be exacerbated if the application is granted.

Pontcanna already has a number of establishments which offer outdoor drinking during the hours proposed in this application - the area is at saturation point with such establishments and it would undermine the predominantly residential nature of the neighbourhood if this application was to be granted. This is not St Mary's Street but an area in which I want to raise my family in a safe environment.

Has the applicant ever failed to adhere to the existing conditions of his license? If so, it would not be appropriate to allow him to benefit from any relaxation or extension of those conditions.

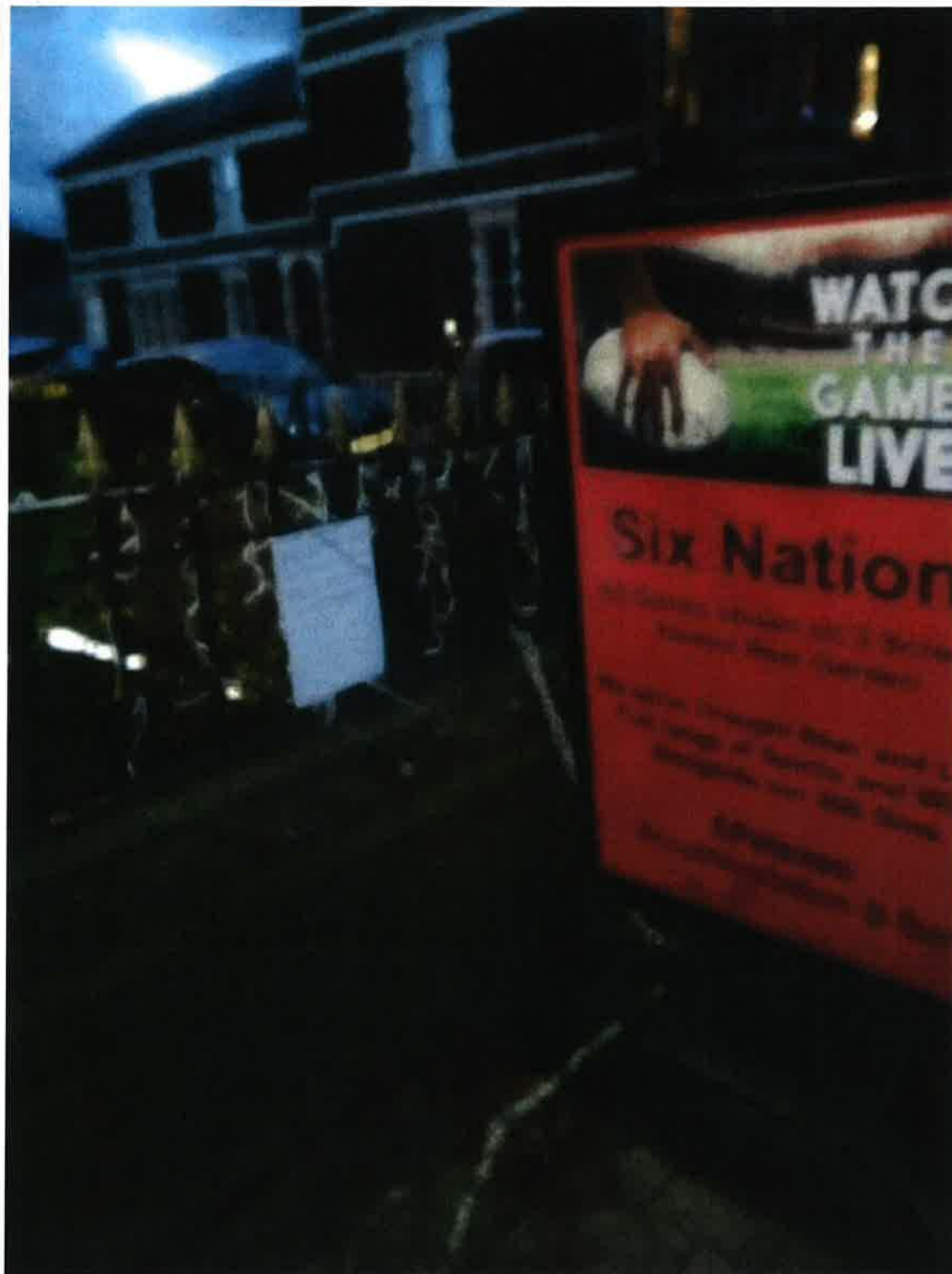

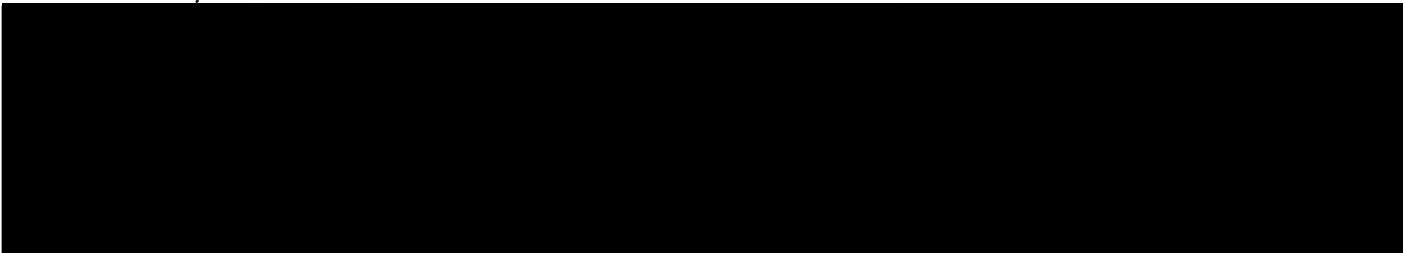

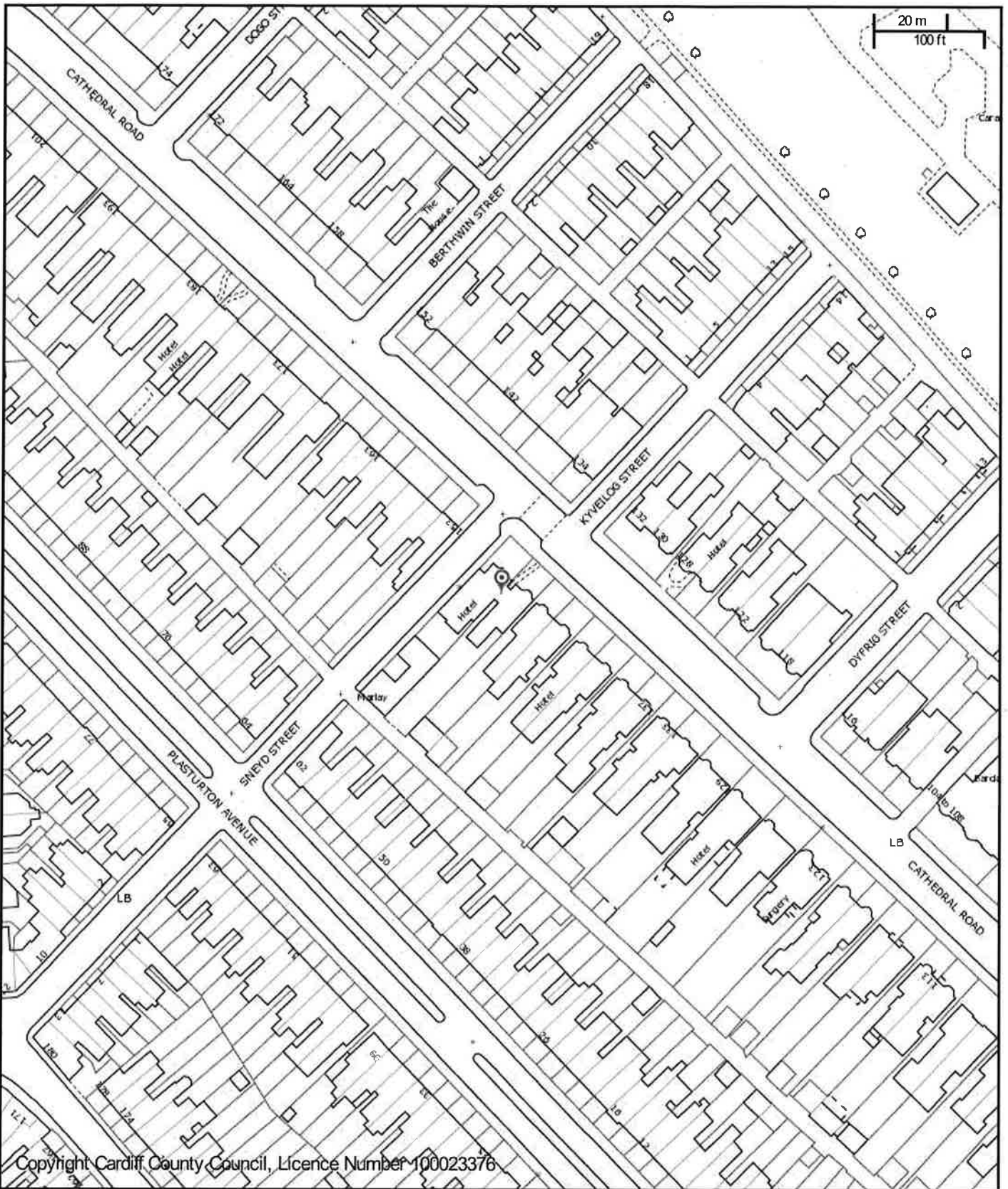
