On behalf of the Committee, I would like to thank you, Claire Marchant, Director of Social Services and Deborah Driffield, interim Assistant Director Children's Services for attending the Children and Young People Scrutiny Committee on 11 December 2018 to present the **Children's Services Quarter Two Performance report and Out of County Inquiry report Cabinet response.**

Children's Services Quarter Two Performance report

The Committee welcomed the new format and content of the performance report and considered it much easier to read and understand and provide a more open and honest approach. The Members wished to thank the Officers and Members for their work in helping to develop this new format.

During the way forward section of the meeting the Members considered the information in the report, and expressed some concern that the Child Sexual Exploitation Strategy was being delayed, as a working group was looking at the wider implications of Children and Adult Exploitation. Members understood the reason for the delay and requested that the draft strategy should be presented to Committee early in the New Year.

The Committee also welcomed the plans being put in place to improve recruitment and retention of social workers, Members suggested that the Directorate consider seeking to extend the range of occupations covered by Cardiff Works to include social worker staff.

Out of County Inquiry report - Cabinet response

The Committee welcomed the Cabinet response to the Out of County Inquiry report, which was presented to Cabinet in July 2018. In particular that the majority of the recommendations were either full or partially accepted. The Committee agreed to seek a progress report on the implementation of the accepted recommendations in six months' time.

The Members also noted that the Directorate was developing a commissioning strategy for Children's Services, the Committee considered that an update commissioning strategy was crucial and welcomed the Directorates commitment to present the draft strategy to Committee in March 2019.

I hope that these comments, advice and requests for future reports, will be of use and support in improving outcomes for children. The Committee looks forward to receiving a response to this letter within the next month.

On behalf of the Committee, I would like to thank you for attending the Children and Young People Scrutiny Committee on 11 December 2018, to provide an opening statement and answering questions on the **School Organisation Proposals: The Provision of English-Medium Primary Education in the Llanrumney area – draft Cabinet Report**

I would also like to thank Janine Nightingale, Head of Schools Organisation, Access & Planning, and Michele Duddridge-Hossain, Operational Manager Planning and provision, for the report and answers to Members questions.

Following the Members consideration of the report and answers to questions **the Committee agreed to commend the report to Cabinet**. Members noted that a further report would be drafted for February 2019 Cabinet, and requested that this reports is also presented to this Committee, prior to their consideration by Cabinet.

The Committee, did however have some reservation around the methodology used to assess future demand for school places, particularly as a result of the new housing developments within the area. The Members requested that the potential demand for school place be regularly reviewed to ensure that appropriate capacity is available within the area.

The Committee understood that Glan-yr-Afon school had accrued a deficit of £130,000 and that the reduction to a one form entry would require a restructure of

the school staff. The Committee requested that additional financial monitoring and advice is provided to the school during this transition period.

The Committee also wished to thank you for answering the questions and wanted to inform you that this letter does not require a formal response.
