**JOINT SCRUTINY COMMITTEE OF THE CHILDREN AND YOUNG PEOPLE AND
COMMUNITY & ADULT SERVICES SCRUTINY COMMITTEE – 15 MAY 2023 – CARDIFF
& VALE JOINT AREA PLAN 2023-28.**

As Chair of the joint meeting of the Children & Young People, and Community & Adult Services Scrutiny Committee, I wish to thank you, Sarah, Jane, Meredith & Cath for attending our meeting, and providing Members with an opportunity to consider the Cardiff & Vale Joint Area Plan, 2023-2028, which we note, is a continuation of the previous Joint Area Plan, and is therefore a combination of existing work, alongside new areas of development.

As mentioned at the meeting, Members appreciated, and commend, the design of the document, due to its clarity and digestibility for the reader.

The Overall Impact of the Joint Area Plan and Partnership Working

We are aware this plan is largely informed by the Population Needs Assessment (PNA) of the area, and so, it was interesting to explore the strength of the Population Needs Assessment. We concur with the comments made by the RPB representatives that, in addition to the PNA, continuous feedback and consultation is still required with all social groups. We wish to stress for this Area Plan to work effectively, it needs to remain committed to a ground-up approach. Where service users, and grass root organisations, voice, views, knowledge, and experience remain integral.

We feel capturing and assessing the impact of partnership work in the region, and delivery of the commitments laid out in this plan is vital. Although the complexities of this matter detailed at the meeting are noted, we are of the view the Delivery Plan being developed, should detail the mechanisms to evaluate the effectiveness of this Area Plan's work.

We would also appreciate further information on how the commitments made in this plan will be monitored and assessed as part of the Regional Outcomes Framework. Including if commitments will be assessed through local policy or action plans relevant to partners, or from a more holistic perspective, led by the RPB. In addition, we would also appreciate insight into how the RPB monitors and evaluates the impact of partnership working in the region.

Further, as mentioned at the meeting, we wish to again highlight the importance of the Regional Partnership Board ensuring there is a consistent training approach to issues across their partners. As we are of the view, this will significantly help ensure continuity in service and positive outcomes.

Starting Well

We were pleased to note the reference to perinatal support for mental health detailed in the plan, yet we would like to request more information on this matter. Specifically, the mechanisms in place to engage with parents and assess their needs. We would also encourage this information being detailed in the Delivery Plan.

It was pleasing to note the plan's commitment towards young people's mental health needs, and the assurance offered at the meeting that this work will be taken forward in conjunction with the recommendations made in the Youth Council's 2019 report. Likewise, it was also pleasing to note the recommendations made in the Children's Commissioner report, 'No Wrong Door', have also been aligned with the plan's commitments.

During the meeting we were informed the current number of young unpaid carers in the region is not currently known. We wish to stress the importance of this data being attained and closely monitored. In line with this, we are of the view it may be beneficial for Cllr Lister and Cllr Merry to liaise with all local schools, and councillors who are governors, to reiterate the importance of utilising the SIMs system to record this information.

We note assessments are currently taking place to determine if the council can achieve Child Friendly City accreditation by this summer, 2023.

Living Well

We note in the commitment for individuals with learning disabilities, there will be improved services to allow individuals to live 'closer to home'. Though improvement in services is welcomed, we wish to stress the importance of those individuals who may reside in a placement outside of county (due to their needs), being allowed to do so, and not being

encouraged, or required, to move, 'closer to home' against their will. We would suggest this recognition be incorporated into the plan itself, or its Delivery Plan.

We welcome the commitment made to improving an individual with learning disabilities access to annual health checks, including dentistry services, and look forward to seeing the breakdown of how this will be progressed, in the forthcoming Delivery Plan.

Regarding the plan's commitment to reduce violence against women, domestic abuse, and sexual violence, we welcome the assurance that this commitment will be achieved. Along with the governance arrangements the Partnership Board has for progressing this work.

Ageing Well

A key area of concern for the council's Community & Adult Services Scrutiny Committee of late has been the national suspension of data collection for delayed transfer of care.

We understand work is taking place, on a national basis, to reintroduce this data collection through a revised model. We note partnership work on this issue has continued, regardless of data suspension, for instance through the establishment of an Integrated Discharge Hub. Although partnership work on this matter has continued, we wish to stress the importance of a model, capturing this data being in place, and available for monitoring, as soon as possible.

Thank you once more for attending our meeting. I hope you find our comments, and the discussions at the meeting of use.

In response to your specific questions, we can advise as follows:

How the commitments made in this plan will be monitored and assessed as part of the Regional Outcomes Framework. Including if commitments will be assessed through local policy or action plans relevant to partners, or from a more holistic perspective led by the RPB.

Each commitment within the Area Plan is linked to one or more outcomes in the Regional Outcomes Framework. The RPB has just launched the Regional Information Sharing Site (RISS) which aims to bring together information from across the partners to inform a shared picture of our work to progressing each outcome. Therefore, we can provide assurance that the plan will be monitored and assessed both at a local level and also at a more holistic perspective via the RISS.

Insight into how the RPB monitors and evaluates the impact of partnership working in the region.

Performance against delivery of the commitments is overseen by the RPB and its associated governance, and it is also reported into Welsh Government.

In addition to the RISS outlined above, the RPB has implemented an engagement framework to support ongoing engagement with stakeholders linked to each priority areas of the Area Plan. For example, people with lived experience played a key role in formulating the commitment related to Learning Disabilities. The views and experiences of stakeholders that are captured through our engagement framework will be combined with the RISS outputs to provide a comprehensive and ongoing impact evaluation. In addition, the RPB invests in specific external evaluation where appropriate. For example, we are in the process of seeking an external evaluator to help support the ongoing assessment and evaluation of how our Regional Integration Fund is used to support the partnership agenda and its impact.

The mechanisms in place to engage with parents and assess their needs to assist with the offer of perinatal support for mental health.

Scrutiny members will recollect that the Area Plan includes an intention to review the partnership priorities relating to Mental Health over the coming year. The need to prioritise opportunities for perinatal support will be considered as part of that process and any baseline assessment will include engagement with parents.

Indication on when the Delivery Plan will be available.

The Delivery Plan will be presented to the RPB for consideration on 13th July 2023 with regular reviews planned throughout the following 5 years.

We hope that these comments provide adequate assurance on the areas in question but will be glad to provide further information should this be required.
