Local Authority Governor Appointment Panel Selection Criteria and Recruitment Process

Selection Criteria

The Council is required to publish criteria which are to be used for the identification and appointment of LA governors.

These criteria are:

- Demonstrable interest in education and understanding of the importance of education in the lives of children and young people;
- Able to offer and share skills and expertise that match the needs of the individual school;
- Evidence of ability to act in a critical friend role, providing support and challenge;
- Interest in the local community within which the school is situated;
- Commitment to regular attendance at meetings of the governing body and its committees;
- Committed to undertaking mandatory training and other forms of training in order to update knowledge and skills and to enhance effectiveness as a governor.

This information will be obtained from the application form completed by potential candidates when applying to become a school governor.

Advertising

- Local Authority governor vacancies will be advertised on the Council website termly, with details of how to apply for the positions. This includes those whose terms of office are due to come to an end as well as any vacancies due to resignations.

Panel Recruitment Process

New Applicants

- Panel receives completed application form from new applicant;
- Panel checks application meets selection criteria and considers any information in the form regarding eligibility and previous appointments;
- Panel considers character references and Disclosure and Barring Service check;
- Panel approves/does not approve the applicant as a LA Governor
- Panel reviews list of governor vacancies and allocates the LA governor to a school, taking into account the needs of the individual school/Governing Body in terms of challenges, skills and expertise. There will be schools that will be prioritised. The Director of Education/representative will provide the panel with this information.

Requests for Re-Appointments

- Panel receives completed application form from governor seeking re-appointment;
- Panel checks application meets selection criteria and considers any information in the form regarding eligibility/previous appointments;
- Panel considers character references/statement from Chair of Governors and DBS form (where available);
- Panel approves/does not approve the applicant's request for re-appointment as a LA governor;
- Panel reviews LA governor's request to be re-appointed to their previous school, taking into account the needs of the school/Governing Body in terms of skills and expertise and supporting statement from Chair of Governors. The Director of Education/representative will provide this information.

Appointments

- Recommendations for Local Authority governor appointments will be presented to the next available full Council meeting for ratification;
- Governor Support Services will notify candidates of the outcome of their application/request for re-appointment.

REPORT OF INTERIM MONITORING OFFICER

NOMINATIONS TO LOCAL AUTHORITY GOVERNOR VACANCIES

Reason for this Report

1. To consider and make recommendations to Annual Council on 26 May 2016 on appointments to Local Authority Governor Vacancies.

Background

2. Section 19 of the Education Act 2002 creates the general ability for the Local Authority to appoint governors to the Governing Bodies of maintained schools, with further detail contained in the Government of Maintained Schools (Wales) Regulations 2005. When Local Authority school governor vacancies arise, either by appointees reaching the end of their term of office or resigning, it is the statutory duty of the Council to fill the vacancies as soon as possible.
3. In November 2014, the Children & Young People Scrutiny Committee undertook a Task and Finish Inquiry into the effectiveness of Cardiff schools' governing bodies, including a review of the appointment process for Local Authority governors. The Inquiry recommended the setting up of a Member Governors Panel to oversee the process of recruiting Local Authority governors and to carry out a programme to recruit and support school governors.

This new approach was approved by the Constitution Committee and it was recommended that the Constitution be amended to establish a cross party Advisory Member Panel to consider and vet all applications to serve as a Local Authority Governor, making recommendations for appointment to the Council.

The Panel would also maintain an overview relating to the recruitment and training for governors, criteria for appointment and conduct. The Constitution Committee also recommended that the Panel would comprise up to seven

Cardiff Councillors and meet termly or more frequently as required to consider all Local Authority Governor applications or renewals. All applications would need to be accompanied with an enhanced Disclosure and Barring Check.

4. These recommendations were approved by Full Council at its meeting on 26th March 2015.

Issues

5. The Panel under Item 5 attached has received the list of current and future vacancies as at 3 May 2016 and applications to these vacancies since its last meeting on 21 January 2016.

Reason for Recommendations

6. To ensure that the Council fulfils its statutory functions in respect of the appointment of local authority governors for maintained schools.

Legal Implications

7. As noted in paragraph 2 of the report, the Council is required, pursuant to the Education Act 2002, section 19 and regulations made there under, to appoint Local Authority governors to the Governing Bodies of maintained schools, in accordance with those statutory provisions.

Financial Implications

8. There are no financial implications arising from this report.

Recommendation

That the Local Authority Governor Appointment Panel considers and makes recommendations to Annual Council 26 May 2016 on applications to the current vacancies as at 3 May 2016.
