The Committee was convened to interview the two candidates shortlisted by the Committee on 5 December 2016.

The Committee was advised that Candidate 1 had withdrawn from the process.

Candidate 2 was interviewed and as part of the process made a 10 minute presentation and Members were given an opportunity to probe and question the

content of the presentation. This was followed by formally agreed set questions and two mandatory questions.

At the end of the interview process the Committee deliberated and considered the performance of the candidate against the competencies and model responses.

The Committee agreed that they were not able to appoint to the post of Assistant Director – Children’s Social Services.

The Committee discussed the difficulties in recruiting to this post which had been advertised on 4 separate occasions since 2013. The Committee noted that the Employment Conditions Committee in 17 October 2016 had agreed a market supplement for the post bringing the salary in line with other major cities.

RESOLVED – That the Committee unanimously agreed that on this occasion they were unable to appoint to the post of Assistant Director Children’s Social Services
