- 1.1 An application for a Premises Licence Grant, has been received from Pearl Restaurants Limited in respect of For Your Eyes Only, 90 St Mary Street, Cardiff, CF10 1DW.
- 1.2 The applicant has applied for a Premises Licence for the above premises and has given the description of the premises as follows:

"Striptease and table dancing performances".

- 1.3 The following licensable activity is proposed:
 - 1. The provision of films (indoors):

Sunday to Thursday: 11:00 to 04:30 Friday and Saturday: 11:00 to 05:30

From the start of permitted hours on New Years Eve to the start of permitted hours on New Years Day.

2. The provision of live music (indoors):

Sunday to Thursday: 11:00 to 04:30 Friday and Saturday: 11:00 to 05:30

From the start of permitted hours on New Years Eve to the start of permitted hours on New Years Day.

3. The provision of recorded music (indoors):

Sunday to Thursday: 11:00 to 04:30 Friday and Saturday: 11:00 to 05:30

From the start of permitted hours on New Years Eve to the start of permitted hours on

New Years Day.

4. The performance of dance (indoors):

Sunday to Thursday: 11:00 to 04:30 Friday and Saturday: 11:00 to 05:30

From the start of permitted hours on New Years Eve to the start of permitted hours on New Years Day.

5. The provision of late night refreshment (indoors):

Sunday to Thursday: 23:00 to 04:30 Friday and Saturday: 23:00 to 05:30 New Years Eve: 23:00 to 05:00

6. The supply of alcohol for consumption on the premises:

Sunday to Thursday: 11:00 to 04:00 Friday and Saturday: 11:00 to 05:00

From the start of permitted hours on New Years Eve to the start of permitted hours on

New Years Day.

2. Promotion of Licensing Objectives.

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report.

The following conditions are proposed to be attached to the Premises Licence detailed above:

(1) There shall be no admittance to the premises after 05:15

(2) There shall be a 30 minute drinking up period.

(3) There shall be no consumption of alcohol on the premises following the 30

minute drinking up period.

(4) Plastic or non-glass vessels will be used when the sale of alcohol extends beyond 03:00. This will mean the supply of drinks at the premises, both alcoholic and non-alcoholic, shall be in non-glass or plastic from 23:00. Sufficient glass collectors shall be engaged on the premises to help remove glass from public areas. The exclusion to the above shall be for persons who are seated, and for those who are seated or standing in the identified 'bar area' as disclosed on the plan.

(5) On days considered to be major event days in the City Centre and Cardiff Bay areas, such as sporting events at the Millennium Stadium, all drinks shall be dispensed in non-glass or plastic vessels. The exclusion to the above shall be for persons who are seated, and for those who are seated or standing in the

identified 'bar area' as disclosed on the plan.

- (6) A CCTV system will be installed to an agreed standard as approved by South Wales Police and maintained and operated at all times when the premises are open to the public. The system will cover all internal areas of the premises where the public have access (excluding toilets), including all entrances and exits extending to the middle of the highway and any external area associated with the premises. The images will be kept for a minimum period of 31 days. The images will be produced to a Police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.
- (7) Suitably qualified SIA door supervisors will be employed at the premises, should the premises operate beyond midnight, and shall be so employed from 21:00 and on a ratio of 1 per 100 persons.
- (8) There shall be no more than 12 extensions per year of one hour allowed. The South Wales Police shall be notified of the extension of hours at least 14 days prior to such an extension. The South Wales Police will have the right to veto such extensions of hours by giving the applicant 7 days notice in writing prior to the extension.
- (9) On days considered major event days in the City Centre and Cardiff Bay areas, such as sporting events at the Millennium Stadium, the premises shall be allowed to open to the public at 10:00
- (10) The premises will adopt the Radionet scheme.
- (11) There shall be no OFF sales of alcohol.
- (12) The premises will adopt the drug safe scheme and conduct random searches of customers attending at the venue for illegal substances and alcohol.
- (13) There will be no striptease or similar entertainment, save that operated under an SEV Licence, for as long as Cardiff Council adopts and operates the SEV legislation.
- (14) No persons under the age of 18 years of age shall be allowed into the premises after 23:00.
- (15) The Designated Premises Supervisor or a member of the management team shall be present on the premises when open to the public. Management to be verified by the production of a management contract which shall be kept on site and produced upon the request of the relevant authorities.
- (16) Whilst entertainment is taking place, no less than two door supervisors, SIA registered, shall be engaged at the premises.

- (17) Management or the Designated Premises Supervisor will remove or refuse entry to any member of the public who is not in a fit and proper state.
- (18) The premises will have a clearly defined conditions of entry policy.
- (19) Any noise produced or associated with the regulated entertainment shall not be audible at the facade of the nearest residential premises.
- (20) Notices shall be displayed advising customers to leave quickly and quietly.
- (21) A complaints book shall be provided and available to Police and Licensing Authority upon request.
- (22) An incident book shall be provided and made available to the Police and Licensing Authority upon request.
- (23) In the last 30 minutes the premises are to be open to the public the music shall be gradually reduced.
- (24) A proof of age scheme will operate requiring persons to provide recognised photographic isdentification as required.
- (25) A Challenge 21 policy shall be in operation at the premises.





The Premises Licence Holder shall maintain a CCTV system which gives coverage of all entry and exit points. The system shall continually record whilst the premises are open and conducting licensable activities. All recordings shall be stored for a minimum period of 28 days and shall be capable of being easily downloaded. Recordings shall be made available upon the receipt of a request by an authorised Officer of the Police or the Local Authority.
2. There shall be "CCTV in Operation" signs prominently displayed at the premises.
3. Between the hours of 23:00 and 05:00 members of the public shall not be allowed to enter the store and shall be served through the night hatch.
4. An incident log (whether kept in a written or electronic form) shall be retained at the premises and made available to an authorised Officer of the Police or the Local Authority.
5. The Premises Licence Holder shall operate a proof of age scheme, such as a Challenge 25, whereby the only forms of acceptable identification shall be either a photographic driving licence, a valid passport, military identification or any other recognised form of photographic identification incorporating the PASS logo, or any other form of identification from time to time approved by the secretary of the state.
6. The premises shall be fitted with a burglar alarm system.
7. The premises shall be fitted with a panic button system for staff to utilise in the case of an emergency.

The Premises Licence Holder shall ensure that the appropriate fire safety, and health and safety regulations are applied at the premises.

d) The prevention of public nuisance

A complaints procedure shall be maintained by the Premises Licence Holder, details of which shall be made available in store and upon request.

- e) The protection of children from harm
- 1. All staff shall receive training in relation to the sale of alcohol. No member of staff will be permitted to sell alcohol until such time as they have successfully completed the aforementioned training.
- 2. An age till prompt system shall be utilised at the premises in respect of alcohol.
- 3. A refusals register (whether kept in written or electronic form) shall be maintained at the premises and shall be made available for inspection upon request by an authorised Officer of the Police or the Local Authority.

AMENDED CONDITIONS

1. CCTV

- 1.1. A CCTV system shall be installed and maintained at the premises.
- 1.2. The CCTV system shall be in operation at all times during which the premises are open to the public and shall give coverage of all areas, except toilets, to which the public have access.
- 1.3. CCTV images shall be kept for a minimum of 31 days and shall be made available to an employee of the Police, a Police Officer or an authorised employee of the Licensing Authority in an easily downloadable format on request.
- 1.4. A member of staff who is able to operate the CCTV system shall be present at the premises at all times that they are open to the public.

2. Incident Log

- 2.1. An incident log, whether kept in written or electronic form, shall be maintained at the premises and shall be made available to an employee of the Police, a Police Officer or an authorised employee of the Licensing Authority for inspection on request.
- 2.2. The incident log shall record any complaints received in connection with the licensable activity at the premises, any faults with the CCTV system, any refusal to sell alcohol at the premises, and any visit to the premises by a Responsible Authority in connection with the licensable activity.

3. Night Hatch

3.1. Between the hours of 2300 and 0500 customers shall not be permitted to enter the shop area of the premises and shall be served through the night hatch.


We have just seen the application to vary the premises' licence at the Coop Garage, Llantrisant Rd, Llandaff. We understand they wish to change the hours for sale, for off-premises consumption of alcohol, from Monday-Sunday 07.00-23.00 to Monday-Sunday 00.00-00.00. They also wish to change the hours for late night refreshment from 23.00-00.00 to 23.00-05.00 Monday-Sunday.

As mentioned in our objection to the original licence application, we object to the principle of sales of alcohol from any garage, as it could encourage drivers to consume alcohol whilst driving. We also worry about people needing to buy alcohol at these late hours and whether it could encourage bad behaviour in the area.

We understood that a previous, similar application had been turned down by the council and would be interested to discover any evidence of need, for this change, which has no doubt been investigated by the Coop.

This is mostly a residential area and if such sales were not made to drivers, as mentioned earlier, sales would be made to passing foot trade, plus some attracted from other areas, who could both be the cause of anti-social behaviour in the area close to the premises.

2. <u>Promotion of Licensing Objectives.</u>

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report.

3. Relevant Representations

4. Legal Considerations.

OPERATING SCHEDULE

Staff shall be trained in the requirements of the Licensing Act 2003 with regard to the Licensing Objectives.

A) The Prevention of Crime and Disorder

- 1. A full CCTV system shall be installed to a standard agreed with South Wales Police. It will be maintained and operated at all times the premises are open to the public. The system shall cover all areas to which the public have access (excluding toilets), including entrances and exits and any outside areas used by customers. Images shall be kept for a minimum of 31 days. The images shall be produced to an authorised police employee in a readily playable format immediately upon request when the premises are open, and at all other times as soon as reasonably practical. There will be sufficient staff training to facilitate the above.
- 2. SIA registered door staff shall be employed at a ratio of 1:100 from 21:00 until close on Friday and Saturday nights and on all major event days. A 'major event' is defined as any event that South Wales Police deem as such and which will be published on the South Wales Police website and/or the Licensees' Forum website.
- 3. At all other times, SIA registered door staff shall be employed at the premises, in accordance with a risk assessment to be carried out by the DPS.
- 4. When employed, a register of those door staff employed shall be maintained at the premises and shall include:
 - (i) the number of door staff on duty;
 - (ii) the identity of each member of door staff;
 - (iii) the times the door staff are on duty.
- 5. Open containers of alcohol shall not be removed from the premises, save for consumption in any delineated external area.
- 6. Any external furniture will be moved inside or alternatively secured by 23:00 daily.
- 7. Staff will be trained in the laws relating to under age sales, and that training shall be documented and repeated at 6 monthly intervals.
- 8. A refusals book will be maintained at the premises, and made available to an officer of a responsible authority upon request.
- 9. On major event days (as defined in Condition 2) all drinks will be dispensed in non-glass vessels with the exception of people partaking of a substantial table meal or consuming wine or champagne.

B) Public Safety

- 1. A first aid box will be available at the premises at all times.
- 2. Regular safety checks shall be carried out by staff.
- 3. Management shall liaise with the Fire Authority as necessary to ensure compliance with all necessary fire regulations.

4. The premises shall maintain an Incident Log and public liability insurance.

C) The Prevention of Public Nuisance

- Noise from amplified music or voices shall not be such as to cause a noise nuisance to occupants
 of nearby premises.
- 2. The exterior of the building shall be cleared of litter at regular intervals.
- 3. A Dispersal and Smoking Policy will be implemented and adhered to (see attached).
- 4. The emptying of bins into skips, and refuse collections will not take place between 11pm and 7am.
- 5. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 6. At any given time, a minimum of 75% of the public trading area will be set aside for tables and chairs.
- 7. There shall be a full meals menu (subject to a wind down period) and waiter or waitress service available throughout the premises.

D) The Protection of Children From Harm

- A "Challenge 21" Policy shall be implemented in full and appropriate identification sought from any person who appears to be under the age of 21. The only acceptable photographic driving licences, passports, HM forces cards, or a form of identification with the "PASS" hologram
- 2. Staff training will include the Challenge 21 Policy and its operation. In particular, staff shall be trained to take such action as is necessary to prevent the sale of alcohol to persons over the age of 18 where those customers are engaged in the distribution of alcohol to persons under the age of 18. The training must be given to a new member of staff before they commence employment and all staff must receive refresher training every 6 months.
- 3. Children under the age of 18 shall not be permitted into or to remain on the premises after 21:00 unless accompanied by an adult.

I Chief Inspector Mark Hobrough of South Wales Police, herby give notice that an objection shall be made to the application for a new premises licence for The Botanist, Unit D, 5 – 10 Church Street, Cardiff.

This Police objection is based upon the licensing objectives:-

- 1. The prevention of crime and disorder. (The premises are situated in an area which has high incidents of crime and disorder and incidents associated with alcohol)
- 2. The prevention of public nuisance (The premises are situated in an area which have incidents of public nuisance)

As a result the premises are located within the agreed Cumulative Impact Policy area for Cardiff City Centre. (Special Policy Statement in respect of Cardiff City Centre adopted 2016)

South Wales Police will object to the application to allow a Licensing Committee the opportunity to undertake the rebuttable presumption that the premises licence will not be granted unless the applicant can demonstrate that there will be no negative cumulative impact on one or more of the licensing objectives

Within the current application, you have detailed the steps you intend to take to promote the four licensing objectives. These are in the way of voluntary conditions that would be placed on the premises licence If you successfully challenges the Saturation Policy or are able to demonstrate that the premises are likely to promote the licensing objectives, I feel that these conditions do not adequately promote the four licensing objectives, in particular the prevention of crime and disorder and the prevention of public nuisance.

For that reason I have identified conditions that are necessary and proportionate that would enable the premises to operate whilst reducing the negative impact it will have on the licensing objectives.

However, I feel that it is pertinent to take this opportunity to reinforce the point that these conditions will not adequately promote the licensing objectives but merely go some way in limiting the extent as to which they are likely to be undermined.

- (3) At all other times, SIA registered door staff shall be employed at the premises, in accordance with a written risk assessment to be carried out by the DPS. A copy of the risk assessment must be maintained for 12 months and be made available to police immediately should it be requested.
- (8) An incident book shall be kept at the premises and maintained on site at all times for a period of 12 months. It shall be made available on request to an authorised officer of the local authority or a member of police staff, which will record the following:

Mon - Sun 08.00 - 01.30

Added conditions other than those on the operating schedule

- (10) The premises will operate a South Wales Police approved radio system at all times when open to the public.
- (11) The DPS or personal licence holder will be on the premises at all times licensable activities are taking place.
- (12)The DPS will ensure that an adequate system for measuring the number of patrons in the premises is used by door security when on duty, such as counting clickers. Numbers of customers on the premises will be recorded each half an hour. The record will be kept for a minimum of 12 months and will be made available to a police employee or representative of a responsible authority immediately upon request.
- (13)The premises must be an active member of the Cardiff Licensee Forum or other such scheme operated within Cardiff City Centre. The DPS or other nominated member of staff must attend meetings when they take place

- (14) There shall be no entertainment of a sexual nature
- (15) There will be no mobile alcohol sales persons of any sort.
- (16) There will be no bars situated in any outside area associated with the premises.
- (17) The premises will operate predominantly as a restaurant and the licence will remain in force as long as the primary use of the premises is that of a restaurant.


