5 : APPLICATION FOR THE GRANT OF A PREMISES LICENCE - MAES B, HEOL PORTH TEIGR, CARDIFF BAY

Application

An application for the grant of a Premises Licence was received from Eisteddfod Genedlaethol Cymru in respect of Maes B, Heol Porth Teigr, Cardiff Bay, Cardiff CF10 4GA. The application was for a time limited Premises Licence to cover the dates 8th-12th August 2018 in respect of the Eisteddfod 2018.

The applicant applied for the following:

(1) In respect of the following licensable activities:

1. The supply of alcohol for consumption on the premises.
2. The provision of regulated entertainment in the forms of films, live music, recorded music (indoors).
3. The provision of late night refreshment (indoors).

(2) Description of Premises (as stated by applicant):

“Semi-permanent building previously home to the Dr Who Experience. Building roughly divides into three – office accommodation at the front, performance area at the rear with a middle section incorporating a mezzanine level. Maes B festival performance and bar area will be mostly in the rear section with the mezzanine used for day time rehearsals and the office accommodation as management and dressing rooms.

Location of venue chosen so as to be close to main Eisteddfod site (WMC and Roald Dahl Plass). Not close to residential properties. Access for shuttle bus to transfer to campsite in suburbs”.

(3) The opening hours are proposed as follows:

Wednesday to Saturday: 21:00 to 03:00

(4) To provide licensable activities during the following hours:

1. The supply of alcohol for consumption on the premises:

Wednesday to Saturday: 21:00 to 03:00

2. The provision of regulated entertainment in the forms of films, live music and recorded music (indoors):

Wednesday to Saturday: 21:00 to 02:00

3. The provision of late night refreshment (outdoors):

Wednesday to Saturday: 23:00 to 03:00

The Sub-Committee were advised that the applicant had agreed the conditions set out by South Wales Police and the recommendations made by Pollution Control regarding the noise management system had also been agreed.

The Sub-Committee noted that there had been 1 objection from a resident, who was not present.

Applicants Representations

The applicant advised the sub-committee that the objection received from the resident related more to Roald Dahl Plass, which was actually under a Cardiff Council Licence until 10.30pm. In relation to this application, there would be a sound system in the auditorium of the old Dr Who building, for 4 nights, the licence was until 02.00am but it was likely the events would finish before this time. The auditorium is half height as there is a suspended ceiling. The sound system would be facing towards the East; there would be a shuttlebus taking people back to the campsite in Leckwith. The applicant advised sub-committee that they would ensure the event was kept as enclosed as possible and thanked licencing officers for all the help received with the application along the way. The applicant also advised that they had been operating for over 20 years and were well used to putting mitigating conditions to applications.

RESOLVED: That the Sub-Committee, having considered all the information; and in accordance with the requirements of the Licensing Act 2003, the Section 182 Guidance and the Licensing Authority's own Statement of Licensing Policy, the Sub Committee GRANTED the application.
