1. Application

- 1.1 An application for a Premises Licence Grant, has been received from Coffi Co (Cardiff) Ltd in respect of Coffi Co, Ground Floor Commercial Unit 2, Bayscape Cardiff Marina, Watkiss Way, Cardiff, CF11 0SY.
- 1.2 The applicant has applied for the following:
 - (1) In respect of the following licensable activities:
 - 1. The supply of alcohol for consumption on the premises.
 - 2. The provision of regulated entertainment in the form of live music and recorded music (indoors).
 - 3. The provision of late night refreshment (indoors).
 - (2) Description of Premises (as stated by applicant):

"Coffi Co coffee shop located in the ground floor commercial unit of the new Bayscape apartment building in Cardiff Marina. The premises are made of standard concrete construction and are in an area designated for residential, leisure and tourism. The business will primarily be involved in the sale of coffee and food products but will also sell craft and specialized alcoholic beverages between the specified standard trading hours for consumption exclusively on the premises. It is envisaged that revenue through the sale of alcohol will make up less than 20% of total sales".

Referring to the above application for a license at "Bayscape" Watkiss Way, Cardiff.

I wish to object to the application for the following reasons:-

- 1 The notice regarding the application is posted in the window of the premises in an area restricted to public access and generally masked by builders vehicles , equipment and fenced off waste skip.
- 2 At this time there are only a handful of residents in the apartments above the premises who are in a position to object, should they have received individual notification? This entire area is residential with no comparable establishment nearby.
- 3 The extended drinking hours proposed will almost certainly lead to outside smoking with associated noise, fumes and litter contaminating the surrounding area including rubbish, glasses and bottles contaminating the adjacent river and White Water Rafting Centre.
- 4 During purchase of our apartment we were led to believe that the establishment would be a low key coffee shop. (not a high profile bar/restaurant more suited to Mermaid Quay!) and the proposal can only sour our right to quiet enjoyment of the area.
- 5 Where are patrons cars to be parked? Will taxis be arriving and departing early and late at night with associated noise?
- 6 Will large delivery trucks be required at any time during the proposed extended opening hours further adding to the noise contamination issues?
- 7 Reduced alchohol serving times would be more acceptable, eg between 10am.and 7pm.all days of the week.
- 8 Many families visit the White Water Rafting Centre, are they likely to be confronted by loutish alcohol fuelled behaviour on occasions?
