#### 1. Application

- 1.1 An application for the Grant of a Premises Licence has been received from Mohammad Ashraf in respect of Chicken Cottage, 108 St Mary Street, Cardiff, CF10 1DX.
- 1.2 The applicant has applied for the following:
  - (1) In respect of the following licensable activities:
    - (i) The provision of late night refreshment (indoors)
  - (2) Description of Premises (as stated by applicant):

"Ground floor shop serving hot food to eat in and takeaway."

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Sunday: 08:00 to 04:00 hours

- (4) To provide licensable activities during the following hours:
  - a) The provision of late night refreshment:

Monday to Sunday: 23:00 to 04:00 hours

- 1.3 A site plan of the premises can be found in *Appendix A*.
- 1.4 The premises has previously benefited from a Premises Licence. This lapsed under Section 27 of the Licensing Act 2003 as a result of the licence holder (limited company) becoming insolvent.

#### 2. Promotion of Licensing Objectives.

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report and can be found in *Appendix B*.

#### 3. Relevant Representations

  - c) Reject the whole or part of the application.
- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council e.g. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.



# APPLICATION FOR THE GRANT OF A PREMISES LICENCE UNDER THE LICENSING ACT 2003 CHICKEN COTTAGE, 108 ST MARY STREET, CARDIFF CF10 1DX

Dear Mr Shafiq Hassan,

I have caused enquiries to be made into this application and make the following representation;

South Wales Police wish to object to the grant of this application under the Licensing Objectives;

Prevention of Crime and Disorder

Protection of Children from Harm, as well as the Cardiff City Council Cumulative Impact Policy 2016-2021.

Should the committee be of a mind to grant this application, we ask that conditions are attached to the premises licence as listed below;

#### CONDITIONS

Prevention of Crime and Disorder

- 1) A CCTV system will be installed to a standard agreed with South Wales Police. It shall be maintained and operated at all times the premises are open to the public. The system shall cover all areas to which the public have access (excluding toilets) including all public entrances and exits and the pavement directly outside. Images will be kept for a minimum of 31 days. The images shall be produced to an authorised Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as is reasonable practical. There will be sufficient staff training to facilitate the above.
- 2) One SIA registered door staff will be employed on the premises from 23:00 hours to close each day. A record of door staff employed at the premises shall be kept. It shall keep a record of the name and SIA number of such staff. It will detain the date and time each member of staff commenced their duty and the time they finished. The record will hold details for at least one year and be made available to authorised members of South Wales Police upon request.
- 3) When SIA door staff are employed at the premises a body worn CCTV camera will be used by those staff to capture images and audio of any incidents of disorder. The device(s) used shall be capable of recording video (images) and sound. They shall be used whenever incidents involving conflict or confrontation occur, or are likely to occur.

Images of any incidents/suspected offences recorded onto the body-worn cameras shall be stored for a minimum of 31 days and shall be produced to a police employee on the provision of satisfactory identification, or other responsible authority representative, in a readily playable format, immediately upon request when the premises are open to the public and at all other times as soon as reasonably possible subject to data protection legislation. There will be sufficient trained staff to facilitate the above.

- 4) There will be no use of any external dining area such as the pavement outside.
- 5) An incident book shall be kept at the premises and maintained on site for a period of twelve months. It shall be made available on request to a police employee, and will record the following:

All crimes reported to the venue

Any complaints received (of a Criminal or Licensing nature)

Any incidents of disorder

Any visit by a representative of a relevant authority or a member of the emergency services.

Any failures of the CCTV system.

#### Protection of children from harm

- 6) No customers under the age of 16 years shall be permitted on the premises after 23:00 hours unless accompanied by a responsible adult.
- 7) There should be a sign at the till point reminding staff of the prohibition on serving food and beverages to children under 16 after 23:00 hours unless accompanied by an adult.

Additional evidence to support the notice of objection will be presented at any subsequent hearing before the Licensing sub Committee. This evidence will be pertinent to the location of the premises and will consist of written, statistical or CCTV evidence. Please find Licensing Authority representation in relation to the above application.

I wish to advise that the Licensing Authority of Cardiff Council will be objecting to the application.

A Cumulative impact Policy has been adopted for the City Centre area of Cardiff. The Licensing Authority has adopted the policy due to high levels of alcohol related crime and disorder, in the interests of public safety and the avoidance of nuisance.

The policy creates a presumption that new applications for Premises Licences will be refused unless the applicant can demonstrate the business will have no negative effect on any of the licensing objectives.

The premises detailed above falls within the boundary of the Cumulative Impact Zone and therefore an objection is submitted in respect to the following Licensing Objectives.

The prevention of crime and disorder.

The prevention of public nuisance.

The operating schedule contains sparse information on how the premises intend to promote the licensing objectives with little consideration to the potential cumulative impact. Consequently the Licensing Sub-Committee will need consider this application in line with Cardiff Councils Statement of Licensing Policy and Cumulative Impact Policy. Reliance on operating without incident alone would ignore the purpose of cumulative impact policies, which are not intended to address individual problems at the premises themselves but problems in the wider area.

If representation is sufficient to overturn the rebuttable presumption. It will need to be demonstrated to the Licensing Sub-Committee that there will be no negative cumulative impact on one or more of the licensing objectives if the Premises Licence were to be granted.

Monday and Tuesday: 23:00 to 05:00 Wednesday to Saturday: 23:00 to 03:00

Sunday 23:00 - 05:00

We as the Local Councillors are submitting the following objections to the application as follows, based on the Licensing Objectives:

#### Prevention of Crime and Disorder

The proposals are likely to increase the incidence of drunken behaviour in the area by attracting more people to the area of the City at that time of night.

#### **Public Safety**

There are already incidents of crime and disorder in the area, which will not be reduced by an increase of drunken people on the street for a longer length of time. There were 119 crimes reported in St Mary's Street and Clubs area from March 2019 to May 2019, with similar reported in the other months of the year. 45 of these were recorded as Anti-Social Behaviour, 2 Drugs related, 11 Public Order Offences and 38 for Violence and sexual offences. Most of these offences appear to be in the lower area of St Mary's Street but keeping the Chicken Cottage open later would attract more people to the High Street end and create more problems where there are more residents and a hotel.

#### **Prevention of Public Nuisance**

Extending the opening hours of the premises will increase the noise, litter and disruption to residents in the blocks of flats and other businesses, particularly hotels, in the area. We feel that extending the opening hours at this business is not conducive to the Licensing Objectives.

#### **Cumulative Impact Policy**

This premises falls within the Cumulative Impact Policy of Cardiff Council which assumes the application will be rejected unless it positively promotes the Licensing Objectives. As addressed above it is very difficult to see how they could achieve that presumption and therefore this application should be rejected.
