#### 1. Application

- 1.1 An application for a Premises Licence Summary Review, has been received in respect of the Premises Licence held by Mr Brian Robert Barton for Pengam Moors Social Club, Seawall Road, Tremorfa, Cardiff, CF24 5TH
- 1.2 The Licence Holder is permitted by the licence to provide the following:
  - (1) In respect of the following licensable activities:
    - 1. The sale by retail of alcohol for consumption on and off the premises.
    - 2. The provision of regulated entertainment in the form of indoor sports, live music (indoors) and recorded music (indoors).
  - (2) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Sunday to Thursday: 10:00 to 00:00 Friday and Saturday: 10:00 to 01:00 Christmas Eve: 10:00 to 02:30 New Year's Eve: 10:00 to 02:30

- (3) The premises are permitted to provide licensable activities during the following hours:
  - 1. The sale by retail of alcohol for consumption on and off the premises:

Sunday to Thursday: 10:00 to 23:30 Friday and Saturday: 10:00 to 00:30 Christmas Eve: 10:00 to 02:00 New Year's Eve: 10:00 to 02:00 2. The provision of regulated entertainment in the form of indoor sports and

recorded music (indoors):

Monday to Sunday: 10:00 to 23:00 Christmas Eve: 10:00 to 02:00 New Years Eve: 10:00 to 02:00

3. The provision of regulated entertainment in the form of live music (indoors):

Friday and Saturday: 20:00 to 23:30

Sunday: 12:00 to 16:00

Christmas Eve: 10:00 to 02:00 New Year's Eve: 10:00 to 02:00

# 2. <u>Details of the Application for Review.</u>

An application for Summary Review, in accordance with Section 53A of the Licensing Act 2003, has been received in respect of Pengam Moors Social Club which holds a Premises Licence permitting the sale of alcohol by retail. The application has been made on behalf of the Chief Constable of South Wales Police and a Certificate has been submitted which has been signed by a police officer of superintendent rank or above. A copy of the application form is attached as *Appendix A*. Brief details are:

The application for Summary Review of the Premises Licence was received from South Wales Police following an incident of serious crime and disorder at the premises on 24th August 2019.

A meeting was held on 30<sup>th</sup> August 2019 to consider whether or not interim steps should be imposed prior to consideration of the application at the end of the consulation period. At this meeting, the Licensing Sub-Committee suspended the Premises Licence until the full review hearing. Following the meeting, the licence holder appealed the decision of the Committee.

On 3<sup>rd</sup> September a meeting was held to consider the appeal and whether the interim steps should be withdrawn or modified. After considering the appeal and the evidence available a decision was made to amend the interim steps as follows:

- a) The premises licence will remain suspended until such time as it is confirmed to the satisfaction of South Wales Police that the CCTV system present is compliant Condition 6 of Annex 2 of the Premises Licence and that the arrangements for the immediate production of images on request by trained staff is in place;
- b) No use of the external areas for the consumption of alcohol;
- c) On Friday and Saturday evenings between 8pm and close a minimum of two Security Industry Authority (SIA) registered door supervisors shall be employed. The SIA

door staff will be equipped with metal detection devices approved by South Wales Police.

#### 3. Relevant Representations

The application for review has been advertised on the premises and the Council website as required by legislation.

A number of letters and emails of support for the premises have been received and are attached to the report as Appendix B.

# 4. Legal Considerations.

4.1 Any decision must be taken following consideration of the representations received with a view to promoting the licensing objectives which are:

Prevention of crime and disorder Public Safety Prevention of Public Nuisance Protection of Children from Harm

- 4.2 In each case the Sub-Committee may make the following determination
  - a) To take no action.
  - b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
  - c) To exclude a licensable activity from the scope of the licence.
  - d) Remove the Designated Premises Supervisor.
  - e) Suspend the Premises Licence for a period not exceeding three months.
  - f) Revoke the Premises Licence.
- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.

#### 5. Recommendation.

It is recommended that the application for Review be considered and determined on its merits.

On the night of Saturday 24<sup>th</sup> August 2019 an incident of serious disorder took place at the Pengam Moors social club. As patrons left the premises fighting broke out and one person stabbed another with a knife. The attacker ran away leaving the injured man with lacerations to his liver and heart.

The incident was not reported to the police at that time and the injured man was taken to A and E by his family and friends.

A number of people involved in the incident sought retribution and left the club in a car. They forced their way into a house where they suspected the attacker was and assaulted two peoiple they found in that house. It was only in attending at the house did the police learn of the incident at the club. Upon attendance at the club Police were unable to obtain downloaded footage

from the cctv there.
This is a breach of the premises licence.

Numerouse other breaches of the licence were also discovered. Examples of these breaches are, no doorstaff were on duty that night, customers were allowed outside with glasses of alcohol in their hands and alcohol was sold to random customers and not limited to club members and their bone fide guests as per the licence conditions.

In October 2018 a person entered the club armed with a baseball bat. He was seeking retribution in relation to another incident. He struck a customer on the head with the bat causing serious injury.

Following that incident a review of the premises licence was sought by the police. At the committee hearing a number of conditions weree placed on the licence to prevent such an incident reoccuring. These conditions were not adhered to and on 24<sup>th</sup> August 2019 and serious violence took place at the premises.



I write with regards to the recent premises licence suspension on the above and can confirm that I have owned the premises since 2002.

In all my years I have never known the club to be deemed a dangerous place and feel as though the suspension together with the interim conditions for door staff every weekend are very extreme.

I have every confidence in the management and the staff. As a club they do all they can for the community by being the home of Pengam Patriots FC. A football club which consists of many young people ranging from 3 years right up to 15. They host charity events by way of coffee mornings and fundraisers. They have a skittles side that has been going for over 10 years together with a darts team. They host members nights on the last Saturday of every month by way of repaying them for their support to the club.

The club is focused on its members (approx 200+) and does its very best to keep any outsiders out and trouble to the bare minimum. The staff have worked extremely hard this last year to comply with the amended conditions and have transformed the club into a family friendly environment. They keep outsiders to a minimum by way of being predominantly members only and having any visitors being signed in.

I am aware of the severity of the incident that occurred a few weeks back and understand that the police and licensing have a job to keep the public safe however, believe that the incident could have happened anywhere and is not something that intended to involve the club.

The closure of the club for a week had a huge impact on all of the members. Some of the older generation rely on the club for weekly dominoes which gets them out to socialise with friends, not to mention the members that use the club daily for a wind down drink after a long hard day in work.

It also put 7 members of staff out of work for a week and so was pleased to hear that it had reopened but the interim conditions have caused 1 member of staff to be out of work temporarily and hope that after the final hearing this will be resolved.
