1. Application

- 1.1 An application for the Grant of a Premises Licence has been received from Unionburger Limited in respect of Burger King, 57-59 St Mary Street, Cardiff, CF10 1FE.
- 1.2 The applicant has applied for the following:
 - (1) In respect of the following licensable activities:
 - (i) The provision of late night refreshment (indoors)
 - (2) Description of Premises (as stated by applicant):

"This application is to operate a Burger King restaurant from 8am until 5am. The current design will be for 52 covers on the first floor and 12 on the ground floor. At 8-9pm it is our intention to close access to upstairs and remove the seating from the ground floor thus making the restaurant take away only. As we already operate existing late night restaurants throughout Cardiff, we are fully aware of the measures we need to take to take".

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Saturday: 08:00 to 05:00 hours Sunday: 10:00 to 00:00 hours

- (4) To provide licensable activities during the following hours:
 - a) The provision of late night refreshment:

Monday to Saturday: 23:00 to 05:00 hours Sunday: 23:00 to 00:00 hours







As experienced franchise operators with 11 sites around South Wales (soon to be 14) we are aware of our obligations in adhering to the four licensing objectives.

In Cardiff we already operate two locations until the early hours. We have always worked with the authorities to improve our late night operations.

b) The prevention of crime and disorder

Licensed security personnel will be employed at peak times and special event days. Security will be provided with a Pinnacle CCTV body cam and security radio.

The premises will be covered with a HD CCTV system with approximately 16 cameras with a 20-30 day recording capacity.

c) Public safety

All electrical systems will be checked regularly by an NICEIC electrician. Gas kitchen equipment will be inspected on a six monthly basis and gas safety certificates obtained. Fire safety systems will be checked on a regular basis and risk assessment completed. Extract ductwork will receive a thorough clean every six months conducted to TR19 standards. A pest control system will be in place with regular preventative visits undertaken. Food standards agency hygiene certificate will be displayed at entrance.

d) The prevention of public nuisance

Our staff and managers will perform regular patrols of both the customer areas and external to check for litter. Both internal & External refuse bins will be provided.

Daily litter collections will be arranged with an approved carrier (probably, Cardiff City Council).

Security personnel will monitor the behavior of patrons leaving the premises.

e) The protection of children from harm

As we are a family friendly restaurant chain our trading activities will not put children at risk e.g. we do not sell alcohol, distribute glass in any form or provide any entertainment of an adult nature.

We would however discourage groups of teenagers from renerating the restaurant late at night.

I, Chief Inspector M. CONQUER of the South Wales Police for the district of Cardiff, hereby give notice that an objection shall be made to the application for the grant of a premises licence for "BURGER KING", 57 St. Mary Street, Cardiff CF10 1FE.

This objection is made under the licensing objectives of;

The prevention of crime and disorder,

Public safety.

The prevention of public nuisance.

The protection of children from harm.

(The premises are in a saturation policy zone, there is a disproportionate amount of crime, disorder and public nuisance in the area.)

p.t.o.

Should the committee be minded to grant this application South Wales Police ask that the below conditions be attached to the licence.

1. A CCTV system shall be installed to a standard as approved by South Wales Police and maintained and operated at all times the premises are open to the public. The system will cover all internal areas of the premises where the public have access {excluding toilets} including all entrances and exits and any external areas associated with the premises. The images shall be kept for a minimum of 31 days and shall be produced to a Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

2. Members of the public shall not be permitted to consume food and drink or remain in any outside area under the control of Burger King St. Mary Street between the hours of 2300 and 0500 each day.

3. Security Industry Authority (SIA) Door Supervisors will be employed at the premises each day from 2300 hours to close. On major event days there will be a minimum of two SIA registered door supervisors from 2300 to close.

4. When SIA registered door supervisors are employed at the premises they will utilise at least one body worn video device. Any such device will be capable of recording both audio recordings and visual images. The recordings will be kept for a minimum of 31 days and will be produced to a Police employee in a readily available format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above. 5. A register of door supervisors shall be kept at the premises. The Register shall show the full name and SIA registration number of each door supervisor, stating the start and end duty times from each door supervisor. The Register shall be kept by the DPS for a minimum of 12 months and will be made available to a Police employee on request.

6. An incident book will be kept and maintained at the premises at all times. It shall be made available on request to a Police employee. This book will record the following:

All crimes reported at the venue

Any ejections of patrons

Any disorder on the premises

Any visit by representatives of a relevant authority or emergency service

Any failure of the CCTV system.

7. Persons under the age of 16 years must not be permitted to enter or remain on the premises after 23:00 hours unless accompanied by a person over the age of 21 years. A notice to this effect must be prominently displayed at the entrance/exit to the premises.

8. The Premises Management must ensure that any WIFI System used at the premises can be switched off at times to prevent or defuse any antisocial behaviour or at the request of Police.

9. From 2300 hours each day only the ground floor area will be used by customers. All ground floor seating will be removed or made inaccessible to customers.

10. The premises shall operate a radio system which is monitored by the Local Authority and South Wales Police.

Good Afternoon Kirstie,

In regard to the above application for grant premises license, I wish to advise that the Licensing Authority of Cardiff Council will be objecting to the application.

A Cumulative impact Policy has been adopted for the City Centre area of Cardiff. The Licensing Authority has adopted the policy due to high levels of alcohol related crime and disorder, in the interests of public safety and the avoidance of nuisance.

The policy creates a presumption that new applications for Premises Licences will be refused unless the applicant can demonstrate the business will have no negative effect on any of the licensing objectives.

The premises detailed above falls within the boundary of the Cumulative Impact Zone and therefore an objection is submitted in respect to the following Licensing Objectives.

The prevention of crime and disorder. The prevention of public nuisance.

The operating schedule contains minimal information on how the premises intend to promote the licensing objectives with little consideration to the potential cumulative impact. Consequently the Licensing Sub-Committee will need consider this application in line with Cardiff Councils Statement of Licensing Policy and Cumulative Impact Policy. Reliance on operating without incident alone would ignore the purpose of cumulative impact policies, which are not intended to address individual problems at the premises themselves but problems in the wider area.

If representation is sufficient to overturn the rebuttable presumption. It will need to be demonstrated to the Licensing Sub-Committee that there will be no negative cumulative impact on one or more of the licensing objectives if the Premises Licence were to be granted.



I write on behalf of myself and Cllrs Weaver, Ahmed and Merry, as councillors for Cathays, in relation to Unionburger Limited's License application for:

Burger King, 57-58 St Marys Street, Cardiff, CF10 1FE

For the provision of late night refreshment (indoors):

Monday to Saturday: 23:00 to 05:00 Sunday: 23:00 to 04:00

We wish to object to the application on the basis that this application will not promote the following Licensing Objectives and comply with the Council's Cumulative Impact Policy:

Prevention of Crime and Disorder

Allowing this premises to opening until 5am every day except Sundays, when they want to open until 4am, is likely to increase the incidence of drunkenness and disorderly behaviour in the St Marys Street. This area already has problems with people leaving late night clubs and bars under the influence of alcohol or other drugs. Police records show that 43 crimes, in the last 3 months, were recorded in St Marys Street, with the majority being violence or sexual offenses, public order, anti-social behaviour or criminal damage. We are aware that violent incidents are occurring outside of take away restaurants in the City Centre taking limited police resources away from preventing other crime.

Public Safety

As already described, approving this licence will encourage an increase in the number of intoxicated people coming to the street to use the premises increasing the risk of anti-social and violent behaviour and another premises for the police to have to deal with.

Burger King also provide a delivery service and meals are normally delivered by cyclists. To increase the number of cyclists on St Marys Street can only create a greater hazard to public safety especially when this area is known for large numbers of intoxicated people being on the street late at night.

Prevention of Public Nuisance

Opening until 4am and 5am will increase the noise from customers adding to the disruption to residents who live in the flats very close to the premises.

Cumulative Impact Policy

St Marys Street comes under Cardiff Council's Cumulative Impact Policy which covers the licensing of fast food and take away premises. The Policy presumes that the application for new licenses in that area will be refused unless the applicants can show exceptional circumstances in the way they will promote the Licensing Objectives.

It is difficult to see how a Burger King open until 5am, in a volatile area, will be exceptional in promoting the Licensing Objectives in St Marys Street.

We would ask you to reject this application.





Measures offered by the Applicant in support of the application.

General.

Those attending the premises as takeaway customers will be permitted to consume on the premises, hot or cold alcoholic and non-alcoholic drinks with their food.

Any alcoholic drink will only be permitted to be removed with takeaway food as long as it is in an unopened or capped container.

Prevention of Crime and Disorder.

The CCTV system installed at the premises is to be of a standard that is acceptable to Cardiff Police. The responsible person shall produce a copy of any footage to the Police or Local Authority within 7 working days if required. This system shall be recording whenever the premises are open for licensable activities. Recordings will be kept for a minimum of 31 days. A notice will be displayed at the entrance to the premises advising customers that CCTV is in operation.

Customers will not be permitted to take open topped containers of alcoholic drinks from the premises.

A notice will be displayed at the premises warning customers of our zero tolerance policy with antisocial, drunken and quarrelsome behaviour and that they could be banned from all licenced premises within the vicinity under the behave or be banned scheme.

Public Safety

A suitable fire risk assessment will be carried out at the premises on an annual basis.

The Fire exit doors at the rear of the property are to be checked regulary to ensure they function satisfactorily.

A fire evacuation procedure will have been implemented at the premises and staff effectively trained in the evacuation procedures.

Adequate and appropriate first aid equipment and materials will be available on the premises.

The prevention of public nuisance.

The premises will be operated so as not to cause a nuisance to nearby properties.

Signage will be displayed in prominent area informing customers to have regard to the residents when leaving the premises.

Consideration as to the incorporation of noise inhibitors will be undertaken in respect of the venue, with regard to its use for the provision of music or amplified entertainment, if and when it is to take place.

Any outside lighting will be operated on a timer and will be turned off at close of business.

The premises has a waste collection contract with Cardiff City Council who will remove waste on a weekly basis.

Staff undertake a litter pick to a distance of 5 metres around the premises every week.

The protection of children from harm.

No person under the age of 18 shall be employed on the premises whether paid or unpaid for the purpose of serving alcohol.

No children under the age of 16years will remain on the premises after 22:00, unless they are accompanied by an adult or they are attending a pre-booked event or function or are providing any regulated entertainment.

Staff shall frequently walk the premises to ensure that the licensing objectives are being promoted.

POLICE REPRESENTATIONS.

South Wales Police take note of the hours applied for by the applicant but seek a reduction in the hours of licensable activity as applied for. The following hours are deemed to be appropriate and proportionate to the application and are as follows;

In addition, whilst acknowledging the above measures offered by the applicant, South Wales Police make the following representations with regard to appropriate conditions be added to the premises licence;

1.A CCTV system shall be installed to a standard as approved by South Wales Police and maintained and operated at all times the premises are open to the public. The system will cover all internal areas of the premises where the public have access {excluding toilets} including all entrances and exits and any external areas associated with the premises. The images shall be kept for a minimum of 31 days and shall be produced to a Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

*This condition should replace that offered by the applicant in section 18B.

2. An incident book will be kept and maintained at the premises at all times. It shall be made available on request to a Police employee. This book will record the following:
All crimes reported at the venue
All refusals of sales of alcohol
Any ejections of patrons
Any disorder on the premises
Any visit by representatives of a relevant authority or emergency service
Any failure of the CCTV system.

4. SIA registered door supervisors will be employed at the premises on Fridays, Saturdays and those Sundays immediately prior to Bank Holidays, from 21:00hrs until the premises closes. There will be a minimum of two door supervisors at the premises at any one time on these days.

5. At all other times, SIA registered door staff shall be employed at the premises in accordance with a written risk assessment to be carried out by the DPS. A copy of the risk assessment will be maintained for 12 months and be made available to the Police immediately upon Request.

6. A register of door supervisors shall be kept at the premises. The Register shall contain the full name and SIA registration number of each door supervisor, stating the start and end duty times from each door supervisor. The Register shall be kept by the DPS for a minimum of 12 months and will be made available to a Police employee on request.

7. When SIA registered door supervisors are employed at the premises they will utilise at least one body worn video device. Any such device will be capable of recording both audio recordings and visual images. The recordings will be kept for a minimum of 31 days and will be produced to a Police employee in a readily available format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

8. On those occasions when SIA registered door supervisors are employed at the premises, the DPS will ensure that an adequate system for measuring the number of patrons in the premise is used by such as clicker devices. Numbers of patrons on the premises will be recorded hourly in the door supervisor log book.

9. Searching and wanding (with a metal detecting wand or similar) will take place on the front door as risk assessed by the Designated Premises Supervisor (DPS) and SIA door supervisors (notices to advise of this shall be on display). A search policy shall be in place and will include procedures for the confiscation of prohibited articles, such as drugs and weapons. Searches shall be conducted at the discretion of SIA registered Door Supervisors.

10. The premises will adopt the drug safe scheme. A lockable Drugs safe will be installed at the premises and accessible only to a Police officer or member of Police staff. Any drugs seized at the premises will be recorded in the premises incident book. This entry will record the date and time of the seizure, the details of the person seizing the items, a description of the items and the circumstances of the seizure. Where it is suspected that a person is supplying drugs then Police will be contacted at the time.

11. Toilet checks will be conducted hourly, at irregular intervals, to deter patrons from illegal activity. A register of toilet checks will be kept by the DPS for a minimum of 31 days and will be made available to a police employee upon request.

12. Purchase of alcoholic beverages will be possible only from static bars and table service. There will be no mobile alcohol sales persons of any sort.

13.At least 70% of the public space within the licensable area of the premises will be occupied by tables and chairs.

14. Young persons under the age of 18 years will not be permitted to consume beer, cider or wine with meals, irrespective of an adult purchase.

15. The Designated Premises Supervisor or a Personal Licence holder shall be present at all times that alcohol is offered for sale.

16. No performance of striptease, lap dancing, entertainment of a sexual nature or other similar entertainment will be permitted on the premises.

17. A sign will be displayed at the entrance to the premises, entrance to the toilets and within the toilets advising of zero tolerance of the possession or use of controlled drugs.

18. Open containers of alcohol shall not be removed from the premises.

19. The entrance to the premises on Arran Street shall shut to members of the public at 21:00 hours each day, after which the sole exit and entry to the premises shall be via City Road.

20. The Premises Licence holder shall submit to the Police Licensing department, a separate operating schedule for each event where an external promoter is involved at the premises. It shall be submitted in writing at least 28 days prior to the event. South Wales Police will notify the premises licence holder in writing of any conditions that should apply to the operation of the event within 10

days of receiving written notification of the event. If less than 28 days written notice is given by the premises licence holder, any condition(s) applied by the Police shall not be challenged by the applicant / premises licence holder.

I would wish to object to this application for a premises licence under the 'Prevention of Public Nuisance' objective.

Please give further details of <u>why</u> you believe this application will have an adverse effect on the licensing objectives

The licence application, includes for the provision of regulated entertainment in the form live music, recorded music and anything of a similar description (indoors) Monday to Sunday: 23:00 to 01:00.

The applicant states within the recent past, at least 6 live music venues have been lost to the Roath area of Cardiff. The applicant by way of obtaining a premises licence for his premises, wishes to re function it to provide a premises that provides live entertainment for its patrons.

The applicant indicates they will be providing live music, (both amplified and nonamplified), for those dining within the front ground floor restaurant and for takeaway customers awaiting collection of their food; live music, (both amplified and nonamplified), in the other three rooms; possible live entertainment evenings, such as open mic nights. Amplified music will be played through the in-house sound system or via suitably placed standalone speakers.

Consideration as to the incorporation of noise inhibitors will be undertaken in respect of the venue, with regard to its use for the provision of music or amplified entertainment, if and when it is to take place under the comments re licencing objectives.

Taking into account all the above, I am of the opinion the noise from within the venue itself; the patrons frequenting the premises (capacity 159) and the possible issues surrounding crowds/queuing to gain access/egress to/from the venue will have the potential to cause serious problems to the nearby residential accommodation, especially given the terminal hour.

Whilst there has been consideration given to the incorporation of "noise inhibitors", there are no details which would help to alleviate my concerns regarding the noise from within the venue.

In addition, I would question the suitability of the building, from a sound insulation view point, to be able to operate as a music venue, without causing the potential for public nuisance.

1. <u>Application</u>

- 1.1 An application for the grant of a Personal Licence has been received from Mr Jack Griffiths.
- 1.2 The applicant has advised that he does not hold, nor has he applied to any other authority for a Personal Licence. He has produced all the documents required by the Licensing Act 2003. The criminal record check produced by the applicant disclosed information regarding a conviction history, details of which will be circulated at the meeting.
- 1.3 South Wales Police have been consulted on the application and have advised that in view of the conviction history they object to a Personal Licence being granted.

2. <u>Legal Considerations.</u>

- 2.1 Applications for the grant of a Personal Licence are determined under Section 120 of the Licensing Act 2003. Under Section 120(5) the Chief Officer of Police may submit an objection notice if satisfied that the granting of the licence would undermine the crime prevention objective.
- 2.2 In each case the Sub-Committee, having regard to the police representations, may make the following determination
 - a) reject the application if it considers it necessary for the promotion of the crime prevention objective to do so, and
 - b) grant the application in any other case.
- 2.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.
