1. Application

- 1.1 An application for the Grant of a Premises Licence has been received from Mohammad Taiyab in respect of Great Welsh Gifts, 21 Castle Street, Cardiff, CF10 1BT.
- 1.2 The applicant has applied for the following:
 - (1) In respect of the following licensable activities:
 - (i) The sale by retail of alcohol for consumption off the premises
 - (2) Description of Premises (as stated by applicant):

"It's currently traded as Welsh Gifts shop. I would like to add Welsh branded alcohol unless converted fully to convenience store/off license. It's most likely that i will convert it to off license because of the pandemic and its effect on Welsh Gifts shop. It's rectangular shape shop with nearly 380 sq ft size with one toilet, CCTV room, storage room for size of more than three 3 fridges for alcohol and food storage".

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Monday to Thursday: 08:00 to 23:00 Friday and Saturday: 08:00 to 00:00 Sunday: 09:00 to 23:00

- (4) To provide licensable activities during the following hours:
 - i) The sale by retail of alcohol for consumption off the premises:

Monday to Thursday: 08:00 to 23:00 Friday and Saturday: 08:00 to 00:00 Sunday: 09:00 to 23:00





CONDITIONS

1. A CCTV system shall be installed to an agreed standard as approved by South Wales Police and it shall be maintained and operated at all times when the premises are open to the public. The system will cover all areas of the premises where the public has access (excluding toilets) including all entrances and exits. The images will be kept for a minimum period of 31 days. The images will be produced to a police employee, in a readily playable format, immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable, subject to data protection legislation. There will be sufficient trained staff to facilitate the above. Signs will be prominently displayed, advising customers that CCTV is in operation at the premises.

2. An incident log with sequentially numbered pages will be maintained at the premises. Each entry shall carry the day, date and time that each report was made. The DPS shall ensure that all incidents are logged on the day of the incident. The log will record the following:

A. All refusals of service.

B. All incidents of disorder of which the premises are aware.

C. Any failure of the CCTV system, with details of actions taken to correct the issue.

D. All visits made by a responsible authority or emergency service.

The log will be made available to an employee of South Wales Police on request. The log shall be retained for 12 months minimum.

3. An Age -Challenge scheme for use when alcohol sales are involved (such as Challenge 25) shall be in use at all times licensable activities are undertaken. Any person who appears to be under the specified age will be required to prove they are over 18 unless otherwise approved by South Wales Police. The only acceptable forms of identification in these circumstances are photographic identification documents, such as; Passport, PASS hologram or Driving Licence. Where a customer's age is in doubt and no identification is available, no admission to the premise shall be allowed. Signs will be prominently displayed throughout the premises advising customers of this policy.

4. Staff involved in the sale and supply of alcohol shall receive refresher training in relation to licensing legislation, age challenging, refusal of sales to underage and intoxicated persons, proxy sales and drugs policies every 12 months. All staff involved in the sale and supply of alcohol shall be fully conversant with the conditions contained in the Premises Licence Conditions. No member of staff will be permitted to sell age-restricted products until such time as they have completed training. Records of such training shall be kept by the DPS for a minimum of 3 years and made available to the police or other responsible authority representative on request.

5. On days declared Major Event Days in Cardiff, a minimum of one (1) Security Industries Agency (SIA) registered Door Supervisor will be provided. Security will be on duty from at least 2 hrs prior to the start of the event, until close.

6. There will be a register of SIA Door Supervisors employed at the premises. It will contain the full SIA registration number of each Door Supervisor, as well as their full name and address. Each Door Supervisor's start and end times will be recorded, with a signed acknowledgement by each Door Supervisor. The register shall be retained by the DPS for a minimum of 12 months and will be made available to an employee of South Wales Police upon request.

7. On days declared Major Event Days in Cardiff, no alcohol shall be sold in glass vessels.

8. The DPS will ensure that staff have access to a radio which affords direct contact with South Wales Police and the Local Authority when the premises is open for Licensable Activity.

9. There shall be a minimum of two (2) staff on duty at the premises whenever Licensable Activity is taking place.

10. There shall be no alcohol, to which the public have ready access, displayed less than 4 meters from the point of entry/exit to the premises.

11. All alcohol displays shall be visible from behind the service desk.

12. There shall be no Beer, Lager or Cider sold from the premises with an ABV higher than 5.5%.

13. Miniature bottles of spirit (20cl or smaller) shall not be sold at the premises.

14. No one in possession of an open container or vessel will be allowed to enter the premises.

15. There will be no sale of single cans of alcohol. All such sales shall be in multiples of four (4) or more.

16. There will be no sale of single bottles of alcohol. All such sales shall be in multiples of four (4) or more.

17. Spirits will not be stored or displayed for sale in an area to which the public has direct access.

18. There shall be a till prompt system which alerts sales staff when age-related goods are involved.

19. There will be no overhead protection from the elements fitted or installed at the external front of the premises.

20. The DPS will ensure that there is a breathalyser device, capable of determining whether a person is intoxicated or not, to reduce the risk of sale of alcohol being made to someone who is already intoxicated through alcohol.

21. The Designated Premises Supervisor (DPS) will ensure that there is a Body Worn Video (BWV) device, capable of recording moving images and sound, available for staff and which shall be worn by SIA registered door supervisors when on duty. Footage from the BWV device will be produced to an employee of South Wales Police, in a readily playable format, upon request when the premises is open to the public and as soon as practicable at all other times. There shall be sufficient staff trained to facilitate the above.

22. Alcohol will only be displayed for sale in the areas shown on the supplied plan – signed by Mohammad Taiyab, dated, 26/02/2021 (attached).

23. The Designated Premises Supervisor will be an active member of the Cardiff Licensees' Forum and will attend meetings in person or by sending a suitable proxy.

24. Orders for home delivery of alcohol will be paid for at the time of ordering. There will be no payment for alcohol at the point of delivery.

25. Delivery of alcohol will only be made to a verified residential address at which the customer is present to receive the order.

26. Customers must be at least 18 years of age. If any customer appears to be 25 or younger, appropriate photo identification will be required. Without such identification the delivery of alcohol will be refused. Terms and conditions will state that if the delivery person is unable to verify the age of the customer at the point of delivery, then the delivery will be refused.

27. All refusals of alcohol delivery will be recorded. The record will include the time and date of the delivery, reason for the refusal and address at which the refusal was made as well as details of the person making the refusal.

28. No alcoholic drinks will be supplied in vessels which were sealed on the premises.

29. Alcoholic beverages sold or supplied for consumption off-premises must be supplied in sealed containers.

30. A daily register must be kept, by the licence holder for a rolling 12 month period enclosing a copy of the purchase order relating to all alcohol delivery sales, specifying the following:-

- The quantity of alcohol purchased.
- The description of alcohol purchased.
- The price of alcohol purchased.
- The name and address of the customer placing the order.
- The address where the delivery is made if different to the customers address.
- Details of photo identification provided if a Challenge 25 proof of age is requested.

CONCLUSION

Additional evidence to support the notice of objection will be presented at any subsequent Licensing Sub-Committee hearing. This evidence will be expanded on verbally, written, statistical or CCTV evidence.



Hi Kirstie,

In regard to the above application to grant premises license, I wish to advise that the Licensing Authority of Cardiff Council will be objecting to the application.

A Cumulative impact Policy has been adopted for the City Centre area of Cardiff. The Licensing Authority has adopted the policy due to high levels of alcohol related crime and disorder, in the interests of public safety and the avoidance of nuisance.

The policy creates a rebuttable presumption that new applications for Premises Licences will be refused unless the applicant can demonstrate the business will have no negative effect on any of the Licensing Objectives.

The premises detailed above falls within the boundary of the Cumulative Impact Area and therefore an objection is submitted in respect to the following Licensing Objectives:

The prevention of crime and disorder. The prevention of public nuisance.

Whilst the applicant has offered a number of conditions in relation to how the premises intend to promote the licensing objectives with little consideration to the potential cumulative impact, the application falls within the CIP and in my opinion the application does not rebut this presumption.

The Licensing Authority would be satisfied if the applicant agreed to draw back licensable activity hours to 07:00 until 21:00 to fall within core hours for Off Licence premises and fall outside of the Red category in Table 2, page 14 of the Cumulative Impact Policy.

We understand that this premise is located with the Cumulative Impact Policy (CIP) area and wishes to sell alcohol outside of the core hours set in the Cardiff Statement of Licencing Policy 2018 – 2021. The applicant has not sufficiently demonstrated that their application to increase the availability of alcohol within the CIP area would not negatively impact on the licencing objectives of Prevention of Public Nuisance, Prevention of Crime and Disorder and Public Safety.

- Reducing alcohol availability and access is key to preventing alcohol related problems in the community².
- Research into the patterns of alcohol availability and alcohol related harm over time in Wales found that changes leading to the increased availability of alcohol were related to an increase in alcohol-related harm, such as excessive alcohol consumption, hospital admissions and violent crimes³.

Data from a report compiled by Cardiff Council into the Night Time Economy showed that between the hours of 18:00 and 06:00 in 2018/19 the city centre, where the premises is based, had the highest count of Violence against the Person in the City (Appendix 1). The city centre area also had highest percentage of incidences of anti-social behaviour (ASB) in 2017/18 and 2018/19 (Appendix 2).

Excessive alcohol consumption can cause breathing difficulty, vulnerability to injury including violence and unconsciousness. The Cardiff Alcohol Treatment Centre (ATC) is a nurse-led service that provides a safe environment in which intoxicated members of the public can be assessed, treated if necessary and monitored. In the calendar year 2019, 940 people used this service as a result of alcohol consumption in the city centre area at a cost per session of £1345 - £2170 (Appendix 3).

We therefore wish to make representation under the licencing objectives of Prevention of Public Nuisance, Prevention of Crime and Disorder and Public Safety.



Violence against the Person, which occurred between 18:00 and 06:00 hours. The following chart shows the total number of offences which occurred between 2018/19.





Great Welsh Gifts, 21 Castle Street, Cardiff, CF10 1BT to sell alcohol to be consumed off the premises. Original times of opening: Monday to Thursday: 08:00 to 23:00 Friday and Saturday: 08:00 to 00:00 Sunday: 09:00 to 23:00

We wish to object to the application on the basis that this application will not promote the following Licensing Objectives and nor comply with the Council's Cumulative Impact Policy.

The applicant originally stated that the license was to sell welsh branded alcohol as an item in the gift shop and we would probably not have objected to that use as long as it contained conditions to ensure that was the only alcohol sold. It now appears that the premises is going to be used as a convenience store and off license.

This premises falls under the Council's Cumulative Impact Policy with the presumption that the application will be refused unless there are exceptional circumstances to show the Licensing Objectives are being promoted. We ask the Committee to consider the issues below that show that another off license in this area will not promote the Licensing Objectives.

Prevention of Crime and Disorder

Allowing this premises to sell alcohol throughout the day and until midnight on some days, is likely to increase the incidence of drunkenness and disorderly behaviour in Castle Street. This area already has problems with people under the influence of alcohol or other drugs and we have evidence of issues with street homeless people and beggars gathering outside convenience stores where they can obtain money from the public and then buy cheap alcohol from the shops. Police records show that 2,863 crimes, from November 2019 to February 2020 (pre-lockdown), were recorded in the City Centre, with the 1,265 being violence or sexual offenses and anti-social behaviour. We are aware that violent incidents are occurring outside of convenience stores in the City Centre taking limited police resources away from preventing other crime.

Public Safety

As already described, approving this licence will encourage an increase in the number of intoxicated people coming to Castle Street to use the premises, increasing the risk of anti-social and violent behaviour and creating another premises for the police to have to deal with.

Prevention of Public Nuisance

We have evidence of gangs, street homeless people and beggars gathering outside convenience stores. They can be aggressive and intimidating to passers-by and the

shop in Castle Street, being a popular route for people accessing the City Centre, would attract these people to beg and then buy alcohol in the shop. The ensuing antisocial behaviour would also cause disruption to residents who live in the area and to visitors to the hotel close to the premises.

Cumulative Impact Policy

Castle Street comes under Cardiff Council's Cumulative Impact Policy which covers the licensing of premises selling alcohol and take-aways. The Policy presumes that the application for new licenses in that area will be refused unless the applicants can show exceptional circumstances in the way they will promote the Licensing Objectives.

It is difficult to see how a further off license in this area, can be exceptional in promoting the Licensing Objectives.

We would ask the Committee to reject this application.

I am writing, as Chair of Cardiff Licensees Forum, to object to the application for a premises licence for Great Welsh Gifts, 21 Castle Street.

In 21 years of representing on-licensed premises in the city centre the Forum has never objected to an application for a new premises licence. In this instance, having learned of the application, and having seen the application notice myself, the thought is that 'enough is enough', a view shared by several Forum colleagues with whom I have discussed the application. I refer to The Forum never having previously objected to an application because I'm aware of how easy it is to make the accusation that it could be seen as based on competitiveness rather than matters of substance. However, in the matter of another off-licensed mini-mart, in the immediate vicinity of at least 3 other such outlets it seems clear that there is more than sufficient provision for this type of premises.

In and of itself, 'sufficient need', is not the basis of objecting to this application. Business surveys, including among on-licensed premises, show that the single greatest matter of concern for those operating and working in businesses in the city centre is the crime and disorder so often associated with on-street drinking. Every day, as I work in St Mary Street I see and experience the consequences of cheap alcohol, freely available through off-licences, fuelling sorts of behaviour that are, at best, inappropriate, at worst offensive and downright criminal. Another off-licence situated directly opposite our 'jewel in the crown' castle would only, in my view, increase instances of this behaviour. Furthermore, with more competition among similar off-licences, the risk will always be there to cut alcohol prices thus encouraging more irresponsible promotions and on-street consumption.

Much work has been undertaken by Cardiff Council, SW Police, FOR Cardiff, and the businesses themselves, to improve and enhance the city centre for its residents, its workers, and its tourists. 



Co-founder, personal licence holder and DPS will ensure that everyone on site is trained effectively to implement the licensing objectives to keep everyone on site safe.

No irresponsible drinks promotions.

A CCTV system shall be installed to an agreed standard as approved by South Wales Police and it shall be maintained and operated at all times when the premises are open to the public. The system will cover all areas of the premises where the public have access (excluding toilets) including all entrances and exits and any external areas associated with the premises. The images will be kept for a minimum of 31 days and shall be produced to a police employee in a readily playable format, immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable.

Staff will be trained to achieve the above

All incidents logged for future reference in case any incidents require further investigation.

Orders for delivery or collection will be made online only. All alcohol will be paid for at the time of ordering. There will be no payment for alcohol at the point of delivery or collection.

Delivery of alcohol will only be made to a verified residential or business address at which the customer is present. Customers must be at least 18 years of age. If any customer appears to be 25 or younger appropriate photo identification will be required. Without such identification the delivery or collection of alcohol will be refused. Terms and conditions will state that if the delivery person is unable to verify the age of the customer at the point of delivery, then the delivery will be refused. A daily register must be kept, by the licence holder for a rolling 12 month period enclosing a copy of the purchase order relating to all alcohol delivery sales, specifying the following:-

The quantity of alcohol purchased.

The description of alcohol purchased.

The price of alcohol purchased.

The name and address of the customer placing the order.

The address where the delivery is made if different to the customers address.

Details of photo identification provided if a Challenge 25 proof of age is requested.

All refusals of alcohol delivery which will include the time and date of the delivery, reason for the refusal and address at which the refusal was made.

Customers only permitted on site during the hours the bar is open or for collection.

A CCTV system set up to cover our point of sale, entrance/exit and the bar.

Roller shutter with door, lock, and additional padlock. We've installed new windows with interior and exterior bars. Signs/notices stating CCTV is in operation as a deterrent.

Nobody allowed to bring unsealed drinks on to the premises.

Open containers of alcohol shall not be removed from the premises save for consumption in any delineated external area An incident book will be kept and maintained at the premises at all times. It shall be made available on request to a Police Officer. This book will record the following;

All crimes reported to the venue.

All refusals of the sale of alcohol

Any ejections of customers

Any disorder on the premises.

Any visit by representatives of a relevant authority or emergency service.


