1. Application

- 1.1 An application for the Grant of a Premises Licence has been received from Jonathan Peter Murray in respect of Handcrafted Horsebox, 14 Rowan Way, Lisvane, Cardiff, CF14 0TB.
- 1.2 The applicant has applied for the following:
 - (1) In respect of the following licensable activities:
 - (i) The sale by retail of alcohol for consumption off the premises.
 - (2) Description of Premises (as stated by applicant):

"The premises is a secure storage unit (garage) situated at a residential address (as detailed in the attached plan) from which a mobile bar business operates. All sales of alcohol will be made on-line or via phone sales as part of garden party events packages and will all be orders for delivery only. Access to the storage facility is restricted to myself - the owner of the business and will only operate 10 - 7pm 7 days a week to minimize any nuisance to neighbours. All orders will be processed and age checks of purchaser will be check upon deliver operating a challenge 25 policy"

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Not open to the public

- (4) To provide licensable activities during the following hours:
 - i) The sale by retail of alcohol for consumption off the premises:

Monday to Sunday: 10:00 to 19:00

1.3 A site map showing the premises and a plan of that premises can be found in *Appendix A*.

2. <u>Promotion of Licensing Objectives</u>

2.1 The additional conditions proposed by the applicant to meet the licensing objectives are attached to the report and can be found in *Appendix B*.

3. <u>Relevant Representations</u>

- 3.1 A representation has been received from South Wales Police and a subsequent amendment to a proposed condition has been received. The applicant has agreed to the proposed conditions therefore the Police objection has been withdrawn. Copies are attached as *Appendix C.*
- 3.2 An objection has been received from Lisvane Community Council in respect of this application. A copy of this representation can be found in *Appendix D*.

4. Legal Considerations

4.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives, which are:

Prevention of crime and disorder Public Safety Prevention of Public Nuisance Protection of Children from Harm

- 4.2 In each case the Sub-Committee may make the following determination
 - a) To grant the application.
 - b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
 - c) Reject the whole or part of the application.
- 4.3 All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council e.g. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.





As the business will be supplying alcohol to customers at their homes we will monitor orders and liaise with the customers influencing decisions on responsible consumption in the home. Limiting drinks ordered in relation to numbers of guests.

b) The prevention of crime and disorder

The storage facility will be secure at all times and with no access to it by the public. 30 day recorded CCTV will be installed at the premises

c) Public safety

No access to the premises will be granted to the public.

d) The prevention of public nuisance

Hours of service at the premises will be restricted to 10:00-19:00 daily to restrict noise disturbance to neighbours and the premises will not be accessed by the public. Deliveries to the premises will be restricted to 'normal' delivery timings

e) The protection of children from harm

No access to children will be granted to the premises. All sales of alcohol will be made to persons over the age of 18 with a challenge 25 policy in place. Age verification is enabled on the website for online orders and age checks will be carried out upon delivery vis nominated courier DHL

1. A CCTV system, will be installed to a standard agreed with South Wales Police. It will be maintained and operated at all times when the storage unit is used to store alcoholic beverage(s); it shall cover each entrance and exit to the storage unit. There shall be a storage facility for images which allows for 31 days of recordings to be held. Images shall be produced, in a readily playable format, to a representative of South Wales Police upon request when the premises is open for licensable activities and as soon as reasonably practicable at other times subject to General Data Protection Regulations. There shall be sufficient persons trained in the use of the CCTV system to facilitate production of images on any day.

2. Payment for orders will be made remotely, by phone or online, at the time of ordering. There will be no payment for alcohol at the point of delivery.

3. There will be no third party courier used to deliver orders taken by the premises.

4. Customers and members of public will not be permitted to attend and purchase alcoholic beverage(s) directly from the premises.

5. Home deliveries will not include the purchase, hire or loan of any type of portable bar.

6. Customers must be at least 18 years of age. If any customer appears to be 25 or younger appropriate photo identification will be required. Without such identification the delivery of alcohol will be refused. Terms and conditions will state that if the delivery person is unable to verify the age of the customer at the point of delivery, then the delivery will be refused.

7. An incident book will be kept which will record;

The name and address of the customer placing the order.

The quantity of alcohol purchased.

The description of alcohol purchased.

The price paid by the customer for alcohol purchased.

The address where the delivery is to be made if different to the customers address. Details of photo identification provided upon delivery if a Challenge 25 proof of age is requested.

LICENSING ACT 2003: APPLICATION FOR A PREMISES LICENCE (UNDER SECTION 17) APPLICANT: JONATHAN MURRAY HANDCRAFTED HORSEBOX 14 ROWAN WAY, LISVANE, CARDIFF, CF14 OTB

Lisvane Community Council (LCC) is aware that the above applicant has applied for a Premises Licence for the sale of alcohol from the above premises. We understand that consumption will be off premises and that the business will operate 7 days a week from 10am to 7pm.

LCC would like to record its Objection to the application.

1.0 LOCATION

14 Rowan Way is a corner house on the junction with Mill Place. The driveway to the property is fronted by zig zag lines leading to a zebra crossing and directly opposite to the property is Lisvane Primary School. The school currently has around 450 pupils from the ages of 3 to 11 years. There are fourteen single age classes and two nursery classes. The school operates different start and finish times for the nursery pupils and also different lunch times, so there are several arrival and departure times during the day.

2.0 REASON FOR OBJECTION

LCC believes that the application fails to meet 3 of the fundamental objectives under the Licensing Act 2003 namely:

2.1 THE PROTECTION OF CHILDREN FROM HARM

With 450 children arriving and departing at various times of the day the vicinity of the school can be very congested particularly as many parents arrive by car. LCC regularly receives reports of dangerous and inconsiderate parking and the school has imposed a voluntary one way system from Mill Place into Rowan Way. The Police are regularly in attendance.

The safe arrival and departure of children at the start and finish of the school day including lunch times is of paramount concern. LCC is of the opinion that an alcohol delivery service operating from this particular location would result in a significant and unwelcome increase in vehicular traffic throughout the day. This increases the danger to and potential harm of children by way of road traffic injury particularly given the proximity of the premises to the zebra crossing.

2.2 THE PREVENTION OF PUBLIC NUISANCE

Local residents are already inconvenienced daily by the volume of school related traffic which appears to be growing steadily worse. The frequent movements of commercial vans to and from the applicant's premises would simply create an additional nuisance to the local residents many of whom are elderly with limited mobility.

2.3 THE PREVENTION OF CRIME AND DISORDER

Crime in Lisvane is generally very low but virtually every month LCC is advised of burglary and theft from sheds and garages. LCC believes that the storage of high value stock in a residential garage would become an obvious target for thieves and would attract the attention of undesirable individuals to the area.

3.0 CONCLUSION

For the reasons given, LCC believes that this is probably the worst residential location in Lisvane for this kind of business. LCC is supportive of business start-ups but not at the expense of child safety or nuisance to neighbours. We would suggest that Mr Murray looks for and secures a suitable commercial unit many of which are available locally at modest cost.
