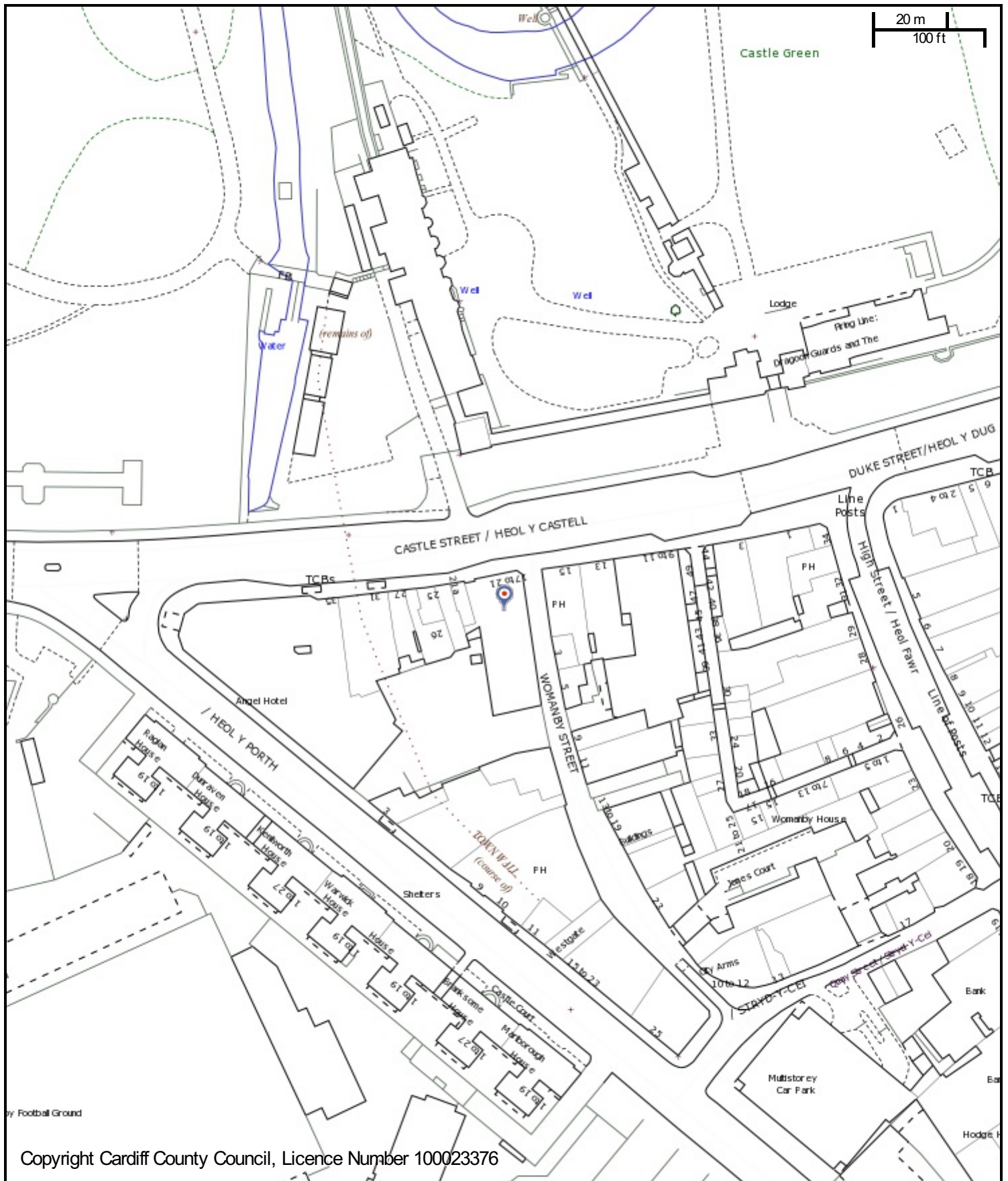

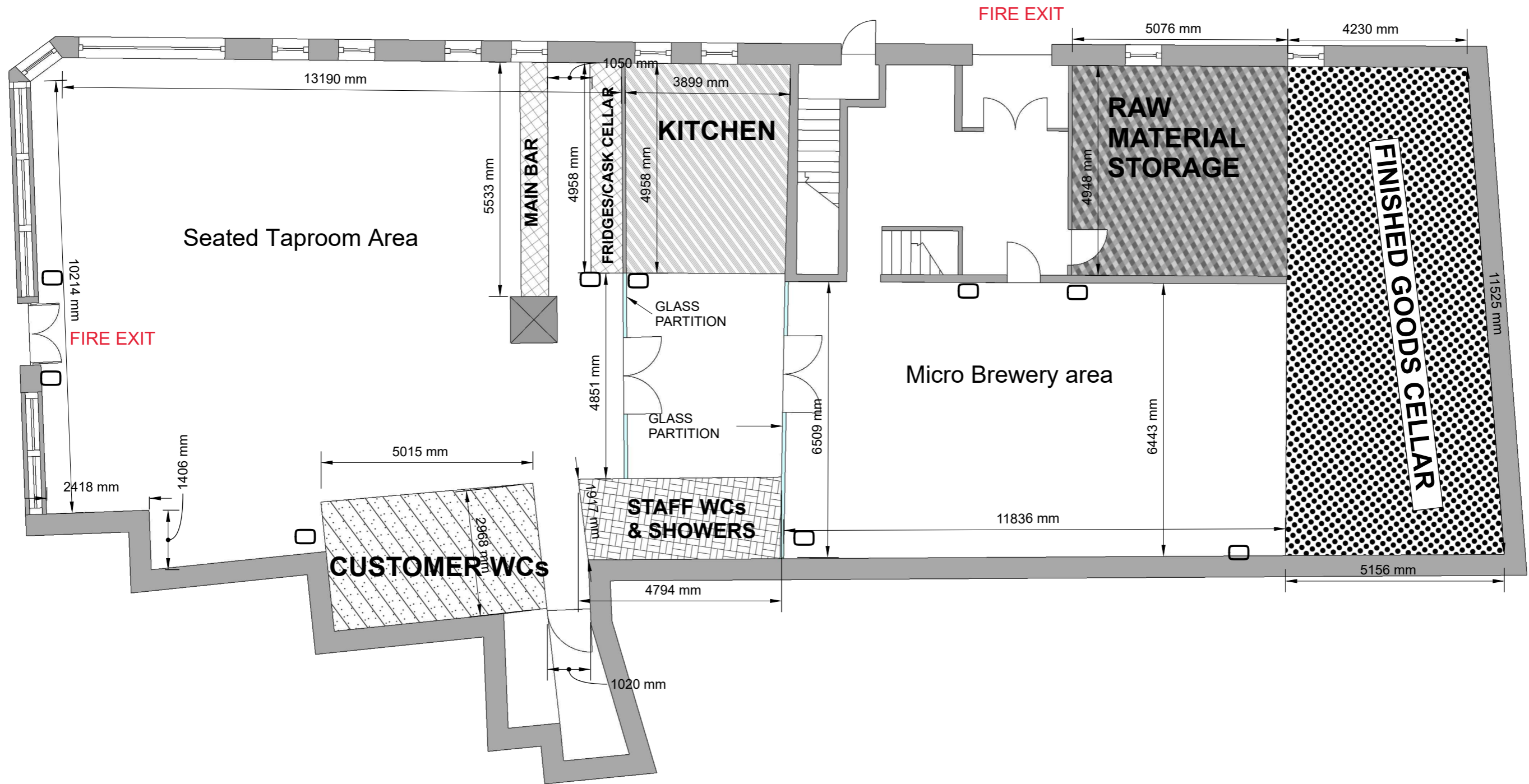

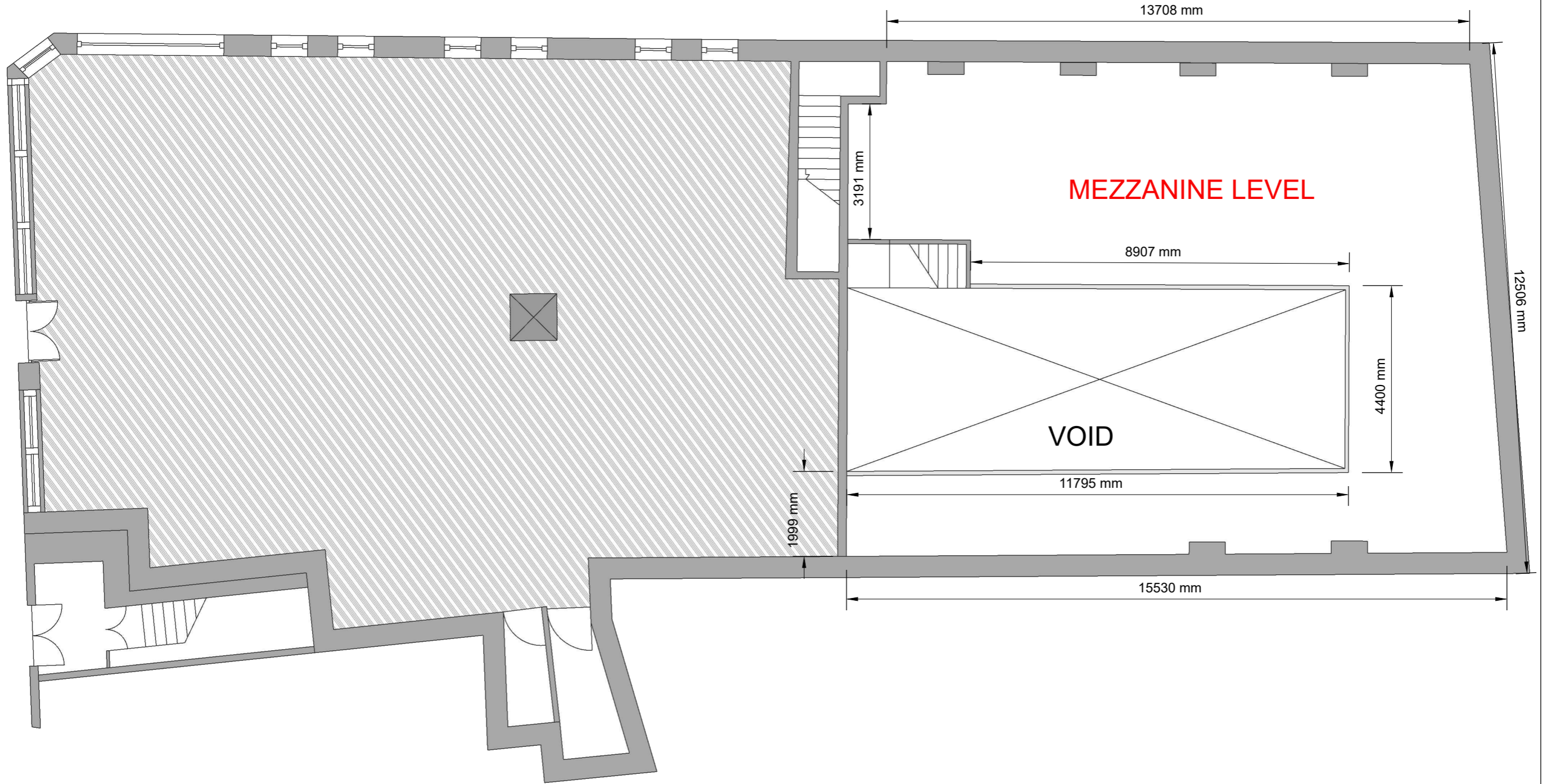
□ Position of Fire Equipment

We have held a premise license for more than a year and understand the importance of running our activities within the four license objectives. Personal License holder on the premises at all times, Designated Premises Supervisor nominated; sufficient number of staff on the premises to cover longer hours & busy times when entertainment is provided; regular training of staff.

b) The prevention of crime and disorder

CCTV is a key tool for us in the prevention of crime & disorder. Staff training will help identify troublemakers and individuals who are drunk before they enter the premises. We understand the importance of data sharing with other licensed premises and the police. Sufficient number of door supervisors; regular glass collections; request photographic identification to control underage drinking; taxi booking service provided; CCTV in place. Signage will be displayed at the exit to the premises that advises customers that they must not take open alcoholic beverages from the premises. Non-glass containers on busy days e.g. rugby internationals

c) Public safety

Annual gas safety check; ring main electrical check (once every 5 years); PAT testing; annual safety checks for lifting equipment; up to date health & safety policy & risk assessments; employers & public liability insurance in place; sufficient lighting internally & externally; regular fire checks & servicing of fire detection & extinguishing equipment; emergency procedures in place; good housekeeping procedures in place; fire exits kept clear and well signposted. Non-glass containers on busy days, e.g. Rugby internationals

d) The prevention of public nuisance

We will have noise restrictions on music equipment, have signage in place asking people to leave quietly, make regular sound checks inside & outside of the premises, position speakers away from external walls, ensure the entertainers are aware of any noise restrictions placed on them prior to commencement. Our kitchen extraction equipment to be vented to top floors away from public proximity.

e) The protection of children from harm

Restrict areas where children allowed, (Taproom only and accompanied by parents / guardians), restrict hours when children are allowed on the premises, (11:00 - 20:00) provide play items and children's books. Train staff to challenge suspected under-age drink requests and use of photographic ID by bar and door staff.

There is a disproportionate amount of Crime, Disorder and Nuisance associated with outlets for alcohol in the Cardiff City Centre. The addition of another outlet will add to the problems caused by alcohol in the Cardiff City Centre.

Should the Licensing Committee be minded to grant this application, we ask that the below conditions are attached to the licence;

CONDITIONS

(1) A CCTV system will be installed to a standard agreed, covering all areas that the public has access (excluding toilets), including all entrances. The system will be maintained and operated at all times the premises are open to the public and there will be a storage facility for images for 31 days. Images shall be produced upon request of the Police immediately when the premises are open to the public and as soon as is reasonable at all other times.

There will be staff training to facilitate the above.

2. On days considered to be major event days in the City Centre of Cardiff, such as sporting events at the Millennium Stadium, suitably qualified door staff will be employed at the premises on a ratio at a minimum of 1 per 100 persons. Suitably qualified door staff will also be employed at the premises from 20:00 hours on New Years Eve.

3. When SIA registered door supervisors are employed at the premises they will utilise at least one body worn video device. Any such device will be capable of recording both audio recordings and visual images. The recordings will be kept for a minimum of 31 days and will be produced to a Police employee in a readily available format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

4. A register of door supervisors shall be kept at the premises. The Register shall show the full name and SIA registration number of each door supervisor, stating the start and end duty times from each door supervisor. The Register shall be kept by the DPS for a minimum of 12 months and will be made available to a Police employee on request.

5. On days considered to be major event days in the City Centre of Cardiff, such as sporting events at the Millennium Stadium, all drinks will be dispensed in non glass vessels.



6. Open containers of alcohol shall not be removed from the premises save for consumption in any delineated external area.
7. Any outside area used by customers will be clearly delineated by ropes, planters or barriers.
8. An incident book shall be kept at the premises and maintained on site. It shall be made available on request to an authorised officer of the local authority or member of the police. The register will record all crimes at the premises, any incidents of disorder, any refusal for the sale of alcohol and any visits by the emergency services
9. The premises shall operate a “Challenge 25 policy” in relation to alcohol sales.
10. No striptease or entertainment of a sexual nature will be allowed on the premises.
11. No persons under the age of 18 years will be allowed on the premises after 2200 hours.
12. Whenever alcohol is offered for sale there will be a member of staff who is the holder of a personal licence on duty at the premises.
13. When a private function is held on the premises and it is closed to the general public, sufficient SIA members of staff will be employed to regulate entrances and exits.

Additional evidence to support the notice of the representation will be presented at any subsequent Licensing Committee hearing. This evidence will be expanded on verbally, written, statistical or CCTV evidence.

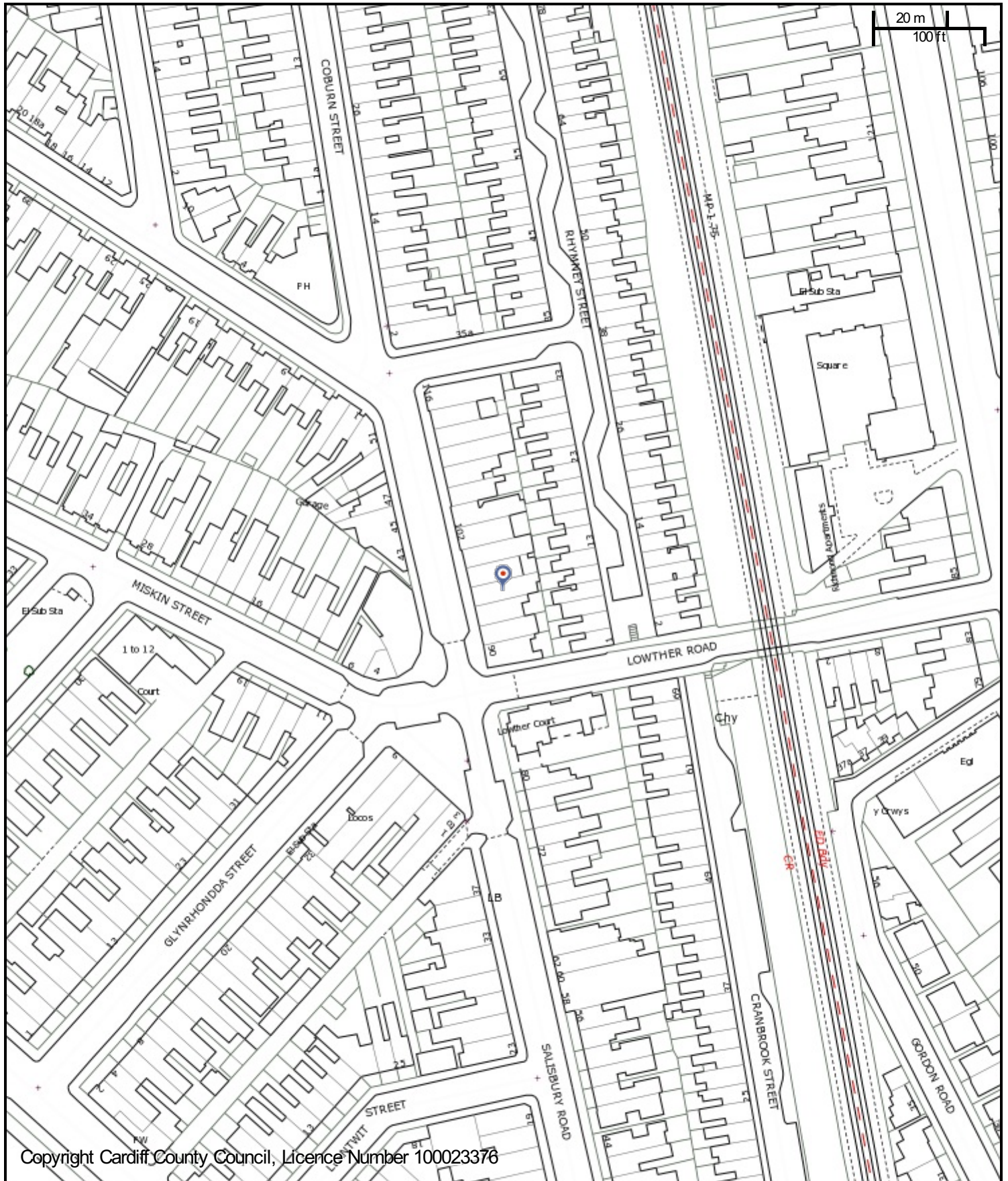

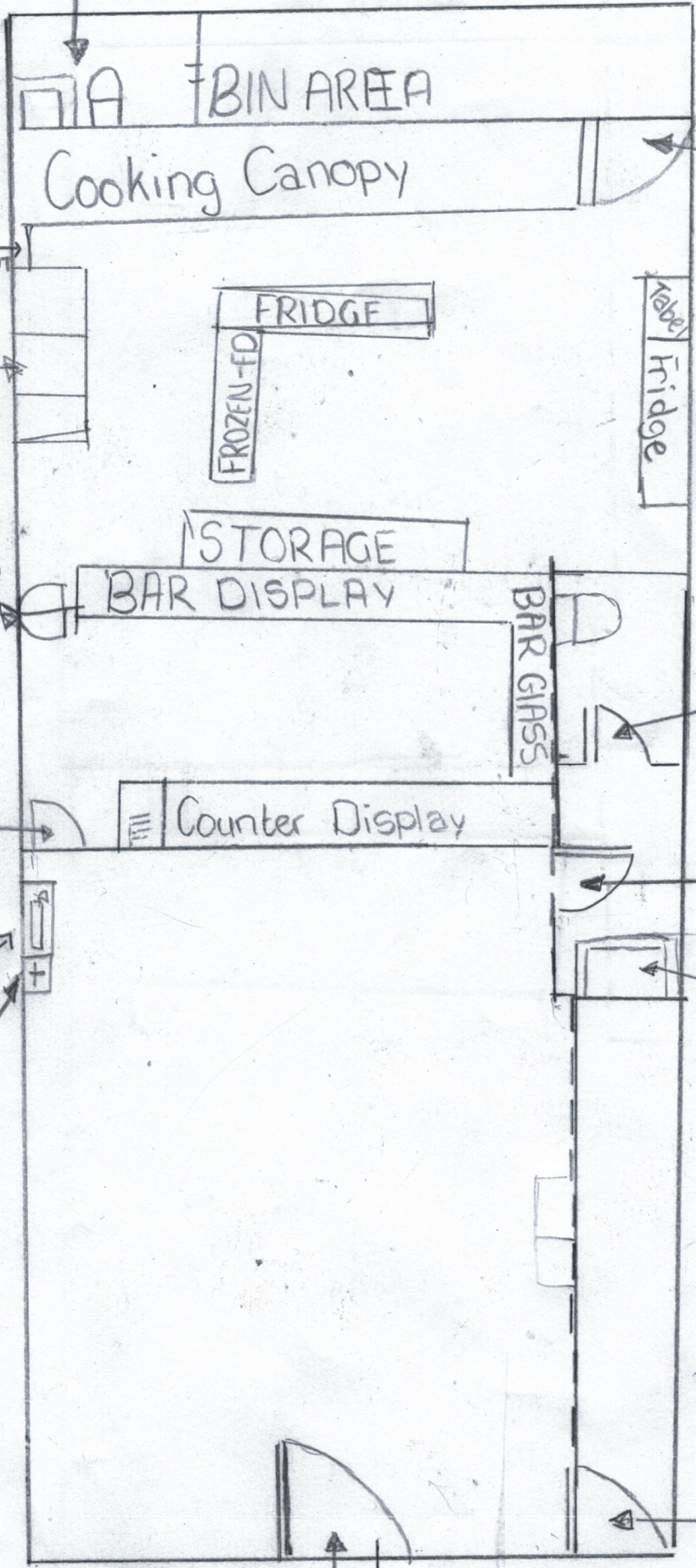

I have had discussions with officer [redacted] about my application . I wish to add some recommendations to the application as highlighted below .

Also I confirm that I wish to surrender the current existing Licence CCCP00345 if I am successful with this application .

We will be running a Srilankan and Indian cuisine restaurant business. We will be providing dine in option with tables and seats with a maximum capacity of 25 people.
We will also be providing takeaway options . We will be delivering with Just Eat and Deliveroo from 5pm to the last orders for delivery being taken at 10.30pm. We will not be delivering any alcohol .

The restaurant will be open until 1am on weekdays and 3am on weekends . However, after 11.30 pm we will not be accepting any new customers for fine dining .After 11.30 pm we will lock the door and only allow the exit of the customers already present and the entry of takeaway customers.Most of our fine dining customers will be coming through booking. The option for customers to walk in and order for takeaway will be available every day.

In terms of alcohol , we will only be providing alcohol with food. There will be no option to buy alcohol as a single item for both our fine dining customers and our takeaway customers . Takeaway customers will only be given canned alcohol after midnight. For every service we will advise the customer not to open the alcohol on the road .

As mentioned before . The food business is our main focus . The on and off license is just a backup for the food business.

The main reason we are asking for an extended hot food serving and on and off license is mainly for our private occasion customers and takeaway customers . We do not know specifically what days we may get a private occasion booking and we would really like to be able to provide for these bookings.

We have many celebrations our restaurant could be used throughout the year . Like diwali and navratri in October and November , south asian new year in april , south asian harvest festival season in january and festivities like christmas.

Overall , our request on this application is to be able to serve hot food from 11am until 3am every day . This will include serving takeaway and private occasion bookings for fine dining . We are also requesting an extended on and off alcohol premises license until 3am every day.

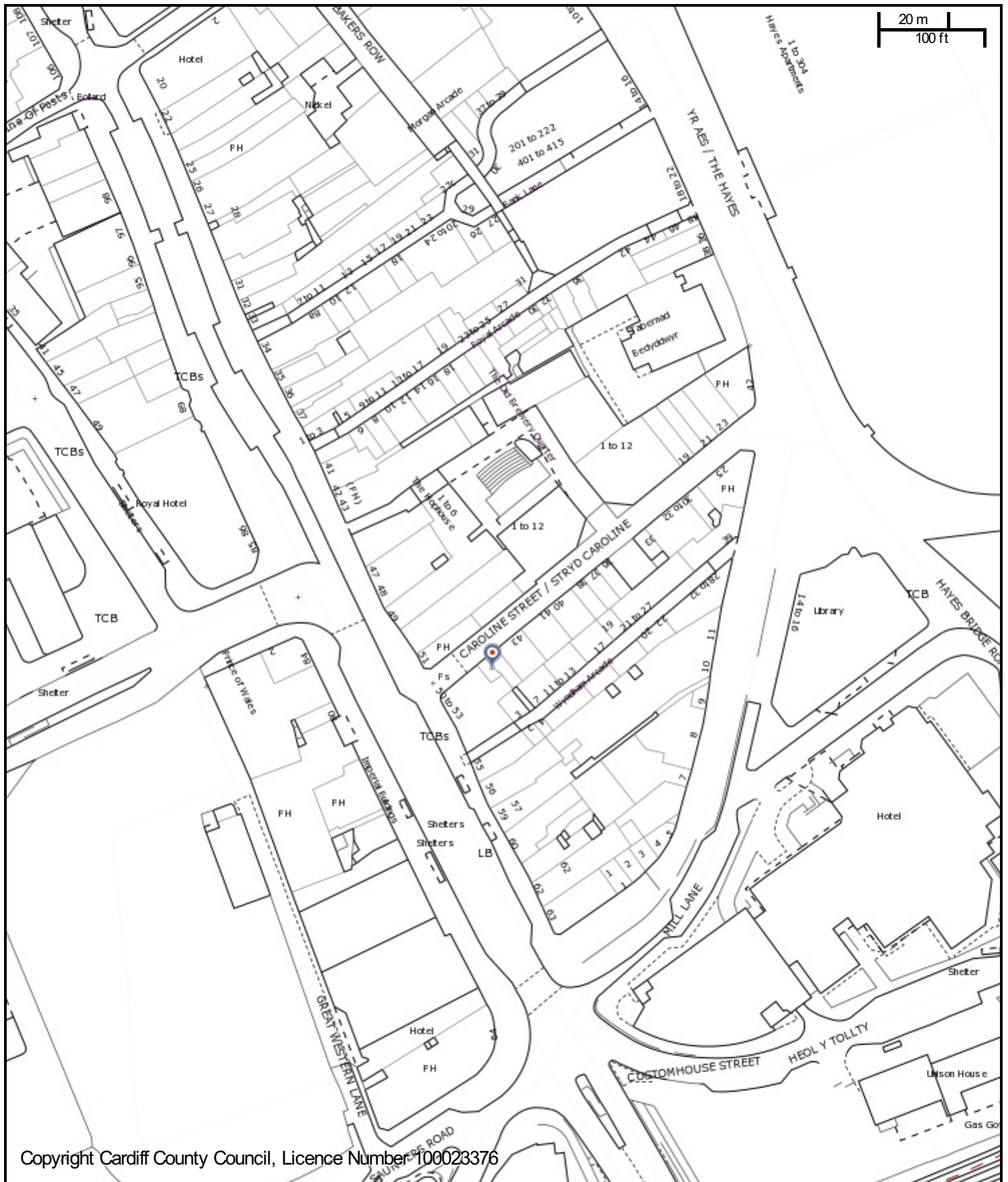

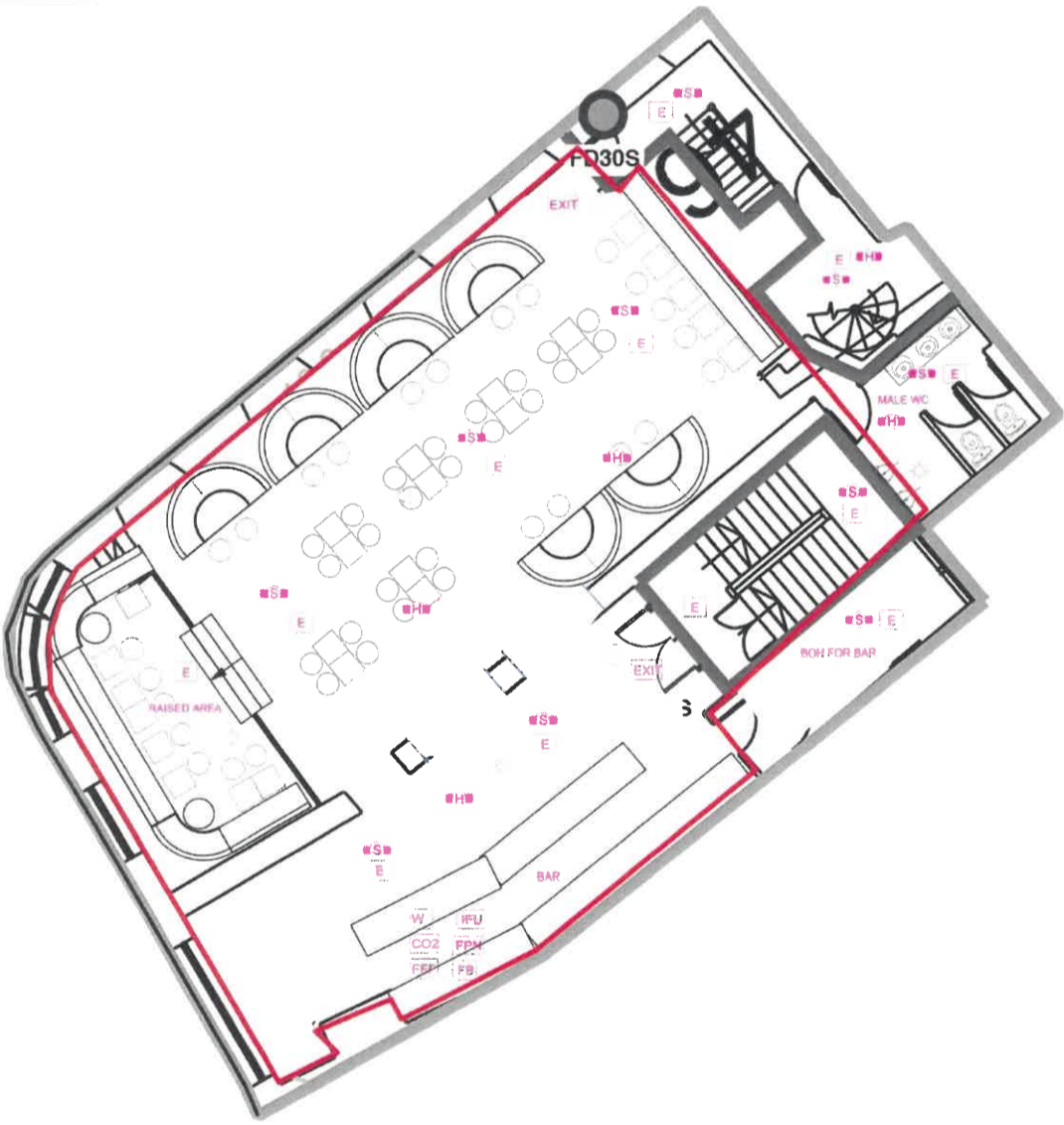

 - c) If the door supervisor is not an employee of the Premises Licence holder, the name of the person, company or agency by whom that person is employed or through whom the services of that person is engaged;
 - d) the register should be kept on the premises and made available for inspection upon request by an authorised officer of the Council or a Police Officer.



8. When SIA registered door supervisors are employed at the premises, they will utilise a minimum of three body worn video devices. Any such device will be capable of recording both audio recordings and visual images. The recordings will be kept for a minimum of 31 days and will be produced to a Police employee in a readily available format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.
9. On those occasions when SIA registered door supervisors are employed at the premises, the DPS will ensure that an adequate system for measuring the number of patrons in the premise is used by such as clicker devices. Numbers of patrons on the premises will be recorded hourly in the door supervisor log-book.
10. The premises shall use a radio system which is monitored by the Local Authority and South Wales Police.
11. The Designated Premises Supervisor or a Personal Licence holder shall be present, at all times that alcohol is offered for sale.
12. Non-glass vessels will be used from 23:00hrs each night when the premises opens beyond 03:00hrs
13. No performance of striptease, lap dancing, entertainment of a sexual nature or other similar entertainment will be permitted on the premises.
14. Open containers of alcohol shall not be removed from the premises.
15. At least 70% of the public space will be occupied by tables and chairs at all times.
16. The Designated Premises Supervisor shall be a member of the Cardiff Licensees Forum and will attend meetings in person or by sending a suitable proxy.
17. On days classified as major event days by South Wales Police, all drinks will be dispensed into non-glass vessels, with the exception being hot drinks.
18. The premises will operate a Challenge 25 policy whereby any person attempting to buy alcohol who appears to be under 25 will be asked for photographic ID to prove their age. The recommended forms of ID that will be accepted are passports, driving licences with a photograph, photographic military ID or proof of age cards bearing the PASS mark hologram.
19. All bottles of spirits supplied to patrons will be fitted with a measured 25ml pourer approved by South Wales Police.

20. Pre-booked Alcoholic beverages;

- a. One 75cl bottle of spirits { being alcohol with an ABV 15% or more } is permitted to be pre-booked and pre-paid electronically per multiple of four customers.
- b. One 75cl bottle of wine, sparkling wine or champagne is permitted to be pre-booked and pre-paid electronically per multiple of two customers.

Should the party size permit the ordering of more than one bottle, or the equivalent of spirits or wine, the bottles may be delivered to the party at the ratio above.

- 21. Last admission to the premises will be 01:00hrs daily. The exception to this will be those existing customers who have temporarily left the premises to smoke in any designated smoking area attached to the premises.
- 22. The premises will adopt the drug safe scheme. A lockable Drugs safe will be installed at the premises and accessible only to a Police officer or member of Police staff. Any drugs seized at the premises will be recorded in the premises incident book. This entry will record the date and time of the seizure, the details of the person seizing the items, a description of the items and the circumstances of the seizure. Where it is suspected that a person is supplying drugs then Police will be contacted at the time.
- 23. Suitable medically trained staff will be on the premises whenever said premise is open to the public. A dedicated area shall be provided, for the purpose of providing care to patrons who are in need of assistance through injury, intoxication, or awaiting collection. In cases where patrons refuse all offer of assistance, all steps taken by staff at the premise shall be recorded, to evidence what efforts were made to ensure the safety of the individual concerned.
- 24. There will be no mobile alcohol sales persons of any sort. All sales of alcohol will be by way of static bars.

In addition, South Wales Police seek a reduction in the hours of licensable activity requested within the application as follows,

1. The sale by retail of alcohol for consumption on and off the premises:


Monday to Sunday: 10:00 to 02:30.

An additional hour on the day when British Summertime commences.

1.1 The number, distribution and/or size of emergency routes and exits is inadequate

1.1.1 The number, distribution and dimensions of emergency routes and exits available are not considered adequate having regard to the use, equipment and dimensions of the premises and the maximum number of persons who may be present there at any one time. This should be remedied by the provision of additional/alternative exits/routes, from the following areas:

- If the spiral stair is to form part of the escape route from the second floor, it should be designed in accordance with guidance given in BS 5395-2.
- Escape stairs should have an absolute minimum width of 1000mm which is in accordance with paragraph 17.4.1 of BS 9999 2017.

I am writing to submit a representation on behalf of the Enforcement Section of the Licensing Authority in respect of the above application for Tonight Josephine.

The Licensing Authority (Enforcement) believes that the application undermines the following licensing objectives:

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance

The premises itself is located in an area that is subject to the Council's Cumulative Impact Policy (CIP) and the applicant's proposals would mean that the premises would fall within the 'red' category in Table 1 of the Cumulative Impact Policy (CIP). The CIP has been adopted due to high levels of alcohol related crime and disorder in the interests of public safety and the avoidance of nuisance. The policy creates a rebuttable presumption that the application will be refused or subject to certain limitations, unless the applicant can successfully demonstrate the proposals will not add to the negative cumulative impact on one or more of the licensing objectives.

Having read the application, I am disappointed to note that the applicant has not put forward any conditions in which they would promote the Licensing objectives, but do note however that they are willing to agree to certain conditions. As it stands I am of the opinion that the application is not "exceptional" which is expected of an application falling within the CIP.

Caroline Street is a busy street, particularly during the early hours of the morning with high incidents of anti-social behaviour, I do not believe that the applicant's proposals go far enough in demonstrating that this new business type will not add to the negative cumulative impact already experienced in this area.

I am happy to continue discussions with the applicant in the hope that the application can be improved.
