1. Application

1.1 An application for the Grant of a Premises Licence has been received from Flight Club Darts Limited in respect of Flight Club, 3-4 St Mary Street, Cardiff, CF10 1AT.

1.2 The applicant has applied for the following:

(1) In respect of the following licensable activities:

- (i) The sale by retail of alcohol for consumption on the premises.
- (ii) The provision of regulated entertainment in the form of indoor sports and recorded music (indoors).
- (iii) The provision of late night refreshment (indoors).

(2) Description of Premises (as stated by applicant):

“Social entertainment venue providing competitive socialising in the form of darts together with ancillary bar and food offerings”.

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

- (iii) The provision of late night refreshment (indoors):
 - Sunday to Wednesday: 23:00 to 00:00
 - Thursday to Saturday: 23:00 to 01:00
 - Sundays preceding a Bank Holiday: 23:00 to 01:00
 - New Year's Eve: 23:00 to 03:00

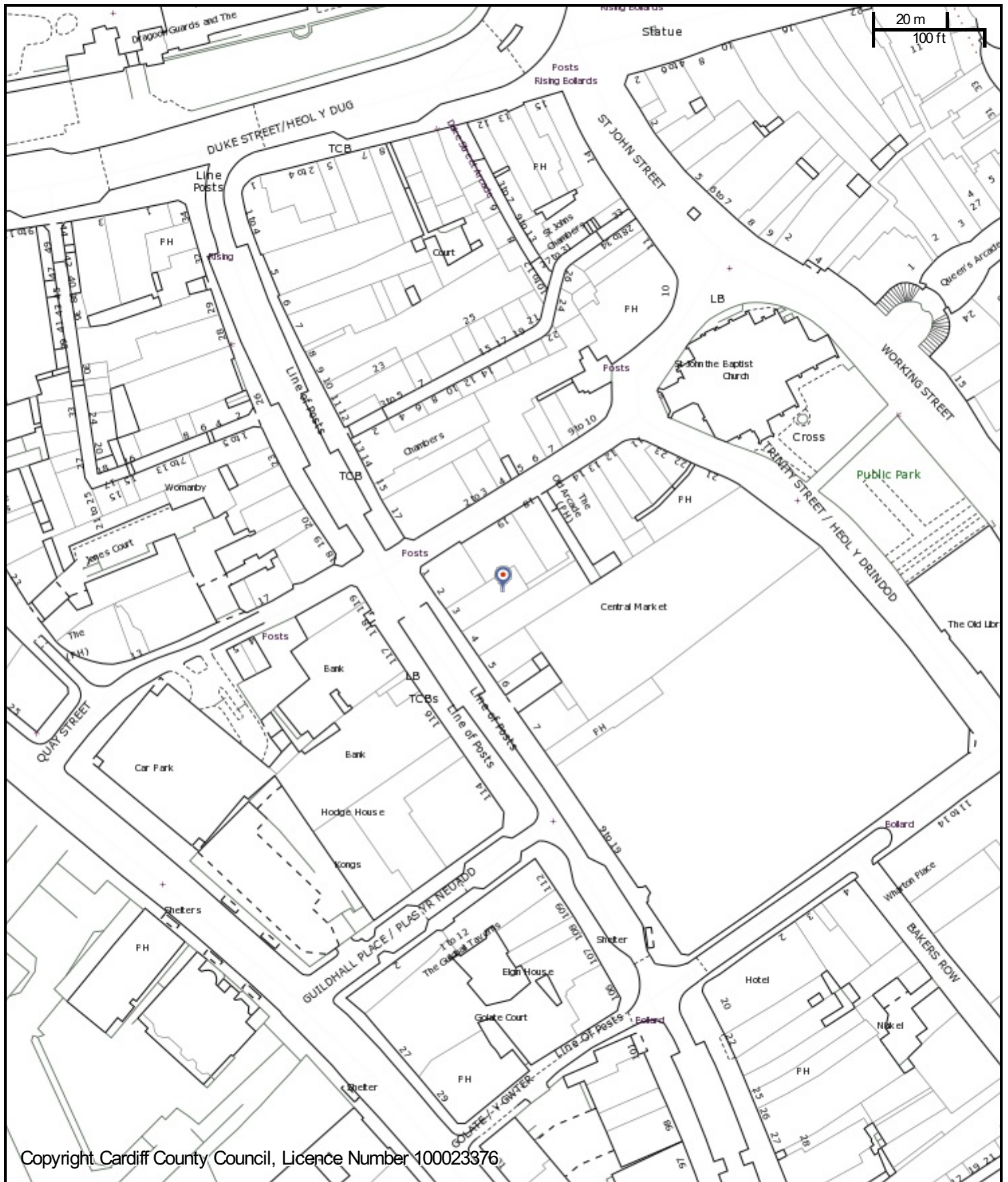

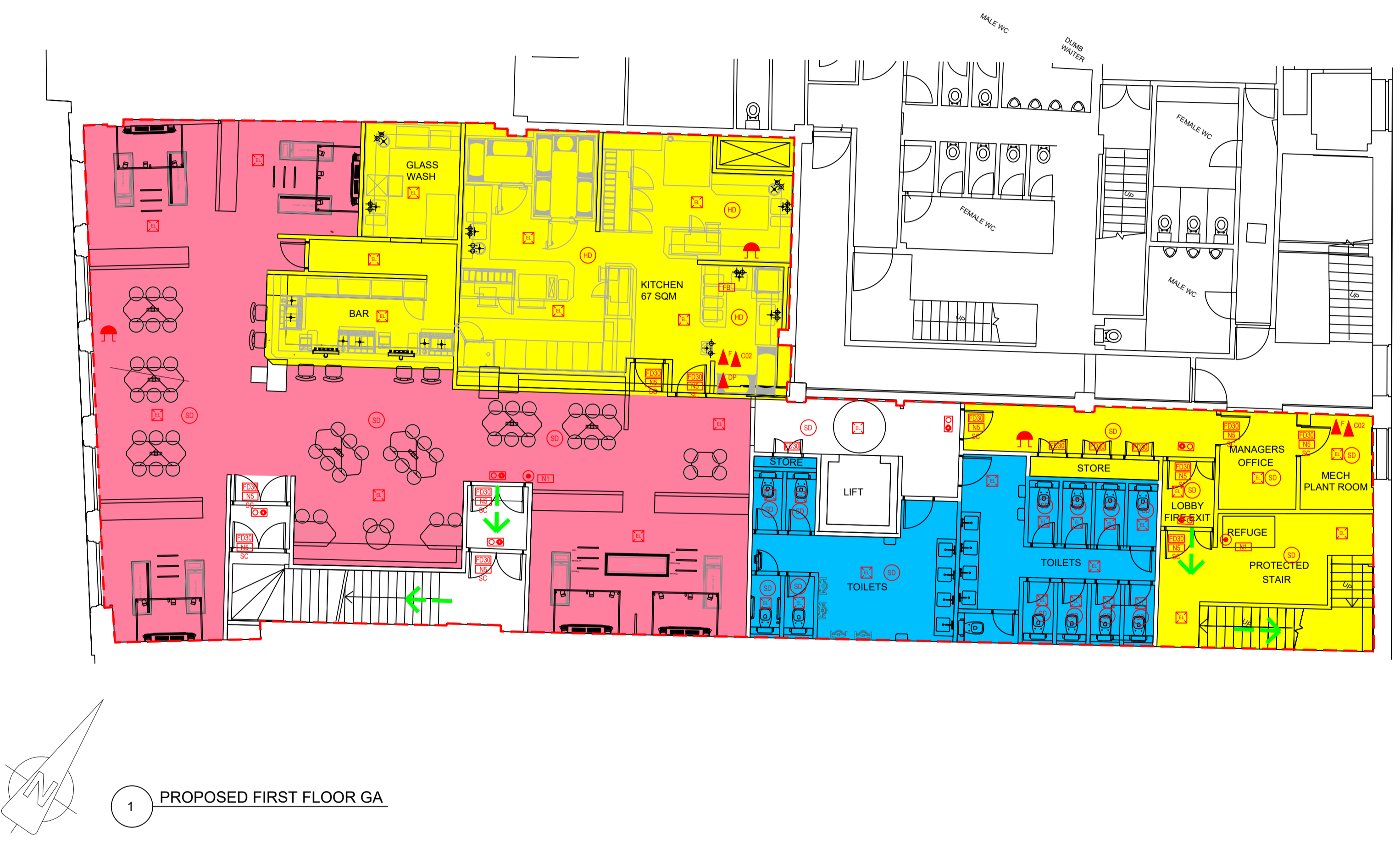

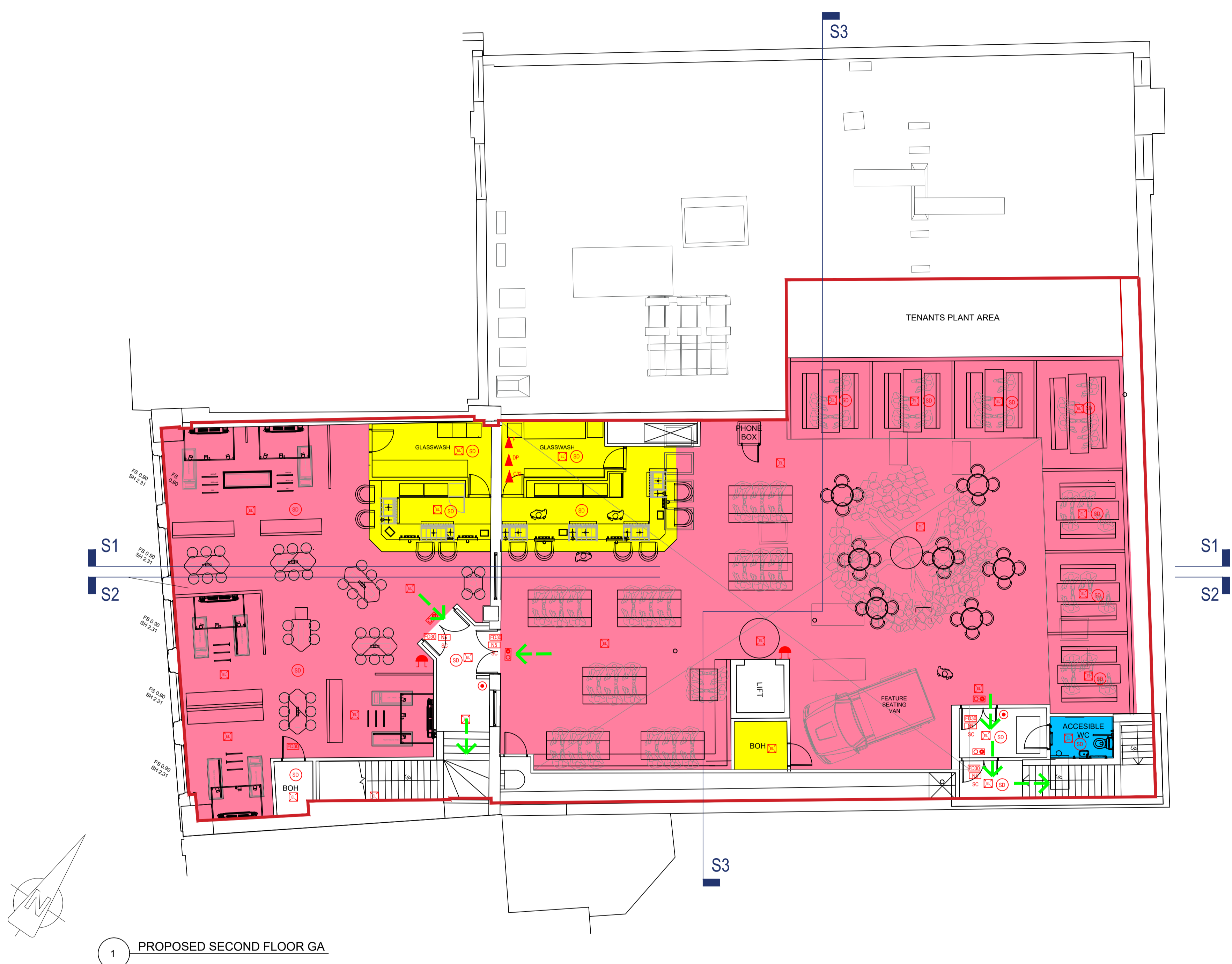

Schedule of Proposed Conditions

General (all Licensing Objectives)

- 1) There shall be a minimum of 8 darts oche's available at any time the premises is open to the public.

The Prevention of Crime and Disorder: CCTV

- 2) A CCTV system shall be installed to an agreed standard as approved by South Wales Police and it shall be maintained and operated at all times when the premises are open to the public. The system will cover all areas of the premises where the public have access (excluding toilets) including all entrances and exits and any external areas associated with the premises. The images will be kept for a minimum of 31 days and shall be produced to a police employee in a readily playable format immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.

Doorstaff:

- 3) SIA registered door staff will be employed at the premises in accordance with a written risk assessment carried out by the premises. A copy of the risk assessment shall be kept on the premises and made available to the police and other responsible authorities on request
(b) The risk assessment shall be reviewed on a 6 monthly basis. In addition:
- 4) The Premises License Holder will employ a minimum of three (3) SIA licensed door supervisors from 20:00 until premises closes on Thursday, Friday and Saturday nights and / or any nights when the licensable activities continue past midnight.
- 5) SIA registered door staff will ensure the dispersal of all patrons from the premises at the end of the trading day.
- 6) On those days designated by South Wales Police as major event days in the City Centre and Bay areas of Cardiff, no less than four (4) SIA registered door supervisors will be employed at the premises from either 16:00 that day or no less than two hours before the commencement of the event, whichever is earlier, until closure of the premises.
- 7) There shall be a minimum of one body worn camera device in use at the premises whenever SIA licensed door staff are on duty. The body worn devices shall be capable of recording video (images) and sound. Recorded images shall be stored for a minimum of 31 days and shall be produced to a police employee on the provision of satisfactory identification, in a readily playable format, immediately upon request when the premises are open to the public and at all other times as soon as reasonably possible subject to data protection legislation. There will be sufficient trained staff to facilitate the above.

- 8) SIA licensed door staff shall each carry an internal radio to allow communication between themselves and management.
- 9) The licensed door supervisors shall be employed solely for vetting, regulating, controlling and supervising patrons whilst entering and whilst on the premises.
- 10) A register of door supervisors shall be kept at the premises. The register shall show the full name and SIA registration number of each door supervisor, stating the start and end duty times from each door supervisor. The register shall be kept by the DPS for a minimum of 6 months and will be made available to a Police employee on request.

Drug safe:

- 11) The premises shall operate a drug safe scheme. A dedicated register shall be kept in which any drugs deposited in the drug safe are recorded. This register shall be cross referenced with the incident book.

Cardiff City Centre:

- 12) The designated Premises Supervisor will be an active member of the Cardiff Licensees Forum.
- 13) The premises will operate a South Wales Police / Cardiff Council approved radio system

Vessels:

- 14) No customers shall be allowed to leave the premises while in possession of any drinking vessel or open glass bottle, whether empty or containing any beverage.

Contact:

- 15) A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open.

Mobile dispense:

- 16) Any mobile alcohol dispensers (shot sales) to be personal license qualified.

Dance Floor:

- 17) No dance floor to be available at the premises.

Incident Book:

- 18) An incident book will be kept and maintained at the premises at all times. This book will record the following:
 - (i) All crimes reported at the venue
 - (ii) Any ejections of patrons
 - (iii) Any disorder on the premises
 - (iv) Any visit by representatives of a relevant authority or emergency service
 - (v) Any failure of the CCTV system

- 19) It shall be made available on request to a police officer.

Food:

- 20) Substantial refreshment (hot) will be readily available at the premises when open to the public until a period of no less than one hour prior to the closure of the premises.

Event Days:

- 21) On days classified as 'major event days' by South Wales Police, all drinks will be dispensed into non glass vessels, with the exceptions being hot drinks (ceramics) and wine, champagne and cocktails, if served with a table meal to seated patrons, unless otherwise agreed with the police, in writing, on request made no less than 14 days before such event.

22) No live sports will be screened at the premises.

The prevention of public nuisance:

23) All areas that are occupied by patrons must have a designated member of staff for that level, during the hours that the premises are open to the public.

24) There will be no patrons permitted to drink on the highway outside of the premises.

25) A dispersal policy will be drawn up and implemented to ensure that as far as practicable customers leaving the premises at the end of each night's trading session do so quickly and quietly.

The protection of children from harm:

26) At all times that the premises is operating under this licence, the Premises License Holder shall ensure that its staff operate a Challenge 25 Policy (to minimise the risk of alcohol being sold to underage customers). This policy shall provide that before any sale of alcohol any person who appears to be under the age 25 will be required to produce photo ID in the form of a passport, driving licence, UK Military ID card; PASS (or similar) card to prove that he/she is over the age of 18. Posters advertising the Challenge 25 and proof of age policies shall be displayed in prominent places in the premises. The premises licence holder shall arrange staff training in relation to underage sales.

27) All staff involved in the sale of alcohol shall be trained to record refusals of sales of alcohol in a refusals log (whether written or electronic)

28) No striptease, no nudity and all persons to be decently attired at all times.

29) No under 18's permitted in the premises after 20:00

I, representing a responsible authority (Environmental Health), wish to object to the above licensing application for the new premises noted above to allow the second floor external area to be used for consumption of alcohol on the grounds that the application does not promote the licensing objective of "The prevention of public nuisance".

I note that the applicants do not address how they intend to promote the licensing objective of "The prevention of public nuisance" within the application with regards to the external area situated on the second floor. The application only gives reference to 'regular monitoring by a member of staff' and 'asking patrons to leave quickly and quietly'. This does not demonstrate a clear preventative for the licensing objective of "The prevention of public nuisance" particularly with lack of reference to the proposed external area situated on the second floor. I am concerned that the application seeks to include outside eating and drinking with recorded music until terminal hour.

I have concerns that the external second floor roof terrace area is situated within near proximity to residents and is intended to be used up until 00:00hrs, Sunday - Wednesday and 01:00hrs Thursday - Saturday which is likely to cause unnecessary nuisance to nearby residents. Cardiff Licensing Policy states that

- "Operators should take particular care to ensure that customers using external drinking areas, smoking areas or the pavement outside, do not cause unnecessary nuisance to local residents. It is suggested that the terminal hour for external areas that are in close proximity to residential properties does not exceed 21:00hrs."
- "Careful consideration should also be given to determining suitable external areas for smoking. Ideally designated smoking areas should be sited at the furthest distance from residential properties and cigarette bins should be provided."

I am writing to submit a representation on behalf of the Enforcement Section of the Licensing Authority in respect of the above application for Flight Club.

The Licensing Authority (Enforcement) believes that the application undermines the following licensing objectives:

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance

Although the applicant has described the premises in the application form as a “*social entertainment venue providing competitive socialising in the form of darts together with ancillary bar and food offerings*”, the proposed conditions do not reflect an ancillary bar. As such, and with the premises being located in an area that is subject to the Council’ Cumulative Impact Policy (CIP) the application would fall within the ‘red’ category in Table 1 of the Cumulative Impact Policy (CIP).

The CIP has been adopted due to high levels of alcohol related crime and disorder in the interests of public safety and the avoidance of nuisance. The policy creates a rebuttable presumption that the application will be refused or subject to certain limitations, unless the applicant can successfully demonstrate the proposals will not add to the negative cumulative impact on one or more of the licensing objectives.

St Mary Street is a busy street, particularly during the early hours of the morning with high incidents of anti-social behaviour, I do not believe that the applicant’s proposals go far enough in demonstrating that this new business type will not add to the negative cumulative impact already experienced in this area. The Licensing Authority (Enforcement) therefore object to the applicant’s proposals and ask that the Licensing Sub-Committee determine the matter.

I write on behalf of myself and Cllrs Chris Weaver, Ali Ahmed and Sarah Merry to note our concerns regarding the above applications.

As you will be aware St Mary Street sits in the Cumulative Impact Zone (CIZ) implemented by Cardiff Council to control the number of licenced alcohol premises in the zone with the aim to promote the Licensing objectives of:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance and :
- the protection of children from harm.

The Cumulative Impact Policy (CIP) which dictates the CIZ is in place because it is already recognised that there are problems related to alcohol consumption in that area, that has an impact on public safety and crime and drains the already overstretched police resources to control it.

It is difficult to see how changing the use of a premises from two shops to another very large drinking establishment on St Mary Street will promote these objectives.

While we recognise that benefit of ensuring the use of the buildings and creating employment, we ask you to consider what disadvantages this could bring.

It is difficult to see from the application whether users of the premises will only be allowed to attend the premises if they are playing darts and are then expected to leave once their session is over or whether they are able to stay on the site and drink until 12.30am or 1.30am dependant on the days of the week.

From the plans of the venue it looks as if about 12 people can gather around one dart board to drink and play darts and this is duplicated a number of times around the venue.

To us, this is aimed at attracting groups, such as hen and stag parties who, as we are aware, can create noise and anti-social behaviour as they exit the building.

The venue is also next door to the entrance to Cardiff Market where these groups could interact with shoppers and their children using the market, especially on a Saturday afternoon.

The Site offers drinking on 3 floors and possibly 4 floors if that is the reason for the roof terrace.

We also have concerns about the noise that might be emitted from this premises, especially from the roof terrace.

This area of St Mary Street is still largely retail with an area of good quality restaurants in the High Street and surrounding streets and is very different to the night life at the other end of St Mary Street. There are also a number of residential flats and a hotel in the area, all of whom are likely to be disturbed by noisy customers

It would be very disappointing if this area was disrupted and spoilt by the opening of such a large drinking establishment.

We ask that the subcommittee to reject these applications.

- (iii) The provision of regulated entertainment in the form of live music (indoors), recorded music (indoors) and entertainment of a similar description (indoors):
Monday to Saturday: 09:00 to 23:00
Sunday: 09:00 to 22:30
- (iv) The provision of late night refreshment (indoors and outdoors):
Monday to Saturday: 23:00 to 23:30

1.3 The application requests the following:

To vary the licensing plans to include the following:

- General refurbishment works to the existing trade area including alterations to fixed seating (remove/relocate/replace).
- Minor alterations to back-bar fitting, including new tiling and shelving. Front bar to remain as existing with new over clad front.
- New safety flooring throughout.
- External works to include a covered dining area

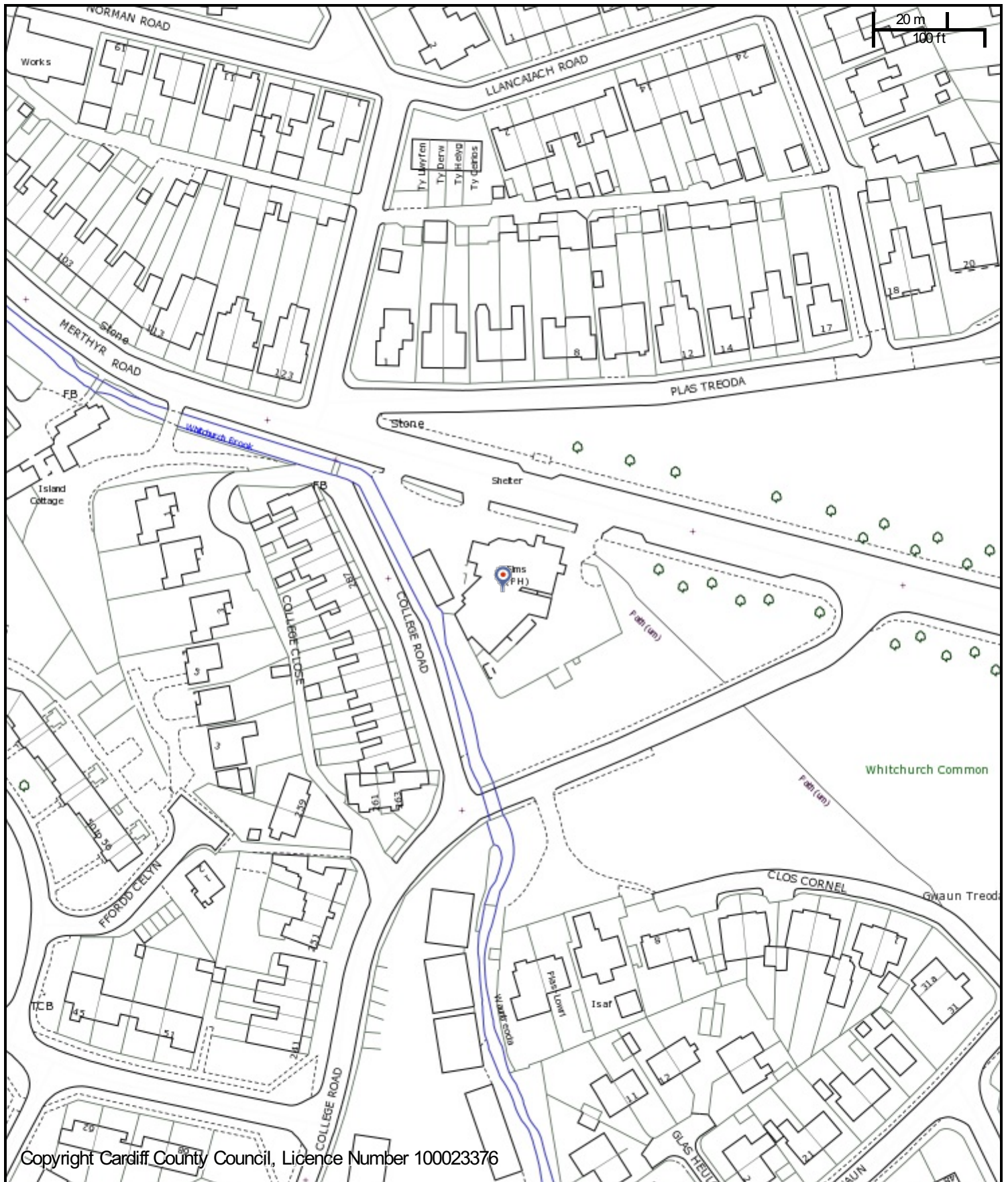

Annex 1 - Mandatory Conditions**Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3)
 - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

Mandatory conditions where licence authorises supply of alcohol for consumption on the premises

1.
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
3. The responsible person must ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the

permitted price.

5. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where-

(i) P is the permitted price,

(ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

6. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

7. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.


(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions Consistent with the Operating Schedule

1. Alcohol may be sold or supplied for one hour following the hours set out above and on Christmas Day between 15:00 and 19:00 to persons taking table meals in the premises in a part of the premises usually set apart for the service of such persons and for consumption by such a person in that part of the premises as an ancillary to his meal. A period of 30 minutes is allowed at the end of each such period of permitted hours for the consumption of alcohol on the premises by persons taking meals provided the alcohol was supplied ancillary to a meal.

For other purposes or in other parts of the premises the hours set out above shall continue to apply.

2. The external areas attached to the premises should not be used after 22:30 hours each day.

We wish to object to this variation application, in particular to the external covered dining area, for reasons relating to noise pollution, light pollution, and highways.

- Noise pollution – we are concerned by any outdoor facility at these premises. We feel this establishment abdicates all responsibility for any noise it generates outside – recent examples are the Munich Beer Festival weekend it held in the marquees which this application will replace, and a scene of many dozens of young people fighting, screaming and crying in the main Merthyr Road at 1am on a Sunday morning. Several complaints were made by locals over that beer festival weekend. A senior member of staff told me to ‘give them a weekend off’ and ‘phone the council on Monday’. A more recent event – again in an outside marquee - attracted a number of calls to your 101 service, if you wish to investigate further. The manager himself admitted noise from recent events had been ‘excessive’. See attached. There are often people congregating in the car park until very late, shouting. Most nights we endure beeping of horns well after shut-tap. As we say, none of this is policed by the premises, and we live in a residential area. We fear the permanent outdoor area proposed in this variation will make the situation even worse.
- Highways – we believe these premises do not have enough parking spaces for the number of people who eat there, and in recent years, spaces have actually been reduced through Covid-outdoor marquees and the selling of Christmas trees. These have taken a considerable amount of space in the back car park, and these proposed plans appear to continue to take up a large area of the rear car park, as well as additional footfall to the premises. Where are they all going to park? Parking relating to these premises have been an issue for some time and we feel it is getting worse, and will worsen further if this variation is agreed. As we have told ward members before, people living on Whitchurch Common have been increasingly squeezed by Cardiff council measures elsewhere in the community – measures to restrict Heath Hospital parking have moved people towards our homes; many shoppers now park outside our houses because of the car parking charges introduced in the village; and the restrictions of parents taking their children to Melin Gruffydd have created a rat-run on nearby Mervyn Road. This situation is exacerbated especially at the weekends by the Elms, which we believe has too big a footfall for the parking spaces provided for its diners, resulting in their customers parking in the local community, making access to own homes difficult. Images below show the extent of illegal parking in the local community on occasions.
- Light pollution – there is already a significant issue with light pollution from these premises intruding into nearby homes. We fear that an additional, external area will make this situation even worse.

We ask that these matters are taken into consideration by the local authority as we fear the impact this application will have on our local community.

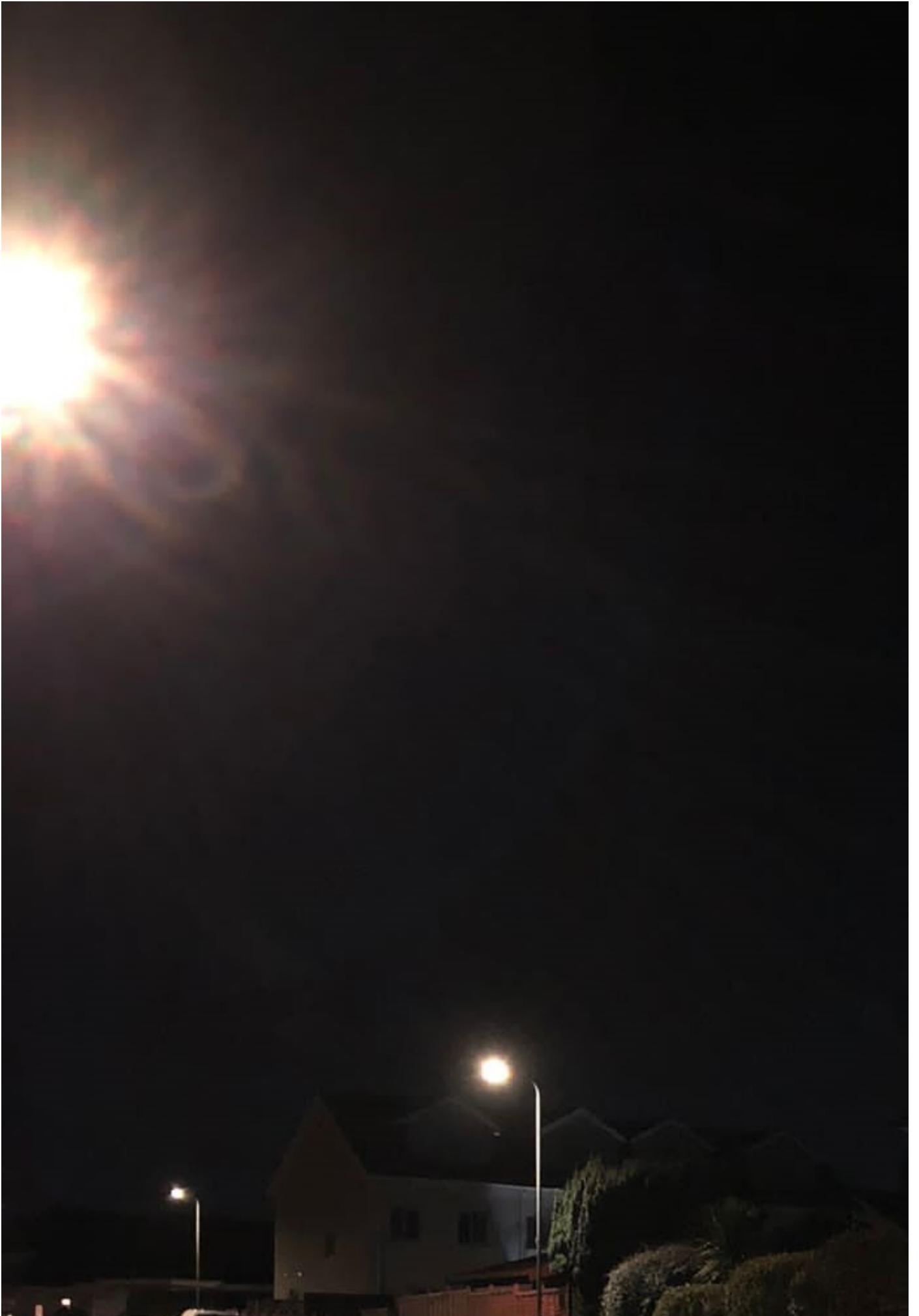

if this proposal to build outside covered seating on a substantial section of car parking area at the Premises is agreed there would be an inevitable increase in an area that already has high levels of traffic and frequent

serious congestion on Merthyr Road, Plas Treoda and surrounding streets.

We already have people who use Plas Treoda as a Park and Ride facility, village shoppers and customers of the Three Elms, the latter being unable to park at the Three Elms because of reduced capacity of parking spaces.

Weekends or particular events at the Premises worsen the parking situation in Plas Treoda and surrounding streets, often resulting in residents not being able to access their homes easily because of inconsiderate parking.

We have also experienced significance levels of noise and disturbance when patrons return to pick up their vehicles are closing time including, shouting, arguing and slamming doors.

-Noise Issues

We are already concerned and disturbed by noise from outside the Premises at closing times, there have been loud arguments, threatening behaviour towards each other, fighting, screaming, crying, all of which can be clearly

heard and observed by residents of Plas Treoda.

Likewise loud music, this can be heard when it is playing inside the Premises, it is extremely loud when it is playing outside the Premises. A recent example was the Oktoberfest event which was held in the marquees and inside

the Premises. At one point the continuous very loud music became intolerable, I went over to the Premises to ask if the noise level could be reduced. I spoke to the manager who said that they had a license to play music

outside the building and they would not be reducing the volume, however he assured me that it would stop at 10pm. I left the Premises, only to be pursued on to the pavement by the landlady who started shouting and shrieking

at me because I had complained about the noise. She referred to residents of Plas Treoda as 'you lot' are always complaining about something.

She continued that there was nothing that we could do as this was 'not a residential area' and 'they could do what they liked'. I was shocked and disturbed by her behaviour , and her attitude towards residents of Plas Treoda. Obviously

I said that this is a residential area , but as she continued shouting and screeching and saying it is not a residential area I simply walked away from her. This does not auger well for future community relations. This matter was reported to Licensing who advised that they could pursue this, but I declined.

We would be very concerned about the impact on the local community if the proposal for the covered outside seating area was approved, and we ask that you consider our concerns and comments.

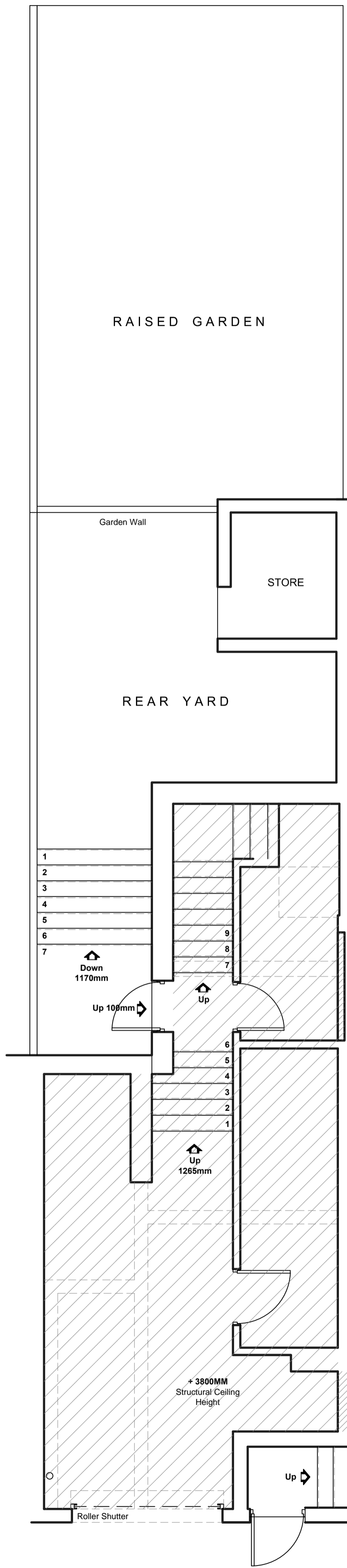

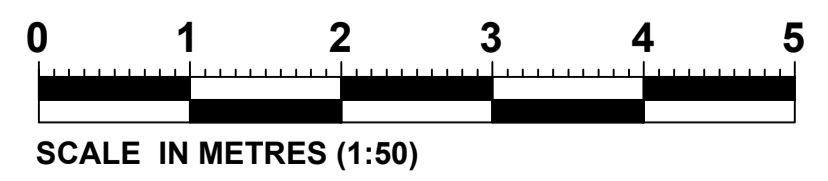

As the Councillor for Adamsdown and Clifton Street this application is concerning. Clifton Street was the traditional high street for the area but has sadly gone downhill over the years. It has seen a rise in anti-social behaviour, and I fear that the addition of another bookkeeper will continue that trend.

Adamsdown is one of poorest wards in the city with areas of high deprivation. It is one of the smallest wards but yet is home to several vulnerable groups of adults including some of Cardiff's biggest homeless shelters, many half way houses for refugees and centres for vulnerable women. There is also plans to establish a care leavers centre at the bottom of the street. (planning permission has been approved) The street already has one bookkeeper less than 100m from this new proposed site and an amusement game shop. I fear that they are choosing this location to target those who are already in a desperate situation. The council should not allow such a concentration of places designed to part people from their money in an area where we know people cannot afford to lose it.

The homeless shelters, the care leavers centres, the women's refuge and the refugee placements have all been put near Clifton street with support from the Council. I would urge the Licensing team to talk to colleagues in Housing and Communities as I believe a concentration of betting facilities would negate much of the good work they are trying to do. I would also suggest that they speak to both Shared Regulatory Services and the local Police. Both spend a huge amount of effort on Clifton Street and both their opinions should be considered.
