### 1. Application

- 1.1 An application to vary a Premises Licence has been received from Punch Partnerships (PTL) Limited in respect of Unicorn Inn, Church Road, Old St Mellons, Cardiff, CF3 6YA.
- 1.2 The applicant has applied for the following:
  - (1) Description of the nature of the variation (as stated by applicant):

The application proposes to -

- 1. Amend the licensing plan in accordance with drawing number 250 Rev A dated 04/05/23 which accompanies the application. Please note that the amendments to the licensing plan are not to take effect until such time as the works are complete and the Licensing Authority are notified.
- 2. Extend the opening hours daily for the premises to open from 08:00 for the provision of non-licensable activities such as breakfast, coffee, & tea etc; and to close on Sunday to Thursday at 00:30 the following day, and on Friday & Saturday at 01:30 the following day
- 3. Extend the start time for the sale of alcohol to 08:00 daily
- 4. Extend the terminal hour for the sale of alcohol and late night refreshment on Sunday to Thursday to 00:00, and on Friday & Saturday to 01:00 the following day
- 5. Add a non-standard timing for certain licensable activities
- 6. Remove certain existing Annex 2 conditions
- (2) The application requests the following:
  - i) The premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Sunday to Thursday: 08:00 to 00:30 hours Friday and Saturday: 08:00 to 01:30 hours New Years Eve: 08:00 to 01:30 hours

ii) The sale by retail of alcohol for consumption on and off the premises:

Sunday to Thursday: 08:00 to 00:00 hours Friday and Saturday: 08:00 to 01:00 hours

New Year's Eve: as existing

iii) The provision of regulated entertainment in the form of live music (indoors) and recorded music (indoors):

Sunday to Thursday: as existing Friday and Saturday: as existing New Years Eve: 20:00 to 01:00

iv) The provision of late night refreshment (indoors):

Sunday to Thursday: 23:00 to 00:00 hours Friday and Saturday: 23:00 to 01:00 hours New Years Eve: 23:00 to 01:00 hours

- (3) To remove the following conditions:
  - (2) Plastic drink containers will be used for outside functions
  - (3) No glass allowed outside front of premises
  - (4) All staff will be made aware of health and safety issues
  - (5) Fire extinguishers and fire alarm to be installed with regular checks made on the beer garden for possible hazards
  - (6) All downstairs windows will be kept closed and locked at all times
  - (7) The bottle bins are to be emptied between 10:00 and 12:00 noon
  - (9) The maximum number of persons that may be accommodated at any time in the premises shall be 200
  - (10) Children will not be allowed to sit at the bar but are allowed in the rest of the bar area, restaurant and beer garden. Soft drinks and snacks will be available at all times with children's menus between 12:00 noon and 15:00 and between 18:00 and 21:00 hours

### 2. Current Licence

- 2.1 The current Premises Licence permits the following:
  - (1) Unless otherwise indicated the premises may currently be open to the public during the following hours and for any hours consequential to the non-standard timings:

Sunday to Thursday: 10:00 to 00:00 hours Friday and Saturday: 10:00 to 01:00 hours

New Years Eve: 10:00 to start of permitted hours on New Year's Day

(2) The sale by retail of alcohol for consumption on and off the premises:

Sunday to Thursday: 10:00 to 23:30 hours Friday and Saturday: 10:00 to 00:30 hours

New Years Eve: 10:00 to start of permitted hours on New Year's Day

(3) The provision of regulated entertainment in the form of live music (indoors) and recorded music (indoors):

Sunday to Thursday: 20:00 to 23:30 hours Friday and Saturday: 20:00 to 00:30 hours

(4) The provision of late night refreshment (indoors):

Sunday to Thursday: 23:00 to 23:30 hours Friday and Saturday: 23:00 to 00:30 hours

2.2 A site map showing the premises and a copy of the plan referred to above (*drawing number 250 Rev A dated 04/05/23*) can be found in *Appendix A*.

## 3. Promotion of Licensing Objectives

3.1 The conditions proposed by the applicant to meet the licensing objectives are attached to the report and can be found in *Appendix B* along with a copy of the current licence conditions.

#### 4. Relevant Representations

- 4.1 A representation has been received from South Wales Police. The applicant has agreed that the conditions suggested by South Wales Police should be attached to the licence if granted and the representation has therefore been withdrawn. A copy of the representation, along with the subsequent agreement, can be found attached as *Appendix C*.
- 4.2 A representation has been received from Neighbourhood Services (Shared Regulatory Services). The applicant has agreed that amended conditions should be attached to the licence if granted and the representation has therefore been withdrawn. A copy of the representation, along with the subsequent agreement, can be found attached as **Appendix D**.
- 4.3 A number of representations have been received from the local residents. Copies of these representations can be found attached as *Appendix E*.
- 4.4 A representation has been received from local ward Councillors. A copy of this representation can be found attached as *Appendix F*.

#### 5. Legal Considerations

5.1 In respect of the application the decision must be taken following consideration of the representations received with a view to promoting the licensing objectives, which are:

Prevention of crime and disorder Public Safety Prevention of Public Nuisance Protection of Children from Harm

- 5.2 In each case the Sub-Committee may make the following determination
  - a) To grant the application.
  - b) To modify the conditions of the licence, by altering, omitting or adding to them, where relevant
  - c) Reject the whole or part of the application.
- All decisions taken by the Sub-Committee must (a) be within the legal powers of the Council and its Committees; (b) comply with any procedural requirement imposed by law; (c) be undertaken in accordance with the procedural requirements imposed by the Council e.g. standing orders and financial regulations; (d) be fully and properly informed; (e) be properly motivated; (f) be taken having regard to the Council's fiduciary duty to its taxpayers; and (g) be reasonable and proper in all the circumstances.





Given the changes proposed, we have carefully considered the application, the effect on the licensing objectives and the council's licensing policy. ## **Annex 1 - Mandatory Conditions**

#### Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### Mandatory conditions where licence authorises supply of alcohol for consumption on the premises

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 4. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider: 1/2 pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- 5. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the

  - (i)the holder of the premises licence,

  - (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d)"relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e)"valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 7. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

I write to object to the proposed variation in licensing for the Unicorn Pub, Church Road, St Ederyns.

I reside at and my property overlooks the pub. I work for the police and therefore work shifts around the clock. From a personal perspective, I am highly concerned about the noise nuisance and it affecting my quality of life and sleep. There are already proposals to put a children's play area into the beer garden which will increase noise levels during the day time. Now the noise levels will undoubtedly be worsened with the extended licensing proposals.

Firstly, I would like to say that in general, I am happy that the pub is re-opening. However, the pub is located on a residential estate with houses in close proximity. I do not feel it is necessary for the hours of operation or for the service of alcohol to run from 0800-0030 Mon

-Thurs and 0800-0100 with the pub being allowed to stay open until 01.30. The opening times and such long and late service hours will undoubtedly cause noise disruption for the neighbouring properties causing a public nuisance. With the large beer garden, the outside noise will be very loud, especially with people being able to purchase alcohol until 1am.

When the pub was open previously, there was an increase in crime and disorder due to the very obvious links between alcohol consumption and crime. There was more police activity between the pub and Boyce Way where people utilised the footpath at the end of Boyce Way towards Llanrumney as a means to escape the police. There is already evidence of crime and disorder being worse in the neighbourhood when the pub was open 6 years ago. The pub re-opening will affect that and the licensing hours and opening hours being increased so early in the morning and so late at night will have a significant impact on crime and disorder in the area. This has already been proven. With this increase in crime and disorder, public safety will inevitably be negatively impacted.

From my policing experience, I'm well aware that public houses do not always serve alcohol responsibly & will enable customers who do not know their own limits to become far too intoxicated. Whilst this is against the law, I'm also well aware that licensing checks are not a priority and this will go unmanaged. This will undoubtedly become worse with such long service hours, causing a public nuisance and increasing disorderly behaviour.

The footpath was also used by regular people walking home from the pub late at night. It is a quiet residential street and they were intoxicated and loud. This will inevitably cause a public nuisance which at 11pm at night is tolerable but not at 1.30-2am, especially when there are weekend workers, shift workers and children living on that street and neighbouring properties. It just feels like a stretch too far and completely unnecessary for a pub on a quiet residential estate.

Further to the letter I have received regarding the Unicorn Pub licencing changes. Whilst I am very supportive of the pub to reopen after being closed for several years.

I have several concerns relating to the proposed licencing. I assume you will have a voice to raise concerns on behalf of the community.

My concerns are the extreme opening hours as follows;

- The opening hours of 8am Monday to Saturday;
- Closing Sunday Thursday 12:30am; and
- Closing Friday and Saturday 1:30am.

Surly these opening hours are quite extreme for a community pub, and will cause noise complaints in the future. It is not justifiable for a local pub to open so early and close so late. - 1.1 An application to vary a Premises Licence has been received from TFSLET Limited in respect of Ground Bakery, 15 Pontcanna Street, Cardiff, CF11 9HQ.
- 1.2 The applicant has applied for the following:

"We are primarily a day time coffee house. We occasionally have resident chefs do 3 months at the venue (currently Fri/Sat nights) and we would like to have the flexibility of offering this on other evenings as well".

- (2) The application requests the following:
  - i) The premises may be open to the public during the following hours and for any hours consequential to the non-standard timings:

Monday to Sunday: 08:00 to 22:00 hours

Sunday to Thursday: 08:00 to 17:00 hours Friday and Saturday: 08:00 to 21:30 hours

2.2 A site map showing the premises and a copy of the plan attached to the current Premises Licence can be found in *Appendix A*.

#### 3. Promotion of Licensing Objectives

3.1 The conditions proposed by the applicant to meet the licensing objectives are attached to the report and can be found in *Appendix B* along with a copy of the current licence conditions.

#### 4. Relevant Representations

- 4.1 A representation has been received from Pollution Control. The applicant has agreed that the conditions proposed by Pollution Control should be attached to the licence if granted and the representation has therefore been withdrawn. A copy of the representation, along with the subsequent agreement, can be found attached as *Appendix C*.





  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

This policy will be brought to customers' attention through point of sale material at the checkout wherever alcohol is displayed for sale, including the display of appropriate signage. The only forms of identification recognised are photographic identification cards, such as driving licence or passport, PASS card or military identification card.
- 5. At least 70% of the public space within the licensable area of the premises will be occupied by tables and chairs.
- 6. Patrons will be encouraged by staff to leave quietly and respect the interests of the occupiers of any nearby premises. The designated premises supervisor or a suitable staff member will monitor patrons leaving at the closing time.
- 7. Use of any delineated external area will cease at 21:00hrs daily.



## Please give further details of <u>why</u> you believe this application will have an adverse effect on the licensing objectives

The regular pop-up event nights by Gorse have been cleared by 10pm and therefore in line with the above condition. There have been occasional events, most recently on a Thursday night that did not accord with these conditions. We spoke directly to the applicant about this the following day who agreed it was unacceptable and would contact the event organisers. We appreciate as a regular 'pop up' it must be difficult for the applicant to oversee someone else's event as they are not present, however the conditions are there to respect neighbouring properties, specifically last orders at 9.30pm and customers to have left by 10pm. Having young children and needing to get up early for work Monday to Friday we feel particularly strongly on this point.

It is suggested the outside pavement seating is subject to additional restrictions to be vacated and cleared by 9pm.

The recent struggles of the hospitality industry are well documented and we understand that the applicant wants to make best use of their premises week long yet this needs to be balanced with the needs of the neighbouring properties and their amenity. It is considered that the licensing on Sunday should remain to coincide with the condition 5 of the planning permission ensuring the premises will close at 5pm.

In summary we would propose the following times in order to respect the residential neighbouring properties





  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- 4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the

- 7. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 - Conditions consistent with the operating schedule

- 1. A CCTV system shall be installed to a standard as approved by South Wales Police and maintained and operated, at all times the premises are open to the public. The system will cover all internal areas of the premises (excluding toilets) where the public have access including all entrances and exits and any external areas associated with the premises. The images shall be kept for a minimum of 31 days and shall be produced to a Police employee in a readily playable format immediately upon request when the premises are open and at all other times as soon as reasonably practicable. There will be sufficient trained staff to facilitate the above.
- 2. The premises will operate a Challenge 25 policy. This policy will be brought to the attention of customers by the use of appropriate signage. The only form of identification recognised will be photographic identification cards such as driving licence, passport or proof of age scheme cards.
- 3. Challenge 25 notices will be displayed in prominent positions in the premises.
- 4. All permanent staff will receive the appropriate Challenge 25 training, having completed a minimum of six continuous weeks of employment.
- 5. An incident book shall be kept at the premises and maintained on site, for a period of twelve months. It shall be made available on request to an authorised officer of the local authority or a member of police staff, which will record the following:
  - i) All crimes reported to the venue
  - ii) Any complaints received (of a Criminal or Licensing nature)
  - iii) Any incidents of disorder
  - iv) Any refusal of the sale of alcohol
  - v) Any visit by a representative of a relevant authority or a member of the emergency services.
  - vi) Any failures of the CCTV system.
- 6. At least 70% of the public space within the licensable area of the premises shall be occupied by tables and chairs.
- 7. A Personal Licence Holder will be present at the premises between 20:00 hours and 23:00 hours on Fridays and Saturdays.
- 8. The sale of alcohol will be ancillary to food.

Pollution Control wish to object to the variation of the Premises licence under the Prevention of Public Nuisance Licensing Objective. There are concerns regarding the provisions of regulated entertainment in the form of live music and recorded music, the provision of late-night refreshments and the sale of alcohol for consumption on the premises.

There are concerns regarding the premises opening hours, the hours for the sale of alcohol for consumption on the premises, the provision of late-night refreshments and the provision of regulated entertainment in the form of live music and recorded music. The cumulative impact of these changes can increase the likelihood for noise nuisance from the premises, namely loud music and noise from patrons at the premises during the late evening hours or early morning hours.

The premises is located in close proximity to residential properties with residential properties located above, opposite and to the rear of the premises.

Shared Regulatory Services have received five complaints regarding noise from late night activities at this business:

On 16<sup>th</sup> May 2022, two complaints were received alleging loud music from the premises was playing beyond 0100hrs; the existing premises licence permits the premises to be open to the public until 23.30hrs.

On 26<sup>th</sup> November 2022, a complaint was received alleging loud music and karaoke. Officers working on the Night Time Noise service responded at 0140hrs. Attending Officers confirmed a statutory nuisance. The attending Officers spoke with staff at the premises on this occasion and warned them that the premises was breaching its current licence conditions and potential causing a statutory nuisance due to loud music.

On 11<sup>th</sup> February 2023, loud amplified music was reported at 0125hrs, which was past the licensing hours of 2300hrs.

On 30<sup>th</sup> April 2023, loud music was reported at premises past 0030hrs. Officers working on the Night Time Noise service attended the business at 0050hrs and witnessed loud amplified music with patrons singing and dancing within the premises. Officers discussed the complaint with employees at the business.

Following this, formal warning letters were sent to the business on 30<sup>th</sup> May 2022 advising them of the complaints received by Shared Regulatory Services and of what action the Local Authority could take if further complaints and/or a statutory nuisance from the business is witnessed.

I have contacted the applicant on 12 July 2023 to discuss the application and discuss a change in the proposed hours. It is my understanding the applicant had already reached an agreement with Police Licensing regarding the following amendments:

#### **Opening Hours:**

Sunday to Wednesday 1200hrs – 2330hrs Thursday to Saturday 1200hrs – 0300hrs

#### Supply of alcohol

Sunday to Wednesday 1200hrs – 2300hrs Thursday to Saturday 1200hrs – 0230hrs

#### Last entry to premises

Thursday to Saturday: 0130hrs

Only background music to be played on the premises from 2330hrs until close

Following a further discussion with the applicant, the additional points have been proposed:

**Subject:** FW: Licensing Act 2003: Application to vary a Premises Licence - Corfu by Night,

#### Good Afternoon,

I write further to the above application. The licensing authority wish to raise an objection to the application under the grounds of crime and disorder and the prevention of public nuisance.

It should be noted that the premises does not fall within the cumulative impact policy however the Licensing authority feel this application will have an adverse impact on the licensing objective and there is evidence of existing non compliance with their current premises licence.

Licensing enforcement officers have had cause to visit and discuss complaints of noise and disturbance from the premises with the designated premises supervisor from March 2023 onwards. During a discussion at these visits it was discovered there could have been potential breaches of their licence, advice was given regarding the best practice moving forward to avoid potential enforcement action. Further allegations we submitted from Noise pollution regarding complaints of trading past their permitted hours in May 2023. Subsequent visit with South Wales Police Licensing officers on 10 May 2023 resulted in the viewing of CCTV footage where images of customers being served alcohol and dancing past 01.00hrs could be evidenced. Further viewing of previous dates namely 15 April and 24 April 2023 also showed images of premises breaching licensing conditions. Screen shots of the CCTV footage will follow in a further email.

The applicant has repeatedly shown little regard to upholding the licensing objectives in relation to their current premises licence; serving alcohol past the permitted hours and causing such a disturbance on the premises where complaints have been received. Even after advice was given by Enforcement Officers in March 2023 the premises continued to operate in this way. The Licensing Authority believe that the granting of this variation application will further undermine the licensing objectives and therefore we object to the proposals.
