CABINET RESPONSE TO REPORT OF COMMITTEE RE: 'HOW TO REDUCE CRIME AND DISORDER IN THE NIGHT TIME ECONOMY IN A TIME OF AUSTERITY'

Purpose of Report

1. The purpose of this report is to provide Members with an overview of the Cabinet response to the recommendations from this Committee's scrutiny of 'How to Reduce Crime and Disorder in the Night Time Economy in a Time of Austerity'.

Background

- 2. At its meeting of 16 September 2015, the Community and Adult Services Scrutiny Committee agreed a Task & Finish group to investigate how to reduce crime and disorder in the Night Time Economy in a time of austerity. The suggestion of a Night Time Economy Crime and Disorder scrutiny was made by South Wales Police, who specifically asked for scrutiny focusing on how, in times of austerity, partners can work together to ensure a sustainable operating model for managing the night time economy and major events, as well as scrutiny of licensing hearings.
- 3. The Committee agreed the following Terms of Reference for the task group:
 - To take a solution focused approach to identifying how best to reduce crime and disorder in the Night Time Economy (NTE) in Cardiff in a time of reducing public and third sector resources, including:

- Exploring the role of licensing, Business Improvement Districts (BID), Late Night Levy, taxi marshalls, street pastors and Alcohol Treatment Centres;
- Exploring partnership working and resource allocation
 associated with managing the Night Time Economy in Cardiff.
- To gather stakeholders' views with regard to the above, including statutory partners, city centre business representatives, third sector organisations representatives and relevant Cabinet Members and Cardiff Council officers.
- To explore relevant best practice in external organisations and other local authorities, that is transferable to Cardiff, including the work of the South Wales Police and Crime Commissioner's Violent Crime Reduction team.
- To make evidence based recommendations to improve the reduction of crime and disorder in the Night Time Economy in Cardiff in a time of austerity.

- 7. Members invited written submissions and received responses from the following:

- 8. The task group also received evidence from desk based research looking at approaches taken elsewhere in the U.K. with regard to tackling crime and disorder in the Night Time Economy, including Business Improvement Districts, Late Night Levy and Local Alcohol Action Areas. Members also used the Welsh Government draft 'Framework for Managing the Night Time Economy in Wales' to identify areas to explore with witnesses and via desk based research.

9. Evidence from all of the above was used to identify suitable findings and recommendations from the Inquiry. The Inquiry Report was agreed at Committee on 2 March 2016 and was presented to Cabinet on 21 March 2016. The full Inquiry report and research report are available at:

Cabinet Response to Recommendations

- 10. Overall, the Committee made fifteen recommendations to the Cabinet.
- 11. The Cabinet agreed their response at their meeting 27 July 2016. The full response is attached at **Appendix A** and shows that:
 - 12 of the recommendations are accepted R1, R2, R3, R4, R7, R8,
 R9, R10, R12, R13, R14, R15.
 - o 3 are partially accepted R5, R6, R11.
 - o 0 are not accepted.

12. Councillor Daniel De'Ath, Cabinet Member (Skills, Safety, Engagement and Democracy) and Neil Hanratty (Director of Economic Development and Commercial Services) have been invited to present the Cabinet Response and answer Members' questions on this.

Legal Implications

implemented with or without any modifications. Any report with recommendations for decision that goes to Cabinet/Council will set out any legal implications arising from those recommendations. All decisions taken by or on behalf of the Council must (a) be within the legal powers of the Council; (b) comply with any procedural requirement imposed by law; (c) be within the powers of the body or person exercising powers on behalf of the Council; (d) be undertaken in accordance with the procedural requirements imposed by the Council e.g. Scrutiny Procedure Rules; (e) be fully and properly informed; (f) be properly motivated; (g) be taken having regard to the Council's fiduciary duty to its taxpayers; and (h) be reasonable and proper in all the circumstances.
