1. Application

1.1 An application for a Premises Licence - Grant, has been received from Mr Bakshish Singh in respect of 46 Tudor Street, Riverside, Cardiff, CF11 6AD.

1.2 The applicant has applied for the following:

(1) In respect of the following licensable activities:

1. The supply of alcohol for consumption off the premises

(2) Description of Premises (as stated by applicant):

“A shop which is a single floored premise on the ground floor”.

(3) Unless otherwise indicated the premises may be open to the public during the following hours and for any hours consequential to the non standard timings:

Monday to Sunday: 07:00 to 23:00

(4) To provide licensable activities during the following hours:

1. The supply of alcohol for consumption off the premises

Monday to Sunday: 07:00 to 23:00

2. Promotion of Licensing Objectives.

Dear Mr Singh,

I have caused enquiries to be made into this application and make the following representation that I wish to be considered when deciding on the licensable activity and conditions for this licence.

We therefore ask that the Licensing Committee hear the representation made by the police when determining the grant of this application.

Should the applicants agree to comply with the representation made to meet the Licensing Objectives before a hearing is held then please accept that the police will automatically withdraw their request for a hearing with the Licensing Committee.

POLICE REPRESENTATION

Hours open to the public and permitted hours to be amended to the following;

08:00-23:00 Mon-Sat

08:00-22:30 Sun

1. A CCTV system shall be installed to an agreed standard as approved by South Wales Police and it shall be maintained and operated at all times when the premises are open to the public. The system will cover all areas of the premises where the public have access (excluding toilets) including all entrances and exits. It will cover the external front of the premises on Tudor St and Beauchamp St. The images will be kept for a minimum period of 31 days. The images will be produced to a police employee or other responsible authority representative, in a readily playable format, immediately upon request when the premises are open to the public and at all other times as soon as reasonably practicable, subject to data protection legislation. There will be sufficient trained staff to facilitate the above. Signs will be prominently displayed, advising customers that CCTV is in operation at the premises.

OFFICIAL

2. An incident log will be maintained at the premises. Each entry made shall carry the day, date and time that each report was made; it will record the following;

- A. All incidents of crime or disorder known to staff.
- B. All refusals of sale to patrons, with details of the individual(s) if known.
- C. All visits by a responsible authority or emergency service.

The DPS shall ensure that all incidents are logged on the day of the incident.

The log will be made available to the police or other responsible authority on request. The log shall be retained for a minimum of 12 months.

3. Displays of spirits will be kept out of reach of the public. Spirits will only be accessible to patrons at the time of purchase.

4. The DPS will operate policies relating to restrictions on entry policy as well as child admission to the premise. The policy will be in the form of a written document which will be made available to a member of any responsible authority upon request.

5. There will be an electronic till-prompt system which alerts staff to the need to confirm the age of the customer prior to making sales of alcohol.

6. Relevant staff will receive comprehensive training in relation to age-restricted products, in particular the sale of alcohol. No member of staff will be permitted to sell age-restricted products until such time as they have completed the aforementioned training. This training will be repeated yearly. The DPS will keep records of staff training for a period of three years.


7. Signage will be displayed at each exit point requesting that customers leave the premise, and immediate vicinity, after service in an orderly fashion, so as not to cause nuisance to nearby residences or businesses.

If the applicant does not agree with the afore-mentioned representations, the police objections will be based on the following Licensing Objective;

- 1. The prevention of crime and disorder.
- 2. The prevention of Public Nuisance.
- 3. Protection of Children from Harm.

Additional evidence to support the notice of objection will be presented at any subsequent Licensing Committee hearing. This evidence will be expanded on verbally, written, statistical or CCTV evidence.

We act for the above named gentleman in relation to his legal affairs.

The purpose of this letter is to advise you that our client, Mr Ilan Ud Din, objects to the proposed grant of a license to enable Mr Bakshish Singh to sell alcohol for consumption off the premises.

Our client, Mr Ilam Ud Din, has owned and operated a supermarket called "Eight Til Late" at 58-60 Tudor Street since 1981. The business is established, and our client has an intimate knowledge of the area and the Community he serves.

The reasons our client has for objecting to the proposed license are fourfold, namely:-

1. **The prevention of crime and disorder**

As you will be aware, our client holds a license to enable him to sell alcohol for consumption off the premises. As such, he is well aware of the needs of the Community and, in his view, the area is well served by licenses for the retail sale of alcohol off the premises and, in our client's view, the grant of another license will saturate the area, and lead to drunk and disorderly conduct, and an increase in crime.

Moreover, it is likely that individuals will consume alcohol in the street, which will lead to disorderly conduct, and an increase in public nuisance complaints.

Disorderly conduct and rowdy individuals, caused through the consumption of alcohol, will invariably lead the local population to have concerns about their safety.

The Riverside area of Cardiff is known for issues arising from social delinquency, drug dealing and prostitution. The local community already suffer as a consequence of these problems, and those arising from the dispossessed, who often suffer degrees of alcohol addiction, drug and substance addiction and mental health problems.

Street crime in the area is likely to be exacerbated by the prevalence of a further outlet which will provide alcohol, which invariably will be abused by the aforementioned groups.

It is not unusual for my staff and I (who are mainly female) to be harassed and abused by people who are drunk, or clearly under the influence of narcotics.

An alcohol license only six doors away from our client's supermarket will only increase alcohol abuse in the area.

The law prohibits our client and his staff from serving an individual who is visibly drunk. However, whenever an individual is refused the purchase of alcohol, substantial conflict can arise, and we are advised that, in the past, there have been occasions when the police have been called.

Our client is of the view that the granting of another license will just exacerbate these problems.

The police have put a great deal of resource and effort into the Riverside Community, and we are advised that, as a result, the area has improved substantially. However, the grant of an alcohol license would be a retrograde step, and will invariably lead to an increase in crime within the area, caused through alcohol abuse.

2. **The prevention of public nuisance**

Tudor Street and Tudor Road are major thoroughfares, leading to and from Cardiff City Centre. It is therefore not appropriate to allow the area to decline by establishing another outlet to provide the transient Community with the opportunity to purchase and then abuse alcohol, which will invariably cause a public nuisance, not only to the resident community, but to such individuals who are passing through the area.

3. **Public safety**

The granting of additional alcohol license will clearly create very real problems for public safety.

Individuals who abuse alcohol tend to congregate in the streets, and will be perceived by the local community as a threat to their public safety, particularly late at night, when it is dark.

4. **The protection of children from harm**

The consumption of alcohol by an individual within a family has a profound impact on family dynamics; and our client, together with other resident shopkeepers in the area, are aware that there are several families who have alcohol related problems. The provision of a further opportunity to acquire alcohol, by the provision of an additional license, will not only cause harm to the individuals concerned, but also to the children within the family, who will invariably be the subject of abuse of one sort or another.

Accordingly, our client strongly opposes the grant of an additional license to sell alcohol in Tudor Street, for the reasons set out above.

The provision of additional alcohol will be disastrous for the local community, and will increase pressure on our client's staff and the police.

We would respectfully request that you take into account these above observations when considering the application for a premises license under Section 17 of the Licensing Act 2003.



1. The prevention of Crime and Disorder

- a. This area of riverside is well known for its history of drug dealers, prostitution and drug addicts. Crack, Heroin, Cocaine, khat (Catha Edulis) and Marijuana/skunk use are the reasons for the regular attendance by the police, ambulance and fire services.

The addition of another outlet being allowed to sell alcohol in later hours could only impact further on a community that already suffers the consequences of ghettoisation of the dispossessed, who by degrees suffer from drug, alcohol or substance addiction and misuse: Some in recovery, some not. Street crime in the area; it is suggested, exacerbated by the prevalence of the aforementioned substance abuse problems.

- b. The police and cpo's have made a fantastic effort to maintain and clear the problems caused by addicts (both alcohol and drugs users) on Fitzhalmon Embankment/ corner of Wood Street, it is our feeling that the granting of a licence would simply be a retrograde step and lead to the re-establishment of this drinking/drug taking spot.

2. The Prevention of Public Nuisance

- a. Further to the point b. There is a huge scope for the possibility of public nuisance. Wood St, Tudor St and Tudor rd are major thoroughfare from the town centre; leading to suburban areas such as Plantagenet St , Dispenser Gardens, Dispenser St, Dispenser Pl, Clare St, Clare Gardens, Havana St, Allensback/Taff Embankment, Beauchamp St, Neville St, De Burgh St, Lower Cathedral Rd, few of which appear to have been canvassed for opinion at the present moment. As residents, employers, workers and also the local community establishments plus Rehabilitation centres, we reasonably fear the granting of an additional off-licence would be a retrograde step and have a deleterious effect on the local family orientated community.

3. Public Safety.

- a. It is not simply a matter of another Off-licence as the applicant would undoubtedly have you believe but will be a source; given the areas background and history, for further incidences of public nuisance and threats to public safety.

4. The Protection of Children From Harm:

- a. It is clear that the consumption of alcohol has a deep impact on a given family dynamic. There would be, it appears to us as local shopkeepers, that have several families and partnerships in our community that have alcohol related problems. It is suggested that another off-licence would further undesirable effect on these already troubled families/relationships.

In conclusion we would strongly oppose the granting of an additional Off-licence on Tudor Street for the above reasons.

The biggest concern that have been brought forward from residents are noise pollution, drunken disorderly behaviour, attracting the wrong type of crowds into this very residential area with so many children living around here and it is not the style of living that anybody would want to portray for their children .

Another outlet with the sale time that has been proposed leads to believe that a cut price Off-licence may be implemented and this could lead to the sale price of alcohol to fall in the area. The resident and CPOs of the area believe that Riverside and Grangetown already have more than adequate supply of Off-licences.
