# **Update to the Recycling & Waste Management Strategy**

Officers welcomed the opportunity to present further detail for the recycling and Waste management strategy in May and note that the Committee wish to hear about the plans to increase commercial recycling potential.

In relation to the specific question on the staff costs for the glass pilot, these costs will be approximately £13,300 per month for the duration of the pilot. These costs will be off set by the reduced processing costs for the glass. It currently costs us to progress the glass for recycling but once collected separately, the Council will receive an income for the sold glass.

With regards to the consideration for flexibility and ward based solutions, the project team will take these comments on board and investigate how this can be applied during the pilot phase.

Your comments on detailed consultation and local member engagement are noted and will be feed into our consultation proposals.
