On behalf of the Committee I would like to thank you for attending the Children and Young People Scrutiny Committee on 10 October 2017 to provide an opening statement and answering questions on **Developing the Education Estate in Cardiff – draft Cabinet Report**

I would also like to thank Nick Batchelar, Director of Education and Lifelong Learning and Janine Nightingale, Head of Schools Organisation, Access & Planning, for the report and answers to Members questions. Members really welcomed the opportunity to scrutinise this issue at such an early stage.

- That the Committee is provided with the pupil data modelling used to predict demand up to and beyond 2026 when proposals are being proposed;
- That the maintenance of the Education Estate is appropriately featured in the development and funding proposals;
- That the proposals provide appropriate capacity for future Welsh Language demand and sufficient ALN demand to minimise the number of pupils being placed out of county.
- That an additional report should be presented to this Committee and Cabinet should the Mutual Investment Model be used to fund any proposals for the development of the Education Estate.

I hope that these comments will be of use and support in the future development of the Education Estate in Cardiff, and the Committee looks forward to working with the Directorate and Cabinet in the development of the School Estate to ensure that it provides a 21st Century learning environment for all Pupils.
