CYP Scrutiny 9 April - School Organisation Proposals

Thank you for your letter of 16 April 2019 in respect of the verbal briefing provided to the Children and Young People Scrutiny Committee on new school provision to serve parts of Creigiau/St Fagans, Radyr/Morganstown and Fairwater.

The Council will commence a full consultation shortly on the first of the new schools serving Plasdwr, which is an innovative variation on the traditional dual-stream primary school provision with a greater focus on Welsh teaching within the English medium stream.

It is intended that this new school would ensure that families who wish for their child to be educated in the medium of Welsh are able to do so, whilst providing a new and exciting opportunity in how the Welsh language is taught to pupils in an English-medium setting, facilitating progression along the linguistic continuum.

The consultation will run for a minimum of 6 weeks, inviting views from a range of stakeholders. Parents, staff and governors at the schools affected would be consulted, and the public, local residents, local businesses and others who have an interest in the community would also have an opportunity to have their say on proposals.
