

Local Health Board Comparison

Since the introduction of the City Centre CIP there has been a reduction in the number of recorded incidents of patients reporting the Emergency Unit or Alcohol Treatment Centre as a result of alcohol related activities* . The total reports were 151 in 2018, 162 in 2017, this compared to 230 in 2013 and 226 in 2014 which were considered when the policy was introduced.

The top four reported locations continue to be 'City Centre', Queen Street, St Mary Street and Greyfriars Road.

The reports from within/outside or near specific late opening fast food restaurants and premises licensed to sell alcohol are shown below. There has been a 69% reduction in reports from fast food restaurants between 2018 and 2014, and a 106% reduction from alcohol licensed premises.
