Thank you for your letter dated 25th September regarding the 'Affordable Funeral Strategy' and observations made by Members. Thank you also for your congratulatory comments concerning the staff at Bereavement Services, this is much welcomed and appreciated.

You have requested information on the type of plan or scheme that the Council is looking to deliver in relation to funeral plans or bonds. Whilst the strategy has identified a need for the Council to explore what options exist, this is very much at the early stage of recognising this need and it forms part of an action plan in the strategy. However a lot more investigation is required to provide you with the information you have requested. I will be happy to report further as this is developed and the Bereavement team has had opportunity to explore this fully.

Bereavement Services have long provided pre-need advice delivered by staff who are knowledgeable, experienced and trained on the services provided by Bereavement Services. It is not intended that Bereavement Services staff will offer a 'counselling' service as those seeking 'counselling' will be signposted to third sector groups who are trained and specialised to provide this service. Bereavement Services staff will be providing advice and guidance on all aspects of burial and cremation services and pre-need information such as funeral planning. Please be assured that the team at Bereavement Services are very competent in providing this type of information and advice already and any further training deemed necessary will be provided.
