#### 1. What are the objectives of the Policy/Strategy/Project/ Procedure/ Service/Function?

The proposal concerns a disposal of land concerning Maindy Park.

It should be noted that Council is a sole corporate trustee of Maindy Park and function is carried out in its capacity as a charitable trustee, and in its capacity as a local authority. The Maindy Park Advisory Committee has been established to consider the proposal and provide an independent recommendation to Cabinet, acting as Trustee, who will make a final decision at a subsequent meeting. This is intended to manage conflicts of interest between the Council's trustee and local authority functions.

The Council, as local authority had offered land in exchange for the Trust land and has put forward two parcels as options – one at Blackweir Fields and the other at Cae Delyn Park.

# 2. Please provide background information on the Policy/Strategy/Project/Procedure/Service/Function and any research done [e.g. service users data against demographic statistics, similar EIAs done etc.]

By way of background, the Council in its capacity as Local Education Authority have a requirement to expand and replace the existing Cathays High School as part of the 21<sup>st</sup> Century Schools Programme. Land supply in the area is minimal to support the construction of a High School.

The land opposite the existing school extends to approximately 11.8 acres and is held in Trust. The Council have offered an exchange parcel of land to be put in Trust at either at Blackweir Fields or Cae Delyn Park as replacement land. Following the second Advisory Committee held on 17 November 2022, and at that meeting, the Advisory Committee disregarded Blackweir as being unsuitable, and so for the purposes of the land swap, the revised consultation held between 16<sup>th</sup> December 2022 and 9 January 2023 was for the purposes of considering Cae Delyn Park only.

Maindy Park Trust was gifted to the Council on trust in 1922 and the charity was registered with the Charity Commission in 1966.

The covenant on the title relates to the use of the land for the purpose of a park, open space, recreation and playground for the benefit of the people of Cardiff.

The land in question is open to the public and has since 1958 been the site of an outdoor velodrome. The site also has a play area and tennis courts and former Bowling Club (now closed) which is currently managed by the Council.

The land proposed to be exchanged from the Trust totals 6.89 acres and includes part of the velodrome area, an area containing 2 bowling greens, part tennis courts and part of the existing car park facility. As part of a separate project, the proposal is to build a replacement and more modern velodrome in the Bay area which is subject to a range of business cases to be brought forward this year. At the second committee meeting, advisers were asked to

consider the effects of the design of the proposed velodrome on the protected characteristics and the impact on equality.

The proposed land to be taken out of the Trust is currently open to the public although subject a public concession arrangement and lease to Greenwich Leisure Limited (GLL). The effect of the lease is that GLL are responsible for the repair and maintenance of the whole area and to undertake all statutory functions associated with the area.

A Health and Safety inspection of the site was undertaken prior to the first committee meeting and shows that the footways and paths are paved or covered with tarmacadam and are deemed to be in good condition. Generally, the area is accessible to all and is well lit with several access and egress points. This report has been updated to reflect the amendment in the land proposed for exchange and is attached as Appendix 1.

Sections of the original land have previously been removed from the trust and acquired by the Council for highway and education uses. This includes the construction of Crown Way and expansion of the school yard at Cathays High School in which is located directly opposite the land in question.

The proposed exchange of land, if approved by the Trustee, is subject to further approval being granted by the Charity Commission prior to implementation.

Cae Delyn Park is suggested as replacement land for the charity and is open to the public to provide an area of recreation in accordance with the Trust's proposed use. The updated Health and Safety Risk Assessment outlines further detail with regards to Cae Delyn.

Approximately 4.91 acres of the Trust land will remain within the Trust and the area adjoining Maindy Road will be subject to an upgrade of the public open space, which will be designed in consultation with members of the community to ensure an upgraded play area is provided and other suitable outdoor facilities.

# Please give details/consequences of the differential impact, and provide supporting evidence, if any.

#### Age – Up to 18 years.

The proposal could have both a positive and negative impact on this age group. The Velodrome is currently used by all ages but in particular for teaching young children and teenagers to cycle through various clubs and competitions. Although the area is managed through the GLL lease on the Maindy Leisure Centre which includes the velodrome and the cycling is a paid activity or through club membership, the general area around the velodrome is open to children of all ages.

Bookings for the velodrome currently amount to approximately 15 hours per week for this age group and various club activities with approximately 1000 under 18's accessing the facility per week.

The proposal of a new up to date velodrome (built as part of the sports village) will have a positive impact as it will be fit for purpose. Concerns were raised at the initial committee meeting around the design and attached as Appendix 2 are correspondence from various cycling groups who have offered commentary on the proposed facility.

A small BMX ramp/parks type area has been constructed to the side to encourage children to use the area with their bikes. This is for ad hoc use and there is no need to book.

However, the proposal of a new velodrome could also have a negative impact for younger local users as they may not be able to access the new site due to the distance from their vicinity.

The site and facilities (play area, tennis courts and former bowling club) are also used by local youths from this age group. There are no usage figures, but the tennis courts are not booked and are generally used for informal football.

The land in and around the velodrome is subject to a footway which is a regular walking area to cut through from the Cathays area to North Road and this is potentially used by students and this age group in particular.

In addition, the cycling is not only for youngsters but for the adult training and it regularly used for competitions including triathlon. From the booking spreadsheet supplied by GLL, approximately 11 hours a week is dedicated to students and adults for training and attended by approximately 400 adults on a weekly basis.

The area is used by walkers from the nearby area and the playground is visited regularly by young families.

The former bowling greens have been closed for a number of years due to the lack of support and club and one of the areas has been used by Cathays High School as additional car parking for staff.

#### Over 65 years

The existing Trust area includes part of the velodrome area and the two (now closed) bowling greens. Around the perimeter of the velodrome is a footpath which is regularly used by members of the public.

### What action(s) can you take to address the differential impact?

The velodrome is proposed to be replaced with a more modern facility at the International Sports Village. It is anticipated that this facility which has been designed in consultation with local clubs and cycling experts, to be open in early 2025. The Council have provided an undertaking that there will be a smooth transition from one cycling facility to the other, with no downtime where there is no velodrome open in Cardiff.

The proposal could have both positive and negative impacts

The proposed land to be taken from the Trust, will have a negative impact on disabled people as it will be fenced off for another use and as such will not be accessible. Potentially the distance to the exchanged land could prove difficult for those with visual, physical or mobility impairments who wish to access it.

The remaining land in the Trust's ownership at Maindy Park Trust is intended be improved as part of the wider project which will be accessible and inclusive to people of all abilities and those who are disabled and as such will have a positive impact.

#### What action(s) can you take to address the differential impact?

It is proposed that the remaining land in the Trust on Maindy Road will be regenerated and the area will provide a much more accessible public open space, constructed to modern requirements and fully compliant with all disability statutory requirements in keeping with the Trust's objectives.

The Council are offering to replace the equivalent Trust land displaced to land at Cae Delyn Park – this land is approximately 3.27 km (or 2 miles) to the north and is also an area of open space.

The updated Health and Safety report attached covers the land at Cae Delyn Park.

All those involved in the proposal will ensure that accessibility and inclusivity is considered at every stage. All involved will also ensure Welsh Government laws on disability are adhered to.

#### 4. Consultation and Engagement

What arrangements have been made to consult/engage with the various Equalities Groups?

The proposals to dispose of land from the Trust has been advertised via a Public Notice in the Western Mail on the 20<sup>th</sup> May 2022. The purpose of this was to engage and consult with a wide audience on the proposals.

In all, 242 responses were received to the advertisement, and a public meeting was held and the Council responded to many FOI queries and direct queries to Council officials and ward members.

In terms of the relocation of the velodrome to the International Sports Village, a consultation was undertaken prior to the Pre-Application Consultation (PAC) being issued in September 2021 as part of the hybrid application for planning. In addition, a consultation report was taken to the Council's Cabinet in March 2022. It should be noted that the provision of a velodrome at Maindy Park is not a specific objective of the Trust.

Following a revised plan of the land to be exchanged from the Trust, a second consultation was undertaken between 16<sup>th</sup> December 2022 and 9 January 2023. 785 responses were received via the Council's website. A separate report providing a summary of the consultation responses has been prepared and is attached as Appendix 3.

#### **Ref: International Sports Village Velodrome- Cardiff**

With regards to my capacity as the Head Coach and Secretary of the above velodrome I have the following observations over the usage of our facility.

Newcastle Velodrome is 400m per lap and the bankings are 29.4 degrees at its steepest. The tracks surface is tarmacadam and was last re-surfaced in 2004. The track has been in existence since 1956 and has been used for racing and training every year since this time.

The velodrome is used primary for use for riders on fixed wheels bike throughout the year however on Fridays throughout the summer riders of all ages ride the track on road, box and mountain bikes as part of our freewheelers night. The youngest riders that have ridden the track on small road/bmx bikes are 5 years of age. The sessions consist of structured training for the younger riders and at the end of the night they take part in races as part of our Freewheelers League.

Regularly through the summer we also rent out the velodrome to time trial riders who use the track to test wheels, clothing and other equipment as the traffic free environment is beneficial to getting accurate readings. Riders this year have included Dan Bigham who recently broke the Hour Record. The bikes used by these riders are time trial bikes with long 175 cranks and I have never had any feedback from them that they touched the bankings at its steepest with their pedals. Only comments have been extremely positive.

I can say that a velodrome of this steepness is perfectly fine to ride road bikes of any description as I have detailed above.

I understand that there are proposals to build a new velodrome in Cardiff. I can say that if we had such an opportunity in our area we would embrace it with open arms. Even though we have a long history at our velodrome we are in need of upgrades of the surface and facility which on looking at the Cardiff proposals we could only dream of. The people of Cardiff would be very lucky if such a facility is built.

#### NEW OUTDOOR VELODROME, WALES NATIONAL CENTRE FOR SPORT

In reference to the above project it is the intention that the forthcoming Velodrome Design Guidance notes will include the following paragraph:

"For community coaching and recreation use, a standard road bike with gears, a freewheel and brakes may be used on tracks with a maximum gradient of 30 degrees however it is suggested that this is under supervision and / or appropriate risk assessments are in place."

Technically I can see no reason that if the above suggestions are followed that a standard road bike could not be used on the proposed outdoor velodrome in Cardiff with a maximum gradient of 28 degrees.

I have also discussed this with British Cycling and they concur with the above.

I trust this is suitable for your requirements at this time, but should you have any queries or require any further information, please let me know.

#### Re. Proposed Velodrome at Cardiff International Sports Village

As National Governing Body for cycle sport in Wales, we are keen to ensure facilities are fit for purpose and appropriate for the promotion of training and competition activities.

Regarding technical specifications, we defer to advice provided by British Cycling (National Governing Body for cycle sport across the UK), who in turn are advised by their technical consultants (Abacus CM) on cycle facility design.

We understand that the design of the proposed Velodrome at Cardiff International Sports Village has considered both the age of participant able to cycle on the facility, and the types of cycle which may be used (fixed or freewheel). Both are important considerations given the Velodrome replaces the current facility at Maindy in the North of Cardiff.

We also stress the importance of the closed road circuit within the International Sports Village concept. This will significantly enhance opportunities for both young and old participants, and people with disabilities together with many other active recreational groups and fellow governing bodies for sport.
