## APPLICATIONS GRANTED

22/02280/FUL – WHITCHURCH AND TONGWYNLAIS WHITCHURCH HOSPITAL, PARK ROAD

Temporary construction access route to the site of the approved Velindre Cancer Centre. The north-south connecting section is then proposed to be converted to provide a revised emergency access for approved Velindre Cancer Centre.

That planning permission be **GRANTED** subject to the Local Planning Authority receiving a confirmation letter from the Welsh Ministers that the decision has not been called in, and authorises the Local Planning Authority to grant planning permission pursuant to its Direction dated 12<sup>th</sup> January 2023 made under Article 18 of the Town and Country Planning (Development Management Procedure)(Wales) Order 2012

'All vehicular use of the temporary road hereby approved shall cases by no later than 30 November 2026, and thereafter by no later than 30 January 2027 (or prior to the first beneficial use of the new Cancer Care Hospital whichever comes first) the width of the road shall have been reduced and remaining land restored/landscaped in accordance with the approved Landscape plan reference 70066877-WSP-EV-DR-LA-P1-5101 REV PO1 and the general arrangement/ details approved under condition 3. The access shall thereafter be retained in its approved form.
