SOP Task & Finish Group

- 4. The SOP Task & Finish Group was established as a rolling Group to consider a number of School Organisation Planning proposals coming forward during 2022/23. Since the last report, the Task & Finish Group has met with the Cabinet Member and Senior Officers on the following occasions and submitted reports to CYPSC accordingly:
 - **January 2023 –** SOP Annual Report
 - March 2023 School Admission Arrangements and Coordinated Secondary School Admission Arrangements 2024/2025; and School Organisation Planning: Primary School Places to Serve Cathays and Parts of Gabalfa, Heath, Llandaff North and Plasnewydd

EOTAS Inquiry Task & Finish Group

- 5. At the Committee's work programming forum in July 2022, the Committee agreed to undertake an in-depth Inquiry on Young People who are educated other than at School (EOTAS) and what factors could lead to them becoming vulnerable to criminal exploitation during the next 12 18 months.
- 6. Members of this Task Group are:

 - Karen Dell'Armi (volunteer co-optee)
- 7. The Group met on the 31 January 2023 where they considered the scope for the Inquiry. It was agreed that a literature review be undertaken on this issue, and this is underway. As the Scrutiny Officer has been undertaking work in relation to the Replacement Local Development Plan (RLDP) Task Group, the Chair of this

Committee agreed that the work of this Group recommence in September 2023, once the RLDP work has been completed.

RLDP Task & Finish Group

- 8. The RLDP will help shape Cardiff for the next 15 years to 2036, ensuring the right development happens in the right place at the right time, benefitting communities and the economy and setting out which areas need to be protected. The Plan is a high-level policy document which impacts on all 5 Scrutiny Committee's Terms of Reference. It will also be the final Plan produced by Cardiff Council.
- 9. The next stage of the RLDP will commence with a consultation on the preferred strategic options. This is currently programmed for July 2023. Scrutiny Chairs agreed that the most effective way to scrutinise this stage of the RLDP would be via a joint Group including all Scrutiny Chairs and 1-2 additional Members from each individual scrutiny committees in this case, Councillors Boes and Ahmed.
- 10. The next meeting of the RLDP Group will take place on Friday 7th July 2023, and an update will be reported to this meeting in September.

CYPSC - Informal Business

- 11. Due to the volume of items coming forward for the CYPSC Work Programme, sometimes the Chair will advise the Scrutiny Officer to send reports informally to Committee Members to invite their comments, views, observations and queries. These responses are collated and detailed in an output letter to the relevant Cabinet Member. The Chair agreed the following to be sent via this method.
 - Cardiff Childcare Sufficiency Assessment 2022-2027 CYPSC Members received this report with Committee papers at the January 2023 meeting of this scrutiny committee.

 Children's Service Quarter 3 Performance 2022/23 – this was distributed to CYPSC Members via email for comments on the 26 April 2023. Q4 performance will be considered at this meeting, elsewhere on the agenda.

CYPSC Work Programme 2023/24
