## SCHOOL ORGANISATION PLANNING - REPORT OF THE SOP TASK \& FINISH GROUP

## Purpose of the Report

1. To provide Members with the output of discussions between the School Organisation Planning (SOP) Task \& Finish Group and SOP Team at its meeting on the 27 June 2023 in relation to the following proposal:

- School Organisation Proposals: Provision for Children and Young People with Additional Learning Needs (ALN)

These proposals will be considered by Cabinet on the 13 July 2023.
2. Members of this Scrutiny Committee are requested to note the comments and observations made by the Task \& Finish Group (set out in paragraphs 8-11 of this report), and these be submitted as a letter to the Cabinet Member ahead of the Cabinet meeting on the 13 July 2023.

## Background to the Proposals

3. Cardiff has a range of in-county provision delivering specialist places in special schools, specialist resource bases and wellbeing classes that operate as part of mainstream schools, a Pupil Referral Unit, and Community Teaching provision.
4. Band B of the Sustainable Communities for Learning Investment Programme (Band B), formerly the $21^{\text {st }}$ Century Schools Programme, includes key Additional Learning Needs projects across Cardiff. These projects, combined with other Council and/or Welsh Government funded projects will enable a phased increase in Cardiff's designated specialist placements.
5. The key recommendation of the report is requesting that the Cabinet authorise officers consult on the proposals to increase the number of places for learners with Emotional Health and Wellbeing Needs and the number of places for learners with Complex Learning Needs.

## SOP Task \& Finish Group Meeting - 27 June 2023

6. The SOP Task \& Finish Group met on the 27 June 2023 to consider the proposals in detail.
7. At the Task Group meeting, Members were joined by the following witnesses:

- Richard Portas, Director of School Organisation Planning
- Brett Andrewartha, School Organisation Planning Manager


## School Organisation Planning Task \& Finish Group Observations

8. The Task \& Finish Group made the following observations at the meeting on the 27 June 2023. Members are requested to note the following. There will be an opportunity for Members of the Task \& Finish Group to briefly give an overview/update of the meeting, if required. The following will be drafted into a letter to the Cabinet Member following this meeting. Comments and observations are as follows:
9. Members of the Task Group considered the content of the Cabinet report and its appendices with officers. They discussed issues relating to:

- Overall proposals contained in the report and any changes since the previous report on this issue ${ }^{1}$
- Ensuring future proofing of any individual proposals (when they arise) including projections for demand and capacity
- Financial-related issues and challenges - cost projections; robust monitoring processes; revenue and capital funding; income sources
- Specialist Resource Bases (SRBs)
- Pupil Referral Units (PRUs)
- Land matters
- Staffing
- Timelines and scrutiny's input into the process as further details emerge.
10.T\&F Members were satisfied with the content of the Cabinet report and its appendices and therefore recommend that CYPSC commend the report to Cabinet for consideration.

11. The Task \& Finish Group also wanted to assure this Committee that agreement has already been reached that, as finer details of ALN proposals emerge, they will be submitted (via a number of reports following consultations on smaller, individual proposals) to a formal meeting of the Children \& Young People Scrutiny Committee. This will ensure that Members have the opportunity to consider proposals in detail and in a manageable way. This will be added to the Committee's work programme, as appropriate.
