CARDIFF INFLUENCERS – BRIEFING REPORT

Purpose of the Report

1. For Members to receive a brief overview of this Agenda Item ahead of this meeting where Members will receive a briefing from the Cardiff Influencers.

Background

2. The Chair of this Scrutiny Committee was approached by a group of young people who are working together as part of the development of the School Organisation Planning (SOP) Strategy. This group are the Cardiff Influencers.

Issues

- 3. The group were keen to come and speak to Members about the work they have been doing and make a presentation on their progress to date. The group are extremely interested in local democracy and the inclusion of the voice of young people in developing policies and strategies that affect them. Members of the group are, in the main, 13–14-year-olds, in Year 9 of secondary school. Having met most of the group, the Chair reported that they are extremely knowledgeable and engaging.
