11	<p><b><u>QUESTION TO COUNTY COUNCILLOR WILD (CLIMATE CHANGE PORTFOLIO)</u></b></p> <p><b><u>QUESTION FROM COUNTY COUNCILLOR WILLIAMS</u></b></p> <p>Recent criminal convictions following a corruption scandal at Cardiff Council have engulfed the Administration. The Council have committed to undertaking a review of the systems and processes in place at the Waste Department. Huw Thomas said in a recent letter that waste “managers have his full confidence”. That surely rules him out from being involved in the appointment on who investigates and undertakes this internal review. Any council employee would know what the Leader’s view was before any investigation &amp; review had even begun. For this reason, along with the scale of corruption at the Council, any review should be an external one. Therefore to restore public trust and confidence in the Waste Department, would the Cabinet Member agree with me, an external review is necessary, with a sufficiently broad Terms of Reference, to empower the individual undertaking the review to follow the evidence and report on their Findings in an independent and impartial manner?</p>
