CARDIFF RECYCLING STRATEGY: UPDATE

Purpose of the Report

1. To provide Members with an informal update in relation to progress and issues in relation to the roll out of the Recycling Strategy for Cardiff.

Background

- 2. The Recycling Strategy for Cardiff 2021-25 was considered by this committee prior to Cabinet and Council in September 2022.¹
- 3. The Assistant Director Street Scene Waste provided an update in relation to the roll out of the Strategy in March 2023²

- 5. A Cabinet report providing an update and the proposed next steps was scheduled in November, however this was deferred due to industrial action that ran between 25th September 28th November. 2023, the report was due to be re scheduled in January, however further industrial action was called and is taking place between 25th December 2023 and 25th January 2024.

- 6. Also, the recent announcement of the budget consultation³ that takes place between 8th January and 4th February 2024 contains proposals that fall within the remit of this committee, and waste collection and recycling, namely:
 - Considering charging for collection of garden waste;
 - Considering charging for all bulky waste collections, as some are currently free;
 - Saving money by collecting black bin/bag waste once every three weeks instead of every fortnight;
 - Reduced frequency of street cleaning;
 - Removal of bins from residential streets, placing them in alternative locations;
 - Changes to the Local Action Teams that work in and around areas with high numbers of council homes.
- 7. There have also been a number of articles in the local and national press relating to these proposals. 456

Way Forward

8. Cllr Caro Wild, Cabinet Member for Climate Change has been invited to make a statement and answer Member's questions. They will be supported by and Matt Wakelam, Assistant Director Street Scene - Waste from the Economic Development Directorate who have been asked to make a brief presentation followed by Member's questions.

All decisions taken by or on behalf of the Council must (a) be within the legal powers of the Council; (b) comply with any procedural requirement imposed by law; (c) be within the powers of the body or person exercising powers on behalf of the Council; (d) be undertaken in accordance with the procedural requirements imposed by the Council e.g. Scrutiny Procedure Rules; (e) be fully and properly informed; (f) be properly motivated; (g) be taken having regard to the Council's fiduciary duty to its taxpayers; and (h) be reasonable and proper in all the circumstances.
